# NOTICE OF PUBLIC HEARINGS: DRAFT REGULATIONS ON THE DIGITAL TERRESTRIAL TELEVISION REGULATIONS

The Independent Communications Authority of South Africa ("ICASA") hereby, in accordance with section 4(6) of the Electronic Communications Act ("ECA") No.36 of 2005, gives notice to convene oral hearings on the Draft Regulations in respect of digital terrestrial television ("Draft DTT Regulations").

ICASA published the Draft Regulations on 10 July 2012, General Notice 532, Government Gazette Number 35508. The Authority invited interested parties, stakeholders, and the public to respond to the issues raised in the Draft Regulations. The closing date for the receipt of written representations was 30 July 2012. The Authority received eighteen submissions. Seventeen of these have indicated their wish to make oral presentations.

Public hearings will be convened on the 21<sup>st</sup> August 2012 to the 23<sup>rd</sup> August 2012.
