BADGE: On a background Argent, an ellipse in fess Azure, circumnavigating the letters SACSA of the second, and to sinister and orb Purpure, charged with an equatorial line embowed to base of the first.

2. APPLICANT: Katoloso Public Primary School H4/3/1/4124)

ARMS: Per fess Or and Argent, a fess Vert, the upper edge dancetty of three the peaks coupé embattled and the lower edge wavy, between in chief an indented sun Gules, and in base dexter a leafed seedling proper ensigned of three droplets in pale Azure and sinister a sunflower plant in full bloom proper; the whole within a bordure per bordure Or and Vert.

ARMS: Per pale, sinister Argent a fess wavy Azure, charged with another of the first, between in chief a ship in full sail proper its sails bearing the colours and monogram of the Dutch East India Company (VOC) and in base Goutty de Sang; sinister Argent, issuant from the partition line, a demi- Jerusalem cross Gules.

CREST: Rizant from flames of fire proper a demi-phoenix Azure, charged on each wing with a fleur de lis Or.

WREATH AND MANTLING: Dexter: Azure and Argent; Sinister: Gules and Argent.

MOTTO: MEMENTO AD OPUS

6. APPLICANT: Reuel Jethro Khoza H4/3/4/965

ARMS: Or, on a chevron embowed Argent, edged Brunatré, between in chief a sun issuant of the first, edged of the last, and in base an open book Argent, bound Sable, ensigned of a crescent moon Argent, edged Brunatré; three droplets Azure placed one and two. The shield is ensigned of a rocky ground, statant there upon a duiker proper, in front of the rocky ground two swords in saltire Argent, hilted and pommelled Or.

ARMS: Azure, on a chevron Argent, charged with another of the first, three six pointed mullets Or, between in chief dexter a griffin and sinister a lion both rampant respectant Or, and in base a protea flower Or, seeded Argent.

CREST: Issuant from an astral coronet proper an eagle with wings displayed Or.

WREATH AND MANTLING: Azure and Argent.

MOTTO: OPTIMUS ANIMUS

13. APPLICANT: Perry Charles H4/3/4/964)

ARMS: Quarterly per fess wavy I, gules an eagle with wings displayed Or, II, Argent a castle with twin towers proper, III, Argent three estoiles Azure, placed two and one, IV, paly of five, Gules and Or.

CREST: Issuant from a crest coronet consisting of a heading Or, embellished with jewels proper, heightened of four double warded keys, alternated with as many estoiles Or, a demi-lion Or, armed and langued Gules, holding in its dexter claw three keys, one erect and two in saltire Gules.

WREATH AND MANTLING: Gules and Argent.

MOTTO: HONESTATE VIRTUS ET VIRTUTE

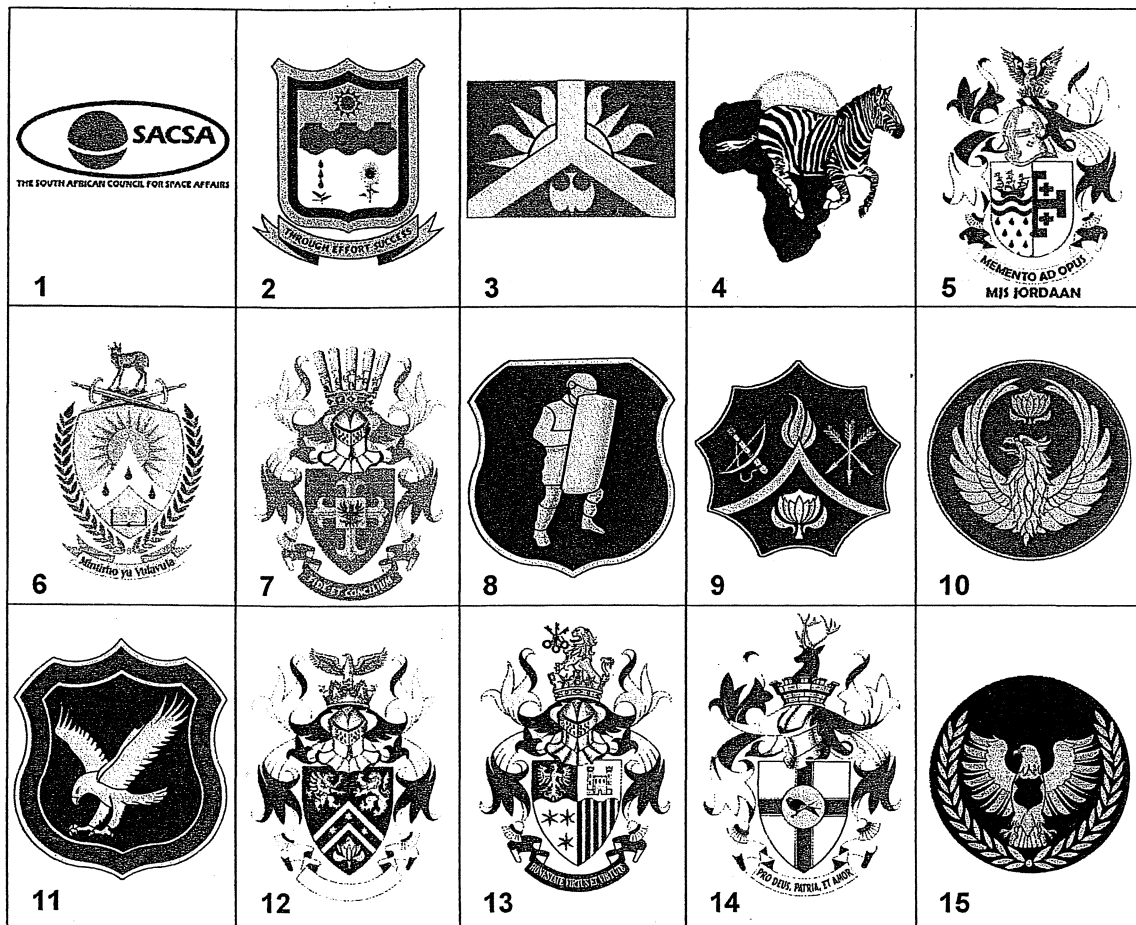

KENTEKEN: Op 'n silwer agtergrond 'n dwarsbalksgewys geplaaste blou ellips wat regs die letter SACSA van blou en links 'n purper bol belaaï met 'n silwer ekwatoriale lyn geboë na benede omsluit.

2. AANSOEKER: Katoloso Publieke Laerskool (H4/3/1/4124)

WAPEN: Op 'n nege-puntige maroen skild die rande geboë en gerand van goud, 'n geboë versmalde keper oortop van 'n vlam alles van goud, tussen in die skildhoof regs 'n skuinsgekruste San boog en pylgevulde koker en links 'n bondel pyle een regop geplaas en oortop van twee skuinsgekruis alles van goud, en in die skildvoet 'n goue protea blom silwer gesaad en gesteel.

10. AANSOEKER: Die Suid-Afrikaanse Polisie – Mobiele Operasies H4/3/3/10/26)

WAPEN: Op 'n ronde maroen skild goud gerand 'n halwe griffioen met omhoog gespreide vlerke wat 'n proteablom in die skildhoof omgewe, alles van goud.

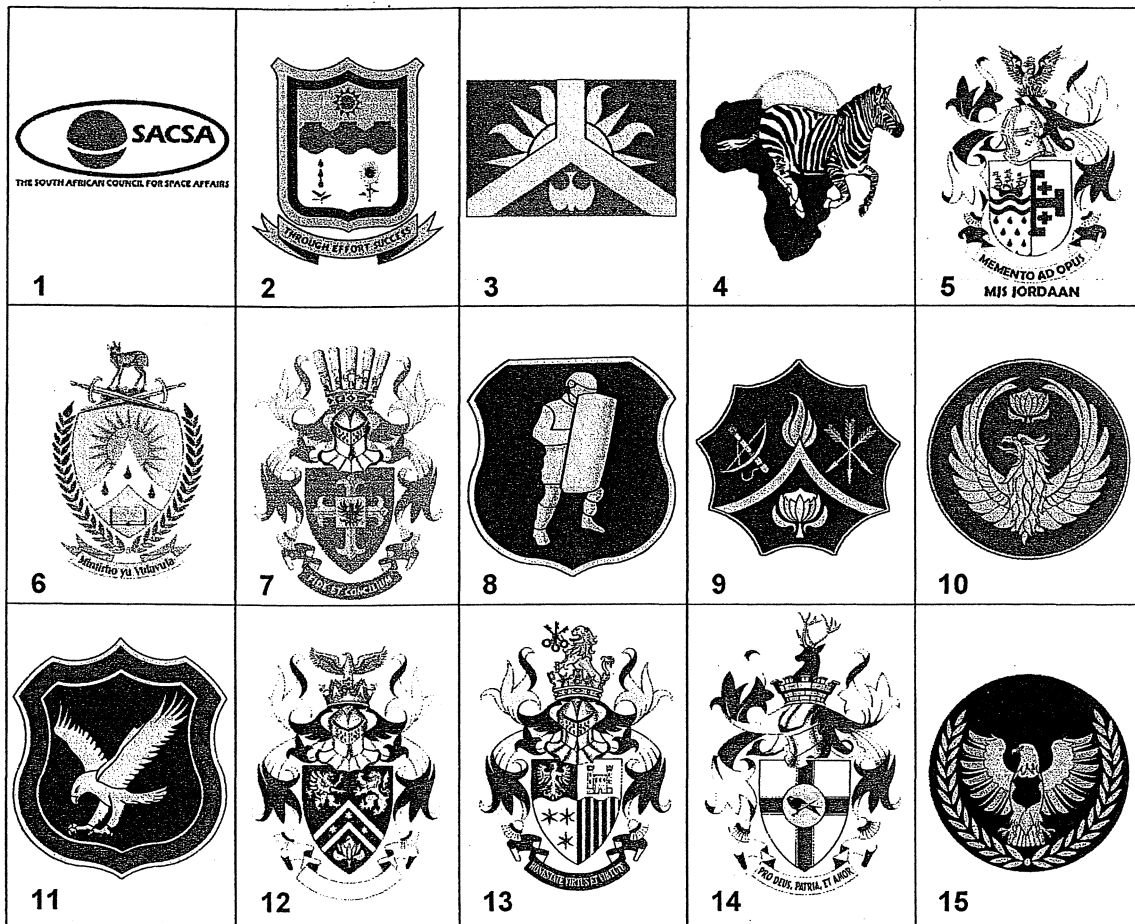

SCHEDULE 1**Definition and Criteria to Classify an Occupation as a Trade.**

Section 26B of the Skills Development Act indicates that SETAs may apply to the Minister in the prescribed form to include an occupation as a listed trade in the Gazette.

In order to align the inclusion of any such occupation as a trade on the Gazetted list with established skills development planning processes, SETAs will be required to include such an application on the form as prescribed in the procedure of submitting new occupations to the Department for inclusion on the Organizing Framework of Occupations (OFO).

However any occupation that a SETA wants to be included as a trade on the OFO must first be submitted to the National Artisan Moderation Body (NAMB) for evaluation and possible endorsement that the occupation meets the criteria for classification of an occupation as a Trade.

The relevant forms to request new occupations on the OFO have been adjusted to include the submission of such an application by a SETA to NAMB should the SETA wish to do so.

In this regard the Skills Development Amendment Act defines:

- An artisan as “a person who has been certified as competent to perform a listed trade in accordance with the Skills Development Act”
- A trade is “an occupation for which an artisan qualification is required in terms of Section 26 B” of the Skills Development Act.

The NAMB will utilize the titles, descriptors, alternate titles, and tasks from the prevailing version of the OFO as the basis to determine which occupations are trades and can be listed by the Minister.

Criteria that will be utilized by NAMB to classify occupations as Trades.

The occupational titles, descriptors, alternate titles, and tasks will be compared to the following broad generic description of a trade:

An occupation where in a qualified person applies a high level of practical skills supported and re-enforced by underpinning and applied knowledge to:

- Manufacture, produce, service, install or maintain tangible goods, products or equipment in an engineering and/or technical work environment (*excluding process controllers and operators*).
- Uses tools and equipment to perform of his/her duties.
- Measure and do fault finding on process, manufacturing, production and/or technical machinery and equipment to apply corrective or repair actions.
- Apply and adhere to all relevant health, safety and environmental legislation.
- Has an accumulative learning period covering knowledge, practical and workplace learning that is equivalent to three or more years.

The route to achieve artisan status will also be considered as such a route is uniquely characteristic of a trade and usually includes features such as:

- ◊ a structured learning programme of knowledge, practical and work experience
- ◊ a structured learning programme that must be successfully completed before a final assessment is attempted
- ◊ a final external summative assessment that must be passed and is known as a trade test.

Historic and global classification of occupations as trades will also be considered.

Any occupation that is determined by NAMB to align to the above criteria will be endorsed for classification as a trade.



Schedule

Definitions

1. In these Regulations, any word or expression to which a meaning has been assigned in the Act has that meaning unless the context indicates otherwise-

"credit accumulation" means retaining recognition for a competence in a task successfully completed during a trade test under specified conditions;

"curriculum" means any listed trade learning programme approved by the QCTO that leads to an artisan qualification contemplated in Section 26D of the Act.

"Department" means the Department of Higher Education and Training;

"exemption" means a credit that is given for a component or all components of an occupational curriculum that has been achieved through a recognition of prior learning process as determined by NAMB in consultation with QCTO;

"GENFETQA Act" means the General and Further Education and Training Quality Assurance Act, 2001 (Act 58 of 2001);

"listed trade" means an occupation that is listed as a trade in the Gazette as is required in terms of Section 26B of the Act;

"Minister" means the Minister of Higher Education and Training;

"NAMB" means the National Artisan Moderation Body established in terms of section 26A of the Act;

"Pre-trade test evaluation" means a predetermined verbal or written evaluation and an integrated practical assessment to determine whether the learner should be allowed to proceed to take a trade test for a listed trade;

"QCTO" means the Quality Council for Trades and Occupations established in terms of Section 26G of the Act;

"the Act" means the Skills Development Act, 1998 (Act 97 of 1998);

"SETA" means a Sector Education Training Authority established in terms of Section 9 of the Act;

“Trade Test” means a final external summative assessment included in the occupational qualification for a listed trade that is conducted by an assessor registered with NAMB at a trade test centre accredited by QCTO; and

“UMALUSI” means the Council established by Section 4 of the GENFETQA Act.

Application for access to a trade test

- 2.1 Subject to Regulation 3, any person may apply to a trade test centre accredited by QCTO to undergo a trade test in any listed trade subject to the person submitting an application form in the format determined by NAMB obtainable from an accredited trade test centre together with evidence of :
 - (a) the successful achievement by the person of the minimum level of education as specified by QCTO in the occupational curriculum for the relevant learning programme for a listed trade qualification;
 - (b) the successful completion by the person of all the curriculum components of a learning programme for a listed trade artisan qualification registered by the QCTO; and
 - (c) compliance to any medical or legal requirement applicable to the relevant trade as may be required by any other legislation.
- 2.2 Notwithstanding sub-regulation 1, any person may apply to a trade test centre accredited by QCTO to undergo a trade test in any listed trade subject to the person submitting an application form in the format determined by NAMB together with a portfolio of evidence approved by NAMB for a listed trade in the case of a person that underwent a recognition of prior learning process.
- 2.3 Upon the receipt and verification of an application, the trade test centre accredited by QCTO must issue a trade test date at an accredited trade test centre as requested by the applicant or as determined by the trade test centre accredited by QCTO within 5 working days.

Pre-Trade Test Evaluations

3. A pre-trade test evaluation must be conducted by an accredited trade test centre on a person who is applying for a trade test and their curriculum or portfolio of evidence was completed three years or more prior to applying for a trade test.

Trade Testing Fees and Rules

4. Trade testing fees and rules for all listed trades will be determined by the Director-General through a circular that is in line with the QCTO Fee Structure Policy and is issued annually to all accredited trade test centres and SETAs before 31 March of each year.

Review of Pre-Trade Test Evaluation and Trade Test

5.1 Pre-trade test evaluation and trade test instruments for all listed trades will be reviewed by NAMB every three years in consultation with QCTO and relevant industries if a need for such a review is considered necessary but the review of the instruments will not necessarily affect the underpinning occupational qualification's assessment frame-work.

5.2 A review may also occur if:

- (a) a SETA and relevant industry stakeholders request a review; or
- (b) indicated through an analysis of moderation results.

Exemptions

6. The QCTO must ensure that the criteria for exemption relating to the completion of any curriculum prior to the undertaking trade test for a listed trade is included in that curriculum.

Credit Accumulation

7. Subject to Regulation 2 and 3, all learners will be allowed three attempts at a trade test irrespective of the learning programme agreement period.
8. A learner who is found not yet competent after three attempts at a trade test may apply for further attempts after consecutive periods of six months from the date of the previous attempt subject to submitting evidence of having had training to address competency gaps as described in the detailed assessment feedback report contemplated in sub-regulation 9.4.
9. A learner who attempted a trade test and was found not yet competent in some of the tasks after the assessment, will nonetheless be given exemption from those tasks in which he/she has been found competent for further trade tests provided that:
 - 9.1 The trade test tasks passed have not significantly been amended;
 - 9.2 the learner was found competent in at least more than 50% of the tasks given during the

trade test on the first attempt;

- 9.3 the learner found competent in at least more than 50% of the tasks given during the trade tests on the first attempt will not be given the same tasks that have been passed during future attempts; and
- 9.4 the learner receives a detailed assessment feedback report from the accredited trade test centre that includes recommendations on further training required in order to address competency gaps, that is also submitted to NAMB and relevant SETAs within 5 working days.

Trade Testing Scheduling, Monitoring, Reporting and Certification of Learners

10. The accredited trade test centre must issue a trade test date to the applicant within 5 working days from receipt of application.
11. The QCTO accredited trade test centres must submit all planned trade test schedules once a month on the first day of the month to the NAMB and relevant SETAs in a format to be determined by NAMB to enable NAMB to moderate artisan trade tests as contemplated in 26A of the Act.
12. The QCTO accredited trade test centres must submit all learner trade test results once a week by close of business every Friday to the NAMB and relevant SETAs in a format to be determined by NAMB in consultation with the QCTO.
13. The NAMB must report monthly on the first day of the month on all learner trade tests scheduled and trade test results to the Department, SETAs, QCTO and Artisan Stakeholders Forums administered by the NAMB.
14. The NAMB must recommend certification of qualifying learners to the QCTO within ten working days after verification of results from the accredited trade test centres.
15. The NAMB must not recommend certification of a learner if the learner does not appear on a monthly trade test schedule contemplated in regulation 11.
16. The QCTO must issue and distribute national trade certificates as per the QCTO Certification Policy.

Appeals

- 17.1 A learner may appeal a trade test result within 21 days of receipt of the results.

17.2 The appeal must be lodged with NAMB in the format determined by NAMB.

17.3 All appeals received by NAMB related to trade test results will be processed in terms of the NAMB and QCTO Assessment Appeals Policy.

Irregularities and Offences

18 The NAMB will establish a Disciplinary Code and Procedures for Trade Testing approved by the Minister.

Transitional Arrangements

19.1 All trade test centres currently accredited by SETAs will be deemed to be accredited by QCTO for a maximum period of three years from the date of this notice or until the trade test centre has been audited by QCTO through its delegation to NAMB and given a revised status;

19.2 Until such time the minimum level of education as specified by the QCTO in the occupational curriculum for the relevant listed trade is implemented as contemplated in Regulation 2.1, the minimum level of education for all listed trades will be the successful achievement by a learner obtaining a minimum of 50% in Mathematics excluding Mathematics Literacy at a Grade 9 level or higher which has been obtained before commencing or which is achieved during or after an artisan learning programme;

19.3 All listed trade learning programmes currently approved by DHET or SETAs that are submitted by 31 August 2012 for provisional registration with NAMB will be deemed to be approved by QCTO until the learning programme has been replaced by the relevant occupational qualification and related curriculum registered with QCTO or the learning programme is de-registered by NAMB;

19.4 All apprentices under a contract of apprenticeship, registered by a SETA in terms of Section 13 of the Manpower Training Act, 1981 (Act no. 56 of 1981) before the commencement of these regulations are deemed to be apprenticeships in terms of Chapter 4 of Act;

19.5 Any person that has been issued with a trade test date for a trade test in terms of Section 28 of the Manpower Training Act prior to the publication of this notice will continue to be managed as a candidate as contemplated in Regulation 2.2;

19.6 No person may apply for or be trade tested under Section 28 of the Manpower Training

Act but any person may apply to the Department for recognition of prior learning;

- 19.7 NAMB, in consultation with SETAs, will determine exemptions for trade testing until the QCTO determines these exemptions in the relevant curriculum; and
- 19.8 Listed trade learner achievements will continue to be processed as per current arrangements until such time that such achievements are uploaded onto the NLRD by QCTO.

Exporters that did not export to SACU during the original investigation period for dumping may request a new shipper review. The exporter requesting such review shall provide sufficient information to prove that it is not and was not related to any party to which the anti-dumping duty was applied.

On 24 April 2012 the International Trade Administration Commission of South Africa (the Commission) accepted a new shipper review.

THE APPLICANT

The application was received from Anqiu Lu'an Pharmaceuticals Co. Ltd a manufacturer and exporter of the subject product from the PRC, alleging that it did not export the subject product to SACU during the period of investigation for dumping in the original investigation and it has no relationship with any of the exporters of the subject product from the PRC to which the anti-dumping duty was applied. The Applicant submitted evidence and established a *prima facie* case to enable the Commission to arrive at a reasonable conclusion that a new shipper review investigation should be initiated.

THE PRODUCT

The subject product is acetaminophenol originating in or imported from the PRC, classifiable under tariff heading 2924.29.05.

PERIOD OF INVESTIGATION

The investigation period for dumping is from 01 January 2011 to 31 January 2012.

PROCEDURAL FRAMEWORK

The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act, the Anti-Dumping Regulations of the International Trade Administration Commission of South Africa (ADR) and will give due regards to the World Trade Organisation Agreement on Implementation of Article VI of the GATT 1994 (the Anti-Dumping Agreement). Both the ITA Act and the ADR are available on the Commission's website (www.itac.org.za) or from the Trade Remedies section, on request.

In accordance with section 50 of the ADR, the Commission recommended to the Minister of Trade and Industry that Anqiu Lu'an Pharmaceuticals Co. Ltd be exempted from the payment of the anti-dumping duty on the subject product originating in or imported from the PRC. The Minister of Trade and Industry on approval of the Commission's determination, requested the Deputy Minister of Finance to withdraw the anti-dumping duty on the subject product originating in or imported from the PRC and manufactured by Anqiu Lu'an Pharmaceuticals Co. Ltd and impose provisional payments at the same level as the applicable anti-dumping duty.

On publication of this notice, the Commission will inform the SACU manufacturers. The trade representative of the exporting country will also be notified. Representations must be made within the time limit set out below.

CONFIDENTIAL INFORMATION

Please note that if any information is considered to be confidential then a non-confidential version of the information must be submitted for the public file, simultaneously with the confidential version. In submitting a non-confidential version the following rules are strictly applicable and parties must indicate:

- where confidential information has been omitted and the nature of such information;
- reasons for such confidentiality;
- a summary of the confidential information which permits a reasonable understanding of the substance of the confidential information; and
- in exceptional cases, where information is not susceptible to summary, reasons must be submitted to this effect.

This rule applies to all parties and to all correspondence with and submissions to the Commission, which unless indicated to be confidential and filed together with a non-confidential version, will be placed on the public file and be made available to other interested parties.

If a party considers that any document of another party, on which that party is submitting representations, does not comply with the above rules and that such deficiency affects that party's ability to make meaningful representations, the details of the deficiency and the reasons why that party's rights are so affected must be submitted to the Commission in writing forthwith (and at the latest 14 days prior to the date on which that party's submission is due). Failure to do so timeously will seriously hamper the proper administration of the investigation, and such party will not be able to subsequently claim an inability to make meaningful representations on the basis of the failure of such other party to meet the requirements.

Subsection 33(1) of the ITA Act provides that any person claiming confidentiality of information should identify whether such information is *confidential by nature* or is *otherwise confidential* and, any such claims must be supported by a written statement, in each case, setting out how the information satisfies the requirements of the claim to confidentiality. In the alternative, a sworn statement should be made setting out reasons why it is impossible to comply with these requirements.

Section 2.3 of the ADR provides as follows:

“The following list indicates “information that is by nature confidential” as per section 33(1)(a) of the Main Act, read with section 36 of the Promotion of Access to Information Act (Act 2 of 2000):

PROCEDURES AND TIME LIMITS

The Senior Manager: Trade Remedies II, should receive all responses, including non-confidential copies of the responses, not later than 30 days from the date hereof, or from the date on which the letter accompanying the notice was received. The said letter shall be deemed to have been received seven days after the day of its dispatch.

Late submissions will not be accepted except with the prior written consent of the Commission. The Commission will give due consideration to written requests for an extension of not more than 14 days on good cause shown (properly motivated and substantiated), if received prior to the expiry of the original 30-days period. Merely citing insufficient time is not an acceptable reason for extension.

The information submitted by any party may need to be verified by the investigating officers in order for the Commission to take such information into consideration. The Commission may verify the information at the premises of the party submitting the information, within a short period after the submission of the information to the Commission. Parties should therefore ensure that the information submitted would subsequently be available for verification. It is planned to do the verification of the information submitted by the exporters within three to five weeks subsequent to submission of the information. This period will only be extended if it is not feasible for the Commission to do it within this time period or upon good cause shown, and with the prior written consent of the Commission, which should be

requested at the time of the submission. It should be noted that unavailability of, or inconvenience to consultants will not be considered to be good cause.

Parties should also ensure when they engage consultants that they will be available at the requisite times, to ensure compliance with the above time frames. Parties should also ensure that all the information requested in the applicable questionnaire is provided in the specified detail and format.

Any interested party may request an oral hearing at any stage of the investigation in accordance with Section 5 of the ADR, provided that the party indicates reasons for not relying on written submission only. <p>GUIDELINES FOR THE CONSIDERATION OF CROSS BORDER ROAD TRANSPORT PERMITS FOR THE CONVEYANCE OF PASSENGERS</p>
--

INTRODUCTION

1. As an organ of state the Cross Border Road transport Agency (CBRTA) is enjoined to comply with various statutory provisions.
2. The purpose of these guidelines is to provide insight into the manner in which the Regulatory Committee (the RC) of the CBRTA exercises its statutory functions in disposing of applications for cross border road transport permits for the conveyance of passengers.
3. The RC recognises that circumstances may differ and stresses that every application will, despite these guidelines, be decided on its own merit.
4. The principles of accountability and transparency enshrined in the Constitution are set out in the Promotion of Administrative Justice Act, 3 of 2000, and the Promotion of Access to Information Act, 2 of 2000, and the RC will comply with the relevant provisions of these acts, especially since they were enacted after the Cross-Border Road Transport Act 4 of 1998 (the CBRT Act) came into force.

CONSTITUTION OF THE REPUBLIC OF SOUTH AFRICA, ACT 108 OF 1996 (the Constitution)

5. In terms of section 33 of the Constitution everyone has the right to administrative action that is lawful, reasonable and procedurally fair.
 6. The RC will ensure that the basic values and principles governing public administration as recorded in Section 195 of the Constitution are adhered to.
 7. In dealing with matters that come before it the RC will accordingly:
 - promote and maintain a high standard of professional ethics;
 - exercise its duties impartially, fairly, equitably and without bias;
 - be development oriented;
 - promote the efficient, economic and effective use of resources;
 - respond to people's needs; and
 - foster transparency.
 8. In terms of section 237 of the Constitution the RC must perform all of their constitutional obligations diligently and without delay.
- 2.
9. In terms of section 9(1) of the Constitution everyone is equal before the law and has the right to equal protection and benefit of the law.
 10. Section 9(2) of the Constitution provides that:
 - equality includes the full and equal enjoyment of all rights and freedoms; and

- to promote the achievement of equality, legislative and other measures designed to protect or advance persons, or categories of persons, disadvantaged by unfair discrimination may be taken.
11. Section 9 of the Constitution must be read with sections 28(1)(a) and 27(1)(1A) of the CBRT Act to which reference is made below.
 12. It bears emphasis that in appropriate instances the RC will accordingly adopt measures designed to protect or advance persons or categories of persons disadvantaged by unfair discrimination.
 13. The RC takes decisions that apply extra-territorially (i.e. beyond the borders of South Africa). The RC's extra-territorial powers are derived in part from international agreements as envisaged in terms of section 2 of the Act.
 14. It is imperative that the provisions of such agreements are taken into account when applications for cross-border road transport permits are considered.
 15. In terms of section 2 of the CBRT Act, read with section 231(3) of the Constitution, such agreements:
 - are concluded by the Minister of Transport subject to the provisions of the Constitution;
 - must be promulgated by the President by Proclamation in the *Gazette*;
 - will have the force of law in the Republic with effect from the date of promulgation or any later date specified in the Proclamation; and
 - must be tabled in the Assembly and the Council within a reasonable time.
 16. In terms of section 25 of the CBRT Act applications for permits must be made in accordance with the regulations as well as the provisions of:
 - any relevant extra-territorial agreement; alternatively
 - any executive arrangement, where the Minister has concluded such an arrangement in anticipation of an extra-territorial agreement being concluded.
 17. These provisions are peremptory and non-compliance cannot be condoned. Accordingly applications that do not comply with these requirements cannot be considered.

3.

PROMOTION OF ADMINISTRATIVE JUSTICE ACT 3 OF 2000 (PAJA)

The following provisions of PAJA are especially pertinent:

18. Section 3, which deals with the requirements for administrative action to be procedurally fair, including that interested persons be given:
- adequate notice of the nature and purpose of the proposed administrative action;
 - a reasonable opportunity to make representations;
 - a clear statement of the administrative action;
 - adequate notice of any right of review or internal appeal, where applicable; and
 - adequate notice of the right to request reasons in terms of section 5.
19. Section 5, which require the RC to furnish adequate written reasons for its decisions within 90 days after being called upon to do so by any person whose rights have been materially and adversely affected by its decisions.
20. Section 6, which records the grounds upon which a decision of the RC can be reviewed and set aside. These include taking a decision that is:
- biased or taken in circumstances where there is a reasonable suspicion of bias;
 - not in compliance with a mandatory and material procedure;
 - procedurally unfair; materially influenced by an error of law; taken for a reason not authorised by the CBRT Act; taken for an ulterior purpose or motive; because irrelevant considerations are taken into account or relevant considerations are not considered; because of the unauthorised or unwarranted dictates of another person or body; or acting in bad faith; arbitrarily or capriciously;
 - not authorised by the CBRT Act; or that is not rationally connected to:
 - the purpose for which it was taken;
 - the purpose of the CBRT Act;
 - the information before the RC; or
 - the reasons given for the decision;
 - so unreasonable that no reasonable person could have so exercised the power or performed the function; or
 - otherwise unconstitutional or unlawful.
21. Section 7(2), which requires an aggrieved person to first exploit internal remedies before a decision of the RC can be taken on review.

4.

PROMOTION OF ACCESS TO INFORMATION ACT 2 OF 2000 (PAIA)

22. PAIA was enacted to

- give effect to the constitutional right of access to information that is required for the exercise or protection of any rights;
 - to foster a culture of transparency and accountability in public and private bodies by giving effect to the right of access to information; and
 - to actively promote a society in which the people of South Africa have effective access to information to enable them to more fully exercise and protect all of their rights.
23. PAIA contains an elaborate procedure whereby interested parties will be able to call upon the RC to provide access to all documents in its possession and that have a bearing on any matter that has or may come before it for a decision.
24. The RC is bound by and, when properly called upon to do so, must comply with these provisions. The Agency's Promotion of Access to Information Manual should be consulted in this regard.

CROSS-BORDER ROAD TRANSPORT ACT 4 OF 1998 (the CBRT Act) AND REGULATIONS (the Regulations).

Reasons for regulating competition in so far as it relates to the conveyance of passengers

25. In terms of Section 23 of the CBRT Act the Board must regulate access to the market by the passenger industry in respect of cross-border road transport by the issuing of permits.
26. The objective stated in the preamble to the CBRT Act is to improve safety, security, reliability, quality and efficiency of services.
27. These objectives require that a balance be struck between not authorizing excessive competition on the one hand and not unduly restricting competition on the other.
28. South Africa and its neighbours face unique challenges with a need to extend passenger transport services that are safe, secure, reliable, of good quality and efficient over long distances between business centres and also to outlying areas so as to enable Africa to develop to its full potential.
29. Issues such as congestion, resulting in environmental nuisance and accidents currently plaguing cross border transport in more developed regions may not as yet be a major concern in the southern regions of Africa but should nevertheless serve as an early warning of the problems the region could be faced with if market entry is not properly regulated.

Distinction between the cross border road transportation of freight and passengers

30. These guidelines are concerned only with the cross-border conveyance of passengers. In order to gain a proper understanding of the relevant provisions of the CBRT Act it is however important to take note of the distinction that is made in the Act between the cross border conveyance of freight and passengers:
- In the case of freight transport the pre-amble of the CBRT Act records the need to “liberalise market access progressively”.
 - In the case of cross border passenger transport the object is different and the pre-amble records a need “to introduce regulated competition”.
31. The liberalization of market access in respect of freight whilst at the same time regulating competition in respect of the transportation of the public by road accords with trends in many countries, although the mechanisms employed may differ from country to country.
32. In South Africa competition in respect of cross-border passenger conveyance is regulated by placing an onus on new entrants to satisfy the regulatory authority (*inter alia*) that:
- there is a need for the particular service that they wish to render taking into account the available transport facilities;
 - they have the ability to provide the particular service safely and effectively; and
 - having regard to the circumstances it will be expedient in the public interest to grant the permit that is applied for.
33. Each of these onus bearing considerations are dealt with more fully in clauses 55 to 59 below. There are also a number of other considerations (non-onus bearing considerations) that must be taken into account by the RC when it considers an application for the issue of permits for the cross-border transportation of passengers. These are set out in clauses 60 to 67 below.
34. Although the non-onus bearing considerations also apply to applications for permits in respect of freight, the onus bearing considerations do not apply to such applications.
35. Applicants for permits for the cross border conveyance of passengers would be well advised to bear this important distinction in mind.

Permit applications

36. Section 25(2) requires permit applications to comply with the applicable extra territorial agreements and the regulations.
37. Regulation 2 sets out the requirements that an applicant for a permit needs to comply with.
38. It bears emphasis that both section 25 and regulation 2 are couched in peremptory terms and accordingly an applicant for a permit must comply with these requirements and the RC has no authority to condone non-compliance with any of these requirements.

Publication

39. In the case of an application for permits for cross-border passenger road transport (and cabotage), Section 33 of the Act prescribes that the RC ... 'must' in every instance publish... 'the particulars of any application as may be prescribed and invite any person to make representations in the manner and within the time prescribed, in respect of such application' in the Government Gazette.
40. In the case of freight (other than cabotage) the Minister is given discretion to order publication.
41. Regulation 3 sets out the requirements that the publication must comply with. Once again the requirements are couched in peremptory terms and the RC cannot condone non-compliance with any of these requirements.

Pre-hearing evaluation of applications and publications

42. The RC has a sub-committee that evaluates applications and publications before matters are heard.
43. In instances where it is of the opinion that the application does not comply with the aforementioned requirements it will, in an endeavour to save costs, advise the applicant accordingly before the matter is set down for hearing.
44. It should be noted that the sub-committee acts in advisory capacity only and its recommendations are not binding on either the applicant or the RC.

7.

HEARINGS BEFORE THE RC

Procedural requirements and points in-limine

45. Before turning to the merits of any matter the RC must consider whether or not:

- the relevant portions of the prescribed form have been completed and properly submitted to the RC as required by regulation 2(1);
- the information, particulars and documents referred to in regulation 2(2) have been furnished;
- the application was accompanied by the prescribed fee as required by regulation 2(4);
- the application is otherwise in accordance with regulations and any applicable extra territorial agreement or an executive arrangement;
- the application was published in the Government Gazette at least four weeks prior to the hearing as required by regulation 3(1);
- the publication in the Government Gazette contained the information referred to in regulation 3(1)(a)(i)to(v); and
- objections to the application have been tabled and, if so, whether or not they have complied with regulation 3(2).

46. Non-compliance with any of the above procedural formalities that materially affect the rights of interested parties will result in applications not being considered on their merits. In this regard the RC must also take cognisance of the interests of parties that are absent and that may be adversely affected by the non-compliance.

Considering the merits of the applications

47. Section 27 records a number of factors that the RC must take into consideration in making its decision "based on the information presented to it by the Chief Executive Officer".

48. Regulation 4(5) requires the Chief Executive Officer to verify the information provided by an applicant for a permit authorising passenger transport and to present the information contemplated in section 28 of the CBRTA Act to the RC.

49. All hearings for passenger conveyance are attended by the CEO and to date he has delegated this function to a regulatory official who in his presence places relevant information before the RC at the commencement of the hearing.

50. It is anticipated that as the revised integrated permit management system comes into effect more and more relevant information will be communicated in this manner.

51. In order to satisfy the requirement of fair and transparent decision making the entire procedure must take place in the presence of all of the interested parties and they must be afforded an adequate opportunity to respond thereto.

52. All of the factors listed in section 28 must be taken into account by the RC. These include both the onus-bearing and non-onus bearing considerations.

ONUS BEARING CONSIDERATIONS

53. Section 28(2) of the CBRT Act stipulates that the onus rests on the applicant to prove paragraphs (b), (c), (d), (e) and (f) of subsection (1).

54. Each of these requirements will be dealt with under separate headings below. At the outset it is however important to note the following:

- The CBRT Act does not place these factors (or any of the non-onus bearing considerations) into any order of ascendancy;
- Section 28(2)(c) expressly places an onus on the applicant to prove each of the factors listed in the paragraphs referred to;
- What kind of evidence will suffice in order to discharge that onus will depend on the circumstances of each application;
- Mere submissions made by legal representatives will rarely suffice, especially not in matters that are opposed;
- Where appropriate, documentary evidence must be provided and witnesses must be called to testify so that they can be questioned by the RC and cross examined by interested parties;
- What follows is no more than a rough guide as to the kind of evidence that may be taken into account;
- Applicants are accordingly free to conduct their cases as they see fit and the RC will take due cognisance of all evidence, documentary or otherwise that is placed before it.

55. Section 28(1) (b) – Whether the applicant has forwarded completed passenger lists

This requirement applies in those instances where the applicant previously held permits. In such an instance passenger lists as prescribed must have been provided.

56. Section 28(1) (c) - The need for the particular service, taking into account the available transport facilities

- 56.1 Applicants must prove that there is a need for the particular service that they wish to render taking into account the available transport facilities.
- 56.2 Available transport facilities are not defined.
- 56.3 Available transport facilities are accordingly not limited to other available road transport facilities for the conveyance of passengers and that are rendered in terms of permits issued by the board but would in an appropriate case also extend to:
- transport by air;
 - rail transport; and
 - transport by car and by mini as well as midi-busses.
- 56.4 In order to establish a need evidence can be provided from ,inter alia:
- Educationalists;
 - Sporting organizations;
 - Religious bodies;
 - Business and industry associations;
 - Tourism bodies;
 - Community leaders;
 - Political bodies;
 - Local and regional government
 - Individuals, including those with special needs or requirements; and
 - Labour and Consumer bodies.
- 56.5 The Applicant can also rely on:
- independent surveys;
 - expert evidence;
 - passenger-list data;
 - factors that may impact on need such as:
 - Macro and micro economic factors;
 - Political circumstances that impact on need such as regional or neighbouring instability;
 - any other circumstances indicating a need.
- 56.6 The issue of temporary permits on a regular basis in terms of section 26 of the CBRTA Act may be a good indicator of the need for the introduction of a new transport facility for the conveyance of passengers on a permanent basis over a particular route with due regard being had to its effect on the existing transport facilities.
- 56.7 It bears emphasis that the above is a non-exhaustive list issued for guidance purposes only and is not necessarily compulsory depending on circumstances.

57. Section 28(1) (d) - whether the applicant operates from the address furnished by him /her

57.1 Applicants must prove that they are operating from the address furnished by submitting a duly executed ranking authority / permissions from the relevant transport planning authorities, i.e. Metro or local municipal authority.

57.2 The authority / permissions must be provided for both the departure and destination points.

58. Section 28(1) (e) - the ability of the applicant to provide the particular service safely and effectively

58.1 Due regard being had to the purpose of regulating cross border road transport of passengers this is a very important requirement. The RC would not be fulfilling its statutory purpose were it to issue permits to an applicant that does not have the ability to provide the service that he or she wishes to introduce safely and effectively.

58.2 There are many ways in which an applicant can discharge the onus of proving that he or she has the ability to provide a particular service safely and satisfactorily including the following:

- The submission of a business plan demonstrating the financial viability of the proposed service and how it will be provided safely and effectively;
- The applicants experience in transport and related industries;
- Proposed vehicles, staff and other relevant infra-structure and equipment that will be utilized;
- Proposed maintenance regime;
- Current commitments;
- Available resources;
- The applicant's safety record; and
- Testimonials from reliable and verifiable sources.

59. Section 28(1) (f) - having regard to the circumstances, whether it will be expedient in the public interest to grant the permit

59.1 A purposive interpretation must be applied when considering the meaning of these words.

59.2 As already explained the preamble makes it clear that as far as cross border passenger transport is concerned the purpose is to introduce regulated competition so as to improve safety, security, reliability, quality and efficiency of services.

59.3 In fulfilling its statutory mandate to regulate competition the RC is enjoined to achieve these public interest objectives and, before granting an application for cross border permits in respect of passengers, it must be satisfied by the Applicant that doing so will improve safety, security, reliability, quality and efficiency of services.

59.4 The disadvantages of a lack of adequate competition are higher prices and reduced service levels. This is not expedient in the public interest.

59.5 On the other hand, excessive competition in the market for the conveyance of passengers over specific routes or between specific points can lead to predatory pricing and compromise passenger safety as competitors resort to cost cutting on service levels and safety in order to survive. This is also not in the public interest.

59.6 Recognised benefits for the common good that can be achieved by introducing regulated competition in respect of passenger services, include:

- Optimum utilization of scarce economic resources, including manpower; natural resources (e.g. fuel); infra-structure (roads and vehicles) and money;
- The prevention of predatory pricing which could lead to the safety of passengers being undermined;
- The introduction of timetables that are sufficiently different to ensure that operators do not snatch each other's passengers and generally make transport facilities more accessible;
- Cross subsidization of services so as to provide passenger services to outlying communities.

59.7 On the other hand regulating competition does not mean that competition must be completely eliminated. Where a route can accommodate two or more carriers it is highly desirable that they be allowed to compete thus ensuring that the benefits of the cheapest rates and the best service levels are still attained.

59.8 An applicant can adduce any evidence he deems appropriate in order to discharge this onus and the RC can and will take a wide range of factors into account, such as the following

- Potential harmful effects of a lack of competition such as reduced service levels and high prices;
- An applicant could discharge the onus by showing that either of these are present over a particular route;

- Expert or other acceptable evidence could be adduced to show that excessive prices are being charged by the existing operators;
- Factual evidence could be adduced to show that service levels are inadequate and below acceptable standards;
- Evidence of collusion between existing operators would be a very strong indicator that further competition is necessary.

OTHER NON-ONUS BEARING FACTORS THAT THE RC MUST TAKE INTO ACCOUNT

60. Section 28(1) (a) read with section 27(1) (a) - whether the applicant and the vehicle complies with the relevant provisions of the National Road Traffic Act, 93 of 1996, as amended.
61. Section 28(1)(a) read with section 27(1)(b) - whether the applicant has a good road transport law enforcement profile based on the information contained in the points demerit system referred to in section 45.
62. Section 28(1)(a) read with section 27(1)(d) - a foreign state's track record with regard to reciprocity where the applicant is from a state with which South Africa does not have an agreement providing for permits with extraterritorial jurisdiction.
63. Section 28(1)(a) read with section 27(1)(e) - in the case of an application for a cabotage permit, the following considerations:
- (i) the foreign state's track record on granting cabotage permits to South African carriers;
 - (ii) whether a South African carrier is able to provide a similar service.
64. Section 28(1)(a) read with section 27(1)(eA) - whether a South African carrier has submitted a valid tax clearance certificate from the South African Revenue Services indicating that the applicant's tax affairs are in order.
65. Section 28(1)(a) read with section 27(1)(eB) - any conditions, factors or criteria specified in a relevant agreement contemplated in section 2 or specified or determined by a joint committee or similar body in terms of such an agreement

66. Section 28(1)(a) read with section 27(1)(1A) - Where the applicant is a South African carrier the Board must take into account-

- (a) the promotion of small business;**
- (b) the empowerment of persons historically disadvantaged by unfair discrimination; and**
- (c) any relevant code of good practice or transformation charter published in terms of the Broad-Based Black Economic Empowerment Act, 2003 (Act 53 of 2003) (Section 27(1)(1A))**

66.1 These provisions must be read with section 9(1) and 9(2) of the Constitution referred to above.

66.2 The requirement is couched in peremptory terms and the RC is accordingly compelled to take the aforementioned factors into account in every instance in which the Applicant is a South African carrier.

67. Section 28(1) (a) - Any other factor which, in the opinion of the Chief Executive Officer, must be considered.

67.1 This provision affords the CEO a wide discretion to introduce additional factors for consideration. These must however be:

- relevant;
- fair;
- reasonable; and
- exercised within the bounds of the Constitution, PAJA and accord with the CBRT Act and the CEO's powers and functions in terms of that Act.

67.2 These factors could include any of the following:

- Potential for conflict between operators;
- The existence of sufficient, safe and secure ranking facilities and the necessary approvals in relation thereto.
- The existence of Joint venture agreements with foreign operator counterparts in foreign countries;
- Single pick-up and discharge points;
- Route descriptions;
- Input from associations and other bodies;
- Route Management Group and Joint Management Group feedback in terms of Regulation 10;
- Resolutions of Joint Committee Meetings held in terms of the provisions of bi-lateral agreements;
- Consultations with the authorities and relevant stakeholders referred to in section 36 of the CBRT Act;

- Reports from the Road Transport Inspectorate in terms of section 39(2) of the CBRT Act and regulation 19.

67.3 Should the RC consider taking any factor which the CEO deems relevant into account the parties should be advised thereof so that they can make representations in regard thereto.

PROCEDURE TO BE FOLLOWED AT HEARINGS

68. Section 17 of the CBRT Act sets out the procedures that can be followed in dealing with matters that come before it.
69. Although these procedures are not couched in peremptory terms, they give effect to the requirements provided for in section 33 of the Constitution and PAJA that everyone is entitled to administrative action that is lawful, reasonable and procedurally fair.
70. In the result these requirements will be complied with whenever it is practicable and necessary in order to arrive at a decision that is just and equitable.
71. Section 17(1)(a) provides that the RC may allow any person affected by or interested in such matter, or the duly authorised representative of such a person, to appear before it and-
- to give evidence or make oral representations relevant to such matter;
 - to call witnesses and lead evidence on any question relevant to such matter; or
 - to question any person who testified as a witness in such matter;
72. Section 17(1)(b) enables the RC to summon any person to appear before it or to produce any book, plan or other document or article in his or her possession or under his or her control which may be reasonably necessary to the meeting.
73. Section 17(1)(c) enables the RC to call upon any person present in or at the place where such matter is dealt with by it, to appear before it to give evidence in connection with any matter which may be reasonably necessary to the meeting or to produce any book, plan or other document or article in the possession or under the control of that person which may be reasonably necessary to the meeting.
74. Regulation 4(6) provides that the presiding officer at the hearing must allow the applicant to present his or her case first, where after the objectors must be afforded an opportunity to present their cases, and thereafter the applicant must be afforded an opportunity to respond to any allegations made by the objectors.

DECISIONS AND REASONS

75. The RC must advise all interested parties of its decision in writing and where called upon to do so, provide adequate reasons in writing for its decision.

CONCLUSION

76. In performing its statutory duty to regulate competition in respect of cross border passenger transport the RC will seek to achieve the object of improving the safety, security, reliability, quality and efficiency of services for the cross border conveyance of passengers.
77. It will also have due regard to the other statutory provisions that regulate its decisions as set out herein.

TITLE

78. These Guidelines are called the "Cross-Border Road Transport Regulatory Guidelines for Passenger Permits, 2012"



Cost of Assessing Applications for CPD (Continuing Professional Development) Activities

In a quest to fulfil its full mandate and in accordance with section 13(k) of the Project and Construction Management Professions Act No. 48 of 2000, Council embarked on a process of developing a policy on Continuing Professional Development (CPD) in 2009. The process culminated in the finalisation of the CPD policy framework, which was ratified by Council on 27th August 2010. The Policy was then published for comment in the Government Gazette number 33802 as Board Notice 172 of 2010.

Thereafter, Council engaged a number of stakeholders, including among others, the Council for the Built Environment (CBE), voluntary associations and other built environment councils. The Policy was further streamlined taking into account inputs received from all the stakeholders. The final SACPCMP CPD Policy Framework for implementation was published in the Government Gazette number 35294 as Board Notice 75 of 2012.

The Policy makes provision for the validation of courses to be offered by service providers to the registered professionals. Council, in accordance with section 12 (g) of the Act, has determined the fees to be levied as detailed below:

Fees

i. Providers : CPD Applications for Training Material and Short Courses

CPD providers are required to submit their proposed activities to the SACPCMP. A Team of Assessors will evaluate the content, CPD credit value and other relevant issues. All programmes submitted by CPD providers must be in line with the recommended SACPCMP core knowledge courses and non-core knowledge courses for validation. The three categories A, B and C each will be allocated points per hours and there is no differentiation between the costs for either of the categories.

ii. Activities of up to 2 hours

Alle nominasies moet vergesel wees met die aanvaarding van die betrokke genomineerde en moet die Direkteur nie later nie as Vrydag, 05 Oktober 2012 bereik. Ingevolge Reël 7.1, saamgelees met Artikel 57 van die Wet op Prokureurs, moet alle genomineerdes praktiserende lede wees wat in goeie stand is. Ingevolge Reël 6.3 sal geen lid wie se ledegelde agterstallig is vir meer as twee maande, geregtig wees om 'n kandidaat voor te stel of te sekondeer as lid van die Raad nie, en geen lid wie se ledegelde aldus agterstallig is, mag as lid van die Raad genomineer word nie.

VERKIESING VAN SIRKELKOMITEES INGEVOLGE REËL 4

Ingevolge Reël 4.4 word die belange van die Sirkels (met uitsluiting van Sirkels 1, 7, 8, 15, 17, 22, 23 en 24) deur 'n Sirkelkomitee behartig, wat bestaan uit drie lede wat in daardie Sirkel praktiseer, behalwe in die geval van die onderstaande Sirkels waar Sirkelkomitees sal bestaan uit -

Sirkel 2 (Boland/Overberg) -	vyf lede;
Sirkel 4 (George) -	ses lede;
Sirkel 9 (Grahamstad) -	vier lede;
Sirkel 10 (Cradock) -	vier lede;
Sirkel 12 (King William's Town) -	vier lede;
Sirkel 13 (Queenstown) -	vier lede;
Sirkel 16 (Kimberley) -	vier lede;
Sirkel 19 (Upington) -	vier lede.

Die lede van die Sirkelkomitees (Sirkels 1, 7, 8, 15, 17, 22, 23 en 24 uitgesluit) tree almal hierdie jaar af en is herkiesbaar.

Ingevolge Reël 4.8 word nominasies vir die Sirkel-komitees (Sirkels 1, 7, 8, 15, 17, 22, 23 en 24 uitgesluit) hiermee versoek.

Enige twee lede van 'n Sirkel mag enige lid van sodanige Sirkel skriftelik nomineer as lid van die Sirkelkomitee vir die betrokke Sirkel vir die volgende jaar. Elke nominasie moet die nommer van die Sirkel waarvoor die kandidaat genomineer word, aantoon. Die nominasie moet vergesel wees van 'n skriftelike aanvaarding deur die genomineerde en moet die Direkteur teen nie later nie as Vrydag, 05 Oktober 2012 bereik.

Ingevolge Reël 4.6 en ingevolge 'n vorige besluit van die Raad van die Wetsgenootskap van die Kaap die Goeie Hoop, is die Komitees van die Prokureursverenigings van Kaapectad, Karoo, Suidoos-Kaap, Transkei, Kalahari, Tygerberg, Suidelike Voorstede en Oos-Londen die Sirkelkomitees van Sirkels 1, 7, 8, 15, 17, 22, 23 en 24 onderskeidelik. Die onderskeie konstitusies van die betrokke Prokureursverenigings is deur die Raad goedgekeur.

Die Komitees van hierdie Prokureursverenigings word verkies ooreenkomstig hul onderskeie konstitusies (slegs vir een jaar) tydens hul Algemene Jaarvergaderings. Die Sekretarisse van hierdie Prokureursverenigings word daaraan herinner om die Direkteur van die Kaapse Wetsgenootskap te verwittig van die name van die lede van hul Komitees sodra die verkiesing plaasgevind het.
