PRIVATE SECURITY INDUSTRY REGULATION ACT, 2001 (ACT NO. 56 OF 2001): EXEMPTION IN TERMS OF SECTIONS 1(2) AND 20(5) OF THE ACT

By virtue of the power vested in the Minister of Police by sections 1(2) and 20(5) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), I, Emmanuel Nkosingithi Mthethwa, hereby determine that J Ramchandran (ID No. 650926 5131 189) is exempted from the provisions of section 23(1)(c) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), for a period of five years from date hereof, on condition that -

- he meets all other registration requirements as contemplated in the Act;
- he may not directly or indirectly participate or influence the decisions relating to the day-to-day security services provided by Nicholls & Steyn (Pty) Ltd;
- he may not function as a security service provider ; and
- he remain in the employment of Nicholls & Steyn (Pty) Ltd in the same position as indicated in his application.


