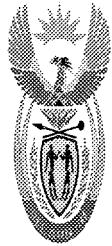

NOTICE 760 OF 2012**INTERNATIONAL TRADE ADMINISTRATION COMMISSION****NOTICE OF INITIATION OF THE SUNSET REVIEW OF THE ANTI-DUMPING DUTIES ON PLATES AND SHEETS, FILM, FOIL AND STRIP OF POLYMERS OF VINYL CHLORIDE (“PVC”) ORIGINATING IN OR IMPORTED FROM THE PEOPLE’S REPUBLIC OF CHINA AND CHINESE TAIPEI**

In accordance with the provisions of Section 53.1 of the Anti-Dumping Regulations of the International Trade Administration Commission of South Africa (ADR), any definitive anti-dumping duty shall be terminated on a date not later than five years from the date of imposition, unless the authorities determine, in a review initiated before that date on their own initiative or upon a duly substantiated request made by or on behalf of the domestic industry within a reasonable period of time prior to that date, that the expiry of the duty would be likely to lead to continuation or recurrence of dumping and material injury.

On 01 July 2011 the International Trade Administration Commission (the Commission) notified all interested parties, through Notice No 226 of 2011. in Government Gazette No.31342, that unless a substantiated request is made by the SACU industry indicating that the expiry of the anti-dumping duties on the subject product originating in or imported from the People’s Republic of China (the PRC) and Chinese Taipei would likely lead to the continuation or recurrence of dumping and material injury. The relevant anti-dumping duties on the subject product originating in or imported from the PRC and Chinese Taipei will expire on 25 October 2012.

On 26 June 2012, the International Trade Administration Commission of South Africa (the Commission) accepted a sunset review application from Arengo 190 (Pty) Ltd representing the SACU industry, alleging that the expiry of anti-dumping duties on the subject product originating in or imported from the PRC and Chinese Taipei would likely lead to the recurrence of dumping and material injury.

THE APPLICANT

The application was lodged by Arengo 190 (Pty) Ltd representing the SACU industry. Arengo 190 (Pty) Ltd represents 86 per cent by production volumes of the SACU producers of the subject product. The applicant alleged that the expiry of the anti-dumping duties would likely lead to the recurrence of dumping and the recurrence of material injury. The applicant submitted sufficient evidence and established a *prima facie* case to enable the Commission to arrive at a reasonable conclusion that a sunset review investigation should be initiated.

THE PRODUCT

The product allegedly being dumped is plates, sheets, film, foil and strip polymers of vinyl chloride ("PVC") non-cellular and not reinforced, laminated, supported or similarly combined with other materials and having a plasticizer content not exceeding 6 per cent. Normally referred to as rigid poly vinyl chloride ("PVC") sheets and foils (PVC Rigid), classifiable under tariff heading 3920.49 originating in or imported from the PRC and Chinese Taipei.

THE ALLEGATION OF THE CONTINUATION OR RECURRENCE OF DUMPING

The allegation of the recurrence of dumping is based on the comparison between the normal value in the PRC and Chinese Taipei, and the export price in the PRC and Chinese Taipei.

PRC

Normal value

The applicant obtained a price quotation from the PRC manufacturer indicating the domestic selling price for the subject product in the PRC.

Export price

The export price was based on a price quotation obtained by the applicant from the PRC manufacturer indicating an FOB export price for the subject product, since the official import statistics under the tariff heading in question includes other products which are not the subject product.

Chinese Taipei**Normal value**

The applicant obtained a price quotation from the Chinese Taipei manufacturer indicating the domestic selling price for the subject product in Chinese Taipei.

Export price

The export price was based on a price quotation obtained by the applicant from the Chinese Taipei manufacturer indicating an FOB export price for the subject product, since the official import statistics under the tariff heading in question includes other products which are not the subject product.

On this basis, the Commission found that there was a *prima facie* proof of the likelihood of recurrence of dumping if the anti-dumping duties expire.

THE ALLEGATION OF THE CONTINUATION OR RECURRENCE OF MATERIAL INJURY

The applicant alleged and submitted *prima facie* evidence to show that should the anti-dumping duties be removed against the PRC and Chinese Taipei, the alleged imports will undercut the SACU's selling price and the applicant will experience price depression and price suppression. The Applicant's information indicated that it would experience a decline in sales volume, sales value, profit margins, output, market share, capacity utilisation, return on investment, employment, wages, cash flow, productivity, and there would be no growth if the anti-dumping duties expire against the PRC and Chinese Taipei.

On this basis, the Commission found that there is *prima facie* proof of the recurrence of material injury should the anti-dumping duties be removed against the PRC and Chinese Taipei.

PERIOD OF INVESTIGATION

The period of investigation for purposes of determining the likelihood of dumping is from 01 March 2011 to 30 April 2012. The period of investigation for purpose of determining the likelihood of material injury involved evaluation of data for the period of March 2009 to April 2012 and the estimates should the anti-dumping duties be removed against the PRC and Chinese Taipei.

PROCEDURAL FRAMEWORK

Having decided that there is sufficient evidence and a *prima facie* case to justify the initiation of a sunset review investigation, the Commission has begun an investigation in terms of section 16 of the International Trade Administration Act, 2002 (the ITA Act).

The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act, the ADR and will give due regards to the World Trade Organisation Agreement on Implementation of Article VI of the GATT 1994 (the Anti-Dumping Agreement). Both the ITA Act and the ADR are available on the Commission's website (www.itac.org.za) or from the Trade Remedies section, on request.

In order to obtain the information it deems necessary for its investigation, the Commission will send non-confidential versions of the application and questionnaires to all known importers and exporters, and known representative associations. The trade representative of the exporting countries has also been notified. Importers and other interested parties are invited to contact the Commission as soon as possible in order to determine whether they have been listed and were furnished with the relevant documentation. If not, they should immediately ensure that they are sent copies. The questionnaire has to be completed and any other representations must be made within the time limit set out below.

CONFIDENTIAL INFORMATION

Please note that if any information is considered to be confidential then a non-confidential version of the information must be submitted for the public file, simultaneously with the confidential version. In submitting a non-confidential version the following rules are strictly applicable and parties must indicate:

- where confidential information has been omitted and the nature of such information;
- reasons for such confidentiality;
- a summary of the confidential information which permits a reasonable understanding of the substance of the confidential information; and
- in exceptional cases, where information is not susceptible to summary, reasons must be submitted to this effect.

The Senior Manager: Trade Remedies II, should receive all responses, including non-confidential copies of the responses, not later than 30 days from the date hereof, or from the date on which the letter accompanying the abovementioned questionnaire was received. If a party considers that any document of another party, on which that party is submitting representations, does not comply with the above rules and that such deficiency affects that party's ability to make meaningful representations, the details of the deficiency and the reasons why that party's rights are so affected must be submitted to the commission in writing forthwith (and at the latest 14 days prior to the date on which that party's submission is due).

Failure to do so timeously will seriously hamper the proper administration of the investigation, and such party will not be able to subsequently claim an inability to make meaningful representations on the basis of the failure of such other party to meet the requirements.

INCREASE:

in the domestic Dollar-based reference price for wheat classifiable under tariff heading 1001.9 from US\$215/ton to US\$326/ton through an adjustment in the variable tariff formula for wheat by the inclusion of a self sufficiency factor of 1.158. Based on the international price information at the time the application was made, the requested formula would trigger an increase in the duty on wheat as well as wheaten flour classifiable under tariff heading 1101.00, from free of duty to 40.91c/kg and 61.36c/kg, respectively. It should be noted that this level of increase is based on price information as on 25 April 2012 when Grain SA's application was received.

Using the requested reference price of US\$326/ton, the variable tariff formula for wheat will trigger an increase if the international price of US No.2 HRW falls by US\$10/ton below the base price of US\$273, which is the 3 week moving average price for US No.2 HRW as calculated on 25 April 2012, resulting in a new moving average base price. Conversely, a reduction in the duty will be triggered if the international price of US No.2 HRW increases by US\$10/ton above the base price.

AS REASONS FOR THE APPLICATION THE APPLICANT STATED THAT:

- The existing rate of duty (free) that was implemented in 27 August 2010, rendered the industry vulnerable to global economic recessionary circumstances;
- The existing rate of duty is based on a domestic Dollar-based reference price of US\$215/ton which does not take into account, amongst other things, the current five year average FOB-price for Hard Red Winter (HRW) Nr 2 wheat of US\$288.31/ton;
- The proposed US\$326/ton reference price will allow producers to increase South Africa's self-sufficiency in wheat production over time from the current 47 percent to 85 percent. The SAFEX price at the time of application, i.e. 25 April 2012, is R2700/ton. Grain SA is of the opinion that a floor/ safety net of R 2934/ton would still not be sufficient to encourage the expansion of wheat production in South Africa but could curb the downward trend in production; and
- The existing rate of duty does not provide sufficient protection or encouragement for the wheat industry. The continued existence and growth of the industry is dependent on a stable trade environment.
