3.2 Thermal collectors for domestic solar water heaters that are imported or sold as separate components of a domestic solar water heating system shall comply with the requirements for collectors in Section 4.5 of SANS 1307.

3.3 The applicant shall ensure that every type of solar water heater and/or thermal collector has been approved by the NRCS in accordance with the requirements of Annex A of this compulsory specification before manufacture, import, sale or supply.

3.4 The applicant shall ensure that approved solar water heaters and/or thermal collectors continue to conform to the mandatory requirements of this compulsory specification.

3.5 The applicant shall inform the NRCS of any change in the material, method of manufacture, design or components affecting any mandatory requirement of this compulsory specification. In the event of such change/s the NRCS may, at its discretion, demand the submission of fresh evidence of conformity or a new application for approval.

4. CONFORMITY TO REFERENCED STANDARDS

For the purposes of this compulsory specification, a new edition of a referenced standard shall become effective 12 months from the date of publication as a South African National Standard. When a new edition of a referenced standard is published, products originally approved in accordance with the previous edition of that standard may on application have their approval extended by the NRCS.

ANNEX A - APPROVAL OF INTEGRAL AND CLOSE-COUPLED DOMESTIC SOLAR WATER HEATERS, AND COLLECTORS FOR SOLAR WATER HEATERS**A.1 APPLICATION FOR APPROVAL**

“Furniture, Bedding, Upholstery and Curtain Manufacturing Industry” or **“Industry”** means, without in any way limiting the ordinary meaning of the

expression, the industry in which employers and their employees are associated for the manufacture, either in whole or in part, of all types of components of furniture, furniture, bedding, curtains, upholstery and/or re-upholstery and will, inter alia, include but not be limited to the following:

(a) Furniture
