NOTICE OF NOMINATIONS

NOMINATIONS OF MEMBERS OF THE SOUTH AFRICAN DENTAL TECHNICIANS COUNCIL

(1) Notice is hereby given in terms of section 5 (1) (b) of the Dental Technicians Act, 1979 (Act 19 of 1979) for the submission of nominations of five (5) persons to be appointed by the Minister of Health for a five (5) year term of office, starting on 26 February 2013 of whom:

- a) One shall be a dentist attached to a university having a dental faculty;
- b) One shall be a dental technician or dental technologist attached to an institution at which dental technicians or dental technologists are education and trained; and
- c) three members of the public not registered in terms of the Act, of whom at least one will be appointed on account of his/her knowledge of the law.

(2) A person nominated shall (a) not be an unrehabilitated insolvent, (b) not be disqualified in terms of the Act or the Medical, Dental and Supplementary Health Service Professions Act, 1974 (Act 56 of 1974), and (c) be a South African citizen and permanently resident of the Republic.

(3) Nominations must be submitted in the form of motivation, including a comprehensive curriculum vitae (CV) and a signed letter of acceptance of the nomination from the candidate not later than **16:30 on 09 November 2012**.

(4) Every nomination in respect of which any of the requirements as stipulated above has not been complied with, or which is not received by the aforesaid date and time at the address below, will be considered invalid:

Notice is hereby given in terms of the provisions of the Regulations relating to the Election of Members of the Council that an election of five (5) members of the Council to serve during the period 26 February 2013 and ending on 26 February 2018 is about to be held.

Nominations of eligible persons as provided for in section 5 (1) (c) (d) and (e) of the Dental Technicians Act No.19 of 1979 as amended are awaited. The nomination categories are as follows:

- a. **Two** dental technician contractors nominated and elected by registered dental contractors in terms of section 5.1 (c);
- b. **Two** dental technicians or dental technologists who practice the profession as employees nominated and elected by registered persons working as employees in terms of section 5.1 (d); and
- c. **One** dentist nominated and elected by dentists in terms of section 5.1(e).

A person nominated shall **(a)** not be an unrehabilitated insolvent, **(b)** not be disqualified, in terms of this Act or the Medical, Dental and Health Professions Act, 1974 (Act 56 of 1974 as amended), from practising his profession, **(c)** not be a patient or a President's patient as defined in section 1 of the Mental Health Act, 1973 (Act 18 of 1973), and **(d)** be a South African citizen and permanently resident in the Republic.

Each candidate shall be nominated on a separate nomination form, but any person entitled to vote in the election may sign the nomination forms of any number of candidates not exceeding the number to be elected.

Each nomination form shall state the first names and the surname of the candidate nominated and shall be signed by two persons. The person nominated shall also sign the form, confirming that he or she consents to the nomination. The registered address of each one so signing shall be appended to his or her signature. If the person nominated is unable to sign the nomination form he or she may inform the returning officer by letter or fax on the consent to the nomination.

Every nomination form shall reach the undersigned at the address given below not later than **09 November 2012**.

A deposit of R50 shall accompany the nomination. Every nomination form in respect of which any of these provisions has not been complied with or which is not received by the aforesaid date at the address given below, shall be invalid.
