

SCHEDULE

1. DEFINITIONS

In this Schedule any word or expression to which a meaning has been assigned in the Act shall have that meaning, unless the context otherwise indicates -

“**broker**” means a person dealing with mohair in the course of trade by treating, keeping, conveying, selling or processing mohair on behalf of a producer or cause such actions to be taken on behalf of a producer.

“**exporter**” means a person dealing with mohair in the course of trade by exporting it from the Republic;

“**importer**” means a person dealing with mohair in the course of trade by importing it into the Republic;

“**mohair**” means the removed natural fleece of the angora goat (*Capra angoriensis*) in whatever form;

“**Mohair SA**” means Mohair South Africa Ltd, an association not for gain incorporated under section 21 of the Companies Act, 1973 (Act No. 61 of 1973), with registration number 1997/021800/09;

“**processor**” means a person dealing with mohair in the course of trade by scouring and combing it, or processing it in any other manner, or cause such actions to be taken;

“**producer**” means a person producing mohair or involved in the production of mohair;

“**Republic**” means the Republic of South Africa;

“trader or mohair buyer” means a person dealing with mohair in the course of trade by buying and selling mohair; and

“the Act” means the Marketing of Agriculture Products Act, 1996 (Act No. 47 of 1996), as amended.

2. PURPOSE AND AIMS OF STATUTORY MEASURE AND THE RELATION THEREOF TO OBJECTIVES OF THE ACT

The purpose and aim of this statutory measure is to provide a statutory mechanism for the keeping of records and the furnishing of returns to Mohair SA. This is deemed necessary to ensure that continuous, timeous and accurate statistics and information relating to the sale of mohair is made available to all role-players. The statutory measure will further the objects of the Act as set out in section 2(2) thereof, and will not be detrimental to any of the matters specified in section 2(3) of the Act.

A centralised source of reliable, objective and user-friendly statistics and information on the aggregate profile of the industry at any given point in time, to aid decision-making during the growing, marketing, processing and promotion of South African mohair is an essential tool to continuously position the South African mohair industry nationally and internationally.

Reliable national statistics and objective aggregate information regarding production (on magisterial district basis), sales, price trends and projections, export data are fundamental to the need to increase market access for all participants, but especially developing farmers who need impartial and objective information. Access to a national database of this nature supports the development of efficient marketing mechanisms for mohair and assists in the optimisation of export earnings for all sectors.

The viability of the agricultural sector, particularly in developing areas, can only be accelerated if reliable, inclusive and comprehensive industry data is available to assess the progress of this sector over time against the benchmark of reliable historical data.

This statutory measure will be implemented and administered by Mohair SA, with due consideration of the South African mohair industry's international associations and links and the need to establish a structure that will ensure the ongoing involvement by all affected parties.

Information gathered will be dealt with in the context of section 23(2) of the Act read with the applicable provisions of the Constitution and the Promotion of Access to Information Act.

Mohair SA will provide macro generic industry statistics and information on and for the mohair industry. This information will be made available on an aggregate basis, in an appropriate format.

3. PRODUCT TO WHICH STATUTORY MEASURE APPLIES

This statutory measure shall apply to mohair.

4. AREA IN WHICH STATUTORY MEASURE APPLIES

This statutory measure shall apply within the geographical area of the Republic of South Africa.

5. RECORDS TO BE KEPT BY BROKERS, TRADERS, PROCESSORS, IMPORTERS AND EXPORTERS

(1) Each broker, trader, processor, importer and exporter of mohair shall keep the following records with regard to mohair that he or she has in his or her possession or under his or her control:

(i) *Brokers and traders or mohair buyers*

(a) Monthly receipts of mohair by total mass.

- (b) Monthly purchases of mohair by total mass not for offer for sale by catalogue.
- (c) Details of sale of mohair by catalogue, in respect of all relevant and certified technical specification available.
- (d) Auction sale data of mohair (gross total monthly mohair sales).
- (e) Lots put up for sale at auctions and not knocked down at that auction.
- (f) Monthly payments to producers and other sellers of mohair (total mass and value).
- (g) Total gross value at first point of sale.

(ii) Processors

- (a) Total mass of greasy mohair processed on a monthly basis.
- (b) Total mass of processed output on a monthly basis.

(iii) Exporters

- (a) Description of consignment (greasy, scoured, carbonised, top, noil or waste, as appropriate).
- (b) Mass of consignment.
- (c) Port of export
- (d) Destination of consignment (country where further processing will take place).

(iv) **Importers**

(a) Description of consignment (greasy, scoured, carbonised, top, noil or waste, as appropriate).

(b) Mass of consignment.

(c) Value of consignment

(d) Country imported from.

(2) The records referred to in subsection (1) shall -

(a) be recorded on a computer or with ink in a book; and

(b) be kept at the head office or usual place of business of the person required to keep it for a period of at least four years after the end of the period for which such records must be kept.

6. RETURNS TO BE RENDERED BY BROKERS, TRADERS, PROCESSORS, IMPORTERS AND EXPORTERS

(1) Each broker, trader, processor, importer and exporter of mohair shall within 30 days after the end of each calendar month, furnish to Mohair SA an accurate return of the particulars prescribed in section 5 above.

(2) Notwithstanding the provisions of section 6(1) of this statutory measure, each broker selling mohair by auction, shall furnish an accurate return of the particulars prescribed in (5(1)(i)(b) by not later than close of business on the day following the auction.

(3) The returns referred to in subsection (1), shall be furnished in the form or manner determined by Mohair SA for this purpose, and shall, if furnished on paper, be completed in ink.

(4) The return shall -

PRODUCERS AND PERSONS DEALING WITH MOHAIR IN THE COURSE OF
TRADE**

I, Tina Joemat-Pettersson, Minister of Agriculture, Forestry and Fisheries, acting under sections 13 and 19 of the Marketing of Agricultural Products Act, 1996 (Act No. 47 of 1996), hereby establish the statutory measure set out in the Schedule.

SCHEDULE

1. DEFINITIONS

In this Schedule any word or expression to which a meaning has been assigned in the Act shall have that meaning, and unless the context otherwise indicates -

“broker” means a person dealing with mohair in the course of trade by treating, keeping, conveying, selling or processing mohair on behalf of a producer or cause such actions to be taken on behalf of a producer.

“exporter” means a person dealing with mohair in the course of trade by exporting it from the Republic;

“importer” means a person dealing with mohair in the course of trade by importing it into the Republic;

“mohair” means the removed natural fleece of the angora goat (*Capra angoriensis*) in whatever form;

“Mohair SA” means Mohair South Africa Ltd, an association not for gain incorporated under section 21 of the Companies Act, 1973 (Act No. 61 of 1973), with registration number 1997/021800/09;

“processor” means a person dealing with mohair in the course of trade by scouring and combing it, or processing it in any other manner, or cause such actions to be taken;

“producer” means a person producing mohair or involved in the production of mohair;

“Republic” means the Republic of South Africa;

“the Act” means the Marketing of Agriculture Products Act, 1996 (Act No. 47 of 1996), as amended; and

“trader or mohair buyer” means a person dealing with mohair in the course of trade by buying and selling mohair.

2. PURPOSE AND AIMS OF STATUTORY MEASURE AND THE RELATION THEREOF TO OBJECTIVES OF THE ACT

The purpose and aim of this statutory measure is to provide a statutory mechanism for producers, brokers, traders or mohair buyers, processors, importers and exporters to register with Mohair SA. A central database of names and contact details of individuals and organizations involved in the production, trading, processing, exporting and importing of mohair supports the accurate and efficient gathering of data. The associated statutory measure of records and returns provide the framework for recording this data on a customized national mohair industry database.

Mohair SA's mandate and purpose is to facilitate access to the mohair market for all participants, to promote the efficiency of the Marketing of mohair and to optimize the export income from mohair as per the objective of the Act.

3. PRODUCT TO WHICH STATUTORY MEASURE APPLIES

This statutory measure shall apply to mohair.

4. AREA IN WHICH STATUTORY MEASURE APPLIES

This statutory measure shall apply within the geographical area of the Republic of South Africa.

5. REGISTRATION OF PRODUCERS, BROKERS, TRADERS, PROCESSORS, IMPORTERS AND EXPORTERS

- (1) All producers, brokers, traders, processors, importers and exporters shall register as such with Mohair SA in the manner set out in section 6.
- (2) An application for registration in terms of subsection (1) shall be made within 30 days from the date of commencement of this statutory measure and, in the case of of person becoming a producer, broker, trader, processor, importer and exporter after such date of commencement, within 30 days of becoming a producer, broker. trader, processor, importer and exporter.
- (3) Upon registration a certificate of registration shall be issued to the applicant.
- (4) A registration certificate issued in terms of subsection (3) shall lapse -
 - (a) on the date of expiry of this measure as granted by the Minister; or
 - (b) upon cancellation in terms of subsection (6) of this statutory measure.
- (5)
 - (a) An application for continued registration shall be lodged at least 30 days before the termination date in terms of subclause (4) (a) above.
 - (b) The provision of clause 6 shall *mutatis mutandis* apply to an application for continued registration.
- (6) Each producer, broker, trader, processor, importer and exporter shall within 30 days of ceasing to be a producer, broker, trader, processor, importer and exporter notify Mohair SA in writing thereof whereupon his or her registration shall be cancelled.

6. APPLICATION FOR REGISTRATION AS PRODUCER, BROKER, TRADER, PROCESSOR, IMPORTER AND EXPORTER

- (1) An application for registration shall be furnished in the form or manner determined by Mohair SA for this purpose, and shall, if furnished on paper, be completed in ink.

Unless required for the purposes of optical astronomy and related scientific endeavours and authorised by the relevant management authority or party with whom the management authority has entered into a co-management agreement, no person may, within the core astronomy advantage area declared as such for the purposes of optical astronomy and related scientific endeavours in terms of section 7 of the Act, conduct any of the following activities;
 - (a) use of the core astronomy advantage area for any purpose other than for optical astronomy and related scientific endeavours;
 - (b) Installation of additional outdoor lighting;
 - (c) access to the restricted area which is controlled by the operating institution as determined by the management authority without authorisation;
 - (d) light emission in the wavelength range from 300 to 5,000 nanometres that could be directly or indirectly detected by the telescopes;
 - (e) activities capable of reducing the transparency of the atmosphere to optical radiation, including but not limited to, the production of dust or smoke;
 - (f) prospecting or mining activities;
 - (g) harmful industrial processes;
 - (h) the construction and development of new business or residential premises or recreational facilities, or
 - (i) any other activity which might detrimentally impact on astronomy and related scientific endeavours, or the astronomy advantage of

the core astronomy advantage area declared for the purposes of optical astronomy and related scientific endeavours.

COMPETITION COMMISSION

APPLICATION FOR AN EXEMPTION

Notice is hereby given in terms of section 10(6)(a) of the Competition Act, No. 89 of 1998, as amended ("the Act"), that the South African Airways (Pty) Ltd (herein referred to as "SAA"), a state owned company, registered in terms of the Company Act of 1973, has applied to the Competition Commission ("the Commission"), in terms of section 10(1) of the Act, to be exempted from certain provisions of Chapter 2 of the Act. SAA is active in the business of providing passenger and cargo air transportation services in South Africa, the African region and internationally.

The subject matter of the application is a code share agreement between SAA and Qantas Airways Limited ("Qantas") on the South African / Australian routes.

It should be noted that the Commission had previously exempted this agreement and SAA is in essence asking it to again consider granting another exemption.

In particular, SAA has requested the Commission that it be permitted to engage in the following activities:

- ❑ Co-ordinate its activities with Qantas in respect of the two airlines routes between South Africa and Australia.
- ❑ Allocate the market in terms of which SAA will operate on the route between Johannesburg and Perth, while Qantas will operate the Johannesburg – Sydney route.
- ❑ Acquire blocks of seats, in various classes, on the each other's aircraft.

SAA and Qantas are in a horizontal relationship, being a relationship between competitors. Previous exemptions granted by the Commission concluded that this code share

agreement constitutes a prohibited practice in that it involves the division of the market by allocating territories, a contravention of section 4(1)(b)(ii) of the Act.

Section 10(3)(b) of the Act provides for four grounds on which the exemption may be granted. SAA avers in its application that the code share agreement is required for:

- The maintenance and promotion of exports [section 10(3)(b)(i)];
- A change in productive capacity necessary to stop decline in an industry [section 10(b)(iii)].

SAA seeks this exemption for a period of three (3) years, commencing on 01 January 2013 and ending on 31 December 2015.

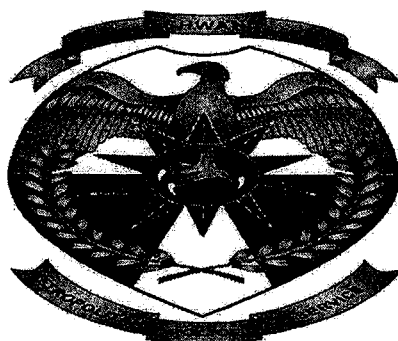

- (4) The council may, in the case of a specific subject, accredit a person to teach such subject: Provided that the council shall first consult the relevant professional board and the council shall satisfy itself that such person is competent to lecture such subject.

General

The council shall afford an educational institution an opportunity until June 2013 to meet and comply with the above prescribed requirements and non-compliance with these requirements by institutions will be subject to the provisions of Section 16F of the Act.
