

## 1. Definitions

In this schedule, unless the context indicates otherwise, any word or expression to which a meaning has been assigned in the Act has the same meaning, and –

**“global infrastructure”** refers to international large research infrastructures, both single-sited and distributed, linked by high-speed networks for optimal sharing of data and resources, which provide research and development capability beyond the resources available at regional or national levels;

**“higher education institution abroad”** means any institution of higher learning with a mandate to offer and confer higher education qualifications, and recognised as such by the government of the relevant country;

**“interested party”** means any researcher or research institution that may apply to utilise a national facility for research or instruction in terms of section 5 (2) of the Act;

**“public higher education institution”** means any institution which has been established, is deemed to have been established or is declared to be a public higher education institution in terms of the Higher Education Act, 1997 (Act No. 101 of 1997);

**“research infrastructure”** includes scientific equipment, specialised facilities, and global infrastructure;

**“scientific equipment”** means a discrete or networked, free-standing or mounted, desk-top to large, dedicated or multi-purpose usage research tool including all necessary ancillary items;

**“specialised facility”** refers to a physical and/or organisational structure of a capital nature which provides a controlled environment for specialised experiments and is required to ensure the optimal performance of research equipment, particularly in the advanced scientific equipment category; and

**“the Act”** means the National Research Foundation Act, 1998 (Act No.5 of 1998).

## **2. Application**

The scope of this declaration excludes the South African Agency for Science and Technology Advancement (SASTA), a component of the NRF whose mandate is not research.

This declaration applies to the following funding categories of the National Research Foundation (NRF):

- 2.1 Postgraduate studies at Honours, Masters and Doctoral levels;
- 2.2 Postdoctoral fellowships;
- 2.3 Research equipment; and
- 2.4 Grants (e.g., research grants, travel grants, capacity development grants, etc).

## **3. Declaration of research institutions**

- 3.1 With reference to qualification-offering research-performing institutions offering postgraduate studies at honours, masters and doctoral levels, as well as postdoctoral fellowships contemplated in subparagraphs 2.1 and 2.2; only public higher education institutions are declared as research institutions.
- 3.2 With reference to research-performing institutions offering postdoctoral fellowships contemplated in sub-paragraph 2.2, or eligible for support in the acquisition of research equipment contemplated in subparagraph 2.3, or whose researchers are eligible for support through various forms of grants contemplated in sub-paragraph 2.4, the following types of institutions are declared research institutions:
  - (a) Public Higher Education Institutions;
  - (b) National Facilities of the NRF declared by the Minister in terms of section 5(1) of the Act;
  - (c) Research-performing museums declared as such under the Cultural Institutions Act, 1998 (Act No. 119 of 1998), and those which house national collections relevant in conducting research;

- (d) The following science councils, whose legislative mandates generally centre around promotion of research development, and technology innovation and transfer in their various fields of operation:
- (i) The Human Sciences Research Council, established by the Human Sciences Research Act, 1968 (Act No. 23 of 1968), and retained by the Human Sciences Research Act, 2008 (Act No. 17 of 2008);
  - (ii) The Council for Scientific and Industrial Research, established by the Scientific Research Council Act, 1945 (Act No. 33 of 1945) and retained by the Scientific Research Act, 1988 (Act No. 46 of 1988);
  - (iii) The Agricultural Research Council, established by the Agricultural Research Act, 1990 (Act No. 86 of 1990);
  - (iv) The South African Medical Research Council, established by the South African Medical Research Council Act, 1969 (Act No. 19 of 1969), and retained by the South African Medical Research Act, 1991 (Act No. 58 of 1991);
  - (v) The Council for Geoscience, established by the Geoscience Act, 1993 (Act No. 100 of 1993);
  - (vi) The Council for Mineral Technology (Mintek), established by the Mineral Technology Act, 1981 (Act No. 84 of 1981), and retained by the Mineral Technology Act, 1989 (Act No. 30 of 1989);

institutions supporting these departments in fulfilling their mandates; and

(f) The South African Environmental Observation Network.

3.3 With reference to research-performing institutions offering postgraduate studies at honours, masters and doctoral levels or postdoctoral fellowships or eligible for support in the acquisition of research equipment, or whose researchers are eligible for support through various forms of grants contemplated in paragraph 2, the following institutions do not qualify to be declared as research institutions:

- (a) Centre for Education Policy Development;
- (b) Monash South Africa;
- (c) National Metrology Institute of South Africa;
- (d) Paleontological Scientific Trust;
- (e) Oceanic Research Institute, a division of the South African Association for Marine Biological Research;
- (f) South African Institute of Chartered Accountants;
- (g) South African Sugarcane Research Institute (SASRI);
- (h) Water Research Commission and
- (i) South African Weather Bureau.

3.4 The institutions referred to in sub-paragraph 3.3 shall remain eligible for funding support in line with the current funding categories of the NRF for a period of not more than one year from the date of commencement of the declaration. Beyond this period continued support for some of these institutions will happen through the declared research institutions they are attached to. Their exclusion from being declared as research institutions is based on one or more of the following reasons:

- (a) They are attached to higher education institutions and are eligible to receive funding for one or more of the categories (bursaries and scholarships; postdoctoral fellowships; research equipment and research grants) through these institutions;

- (b) They are private or non-governmental institutions, and at present the aim is to strengthen research-intensive public institutions; and/or
- (c) Their legislative mandates fall outside the scope of research and technology development.

**NOTICE 866 OF 2012****INTERNATIONAL TRADE ADMINISTRATION COMMISSION****NOTICE OF INITIATION OF THE SUNSET REVIEW OF THE ANTI-DUMPING DUTIES ON GARDEN PICKS & SPADES, SHOVELS, RAKES AND FORKS ORIGINATING IN OR IMPORTED FROM THE PEOPLE'S REPUBLIC OF CHINA (PRC)**

In accordance with the provisions in Article 53.1 of the Anti-Dumping Regulations (ADR), any definitive anti-dumping duty shall be terminated on a date not later than five years from the date of imposition, unless the International Trade Administration Commission (the Commission) determines, in a review initiated before that date on its own initiative or upon a duly substantiated request made by or on behalf of the domestic industry, that the expiry of the duty would likely lead to continuation or recurrence of dumping and material injury.

On 27 May 2011 the Commission notified the interested parties through Notice No.308 of 2011 in Government Gazette No. 34307, that unless a substantiated request is made indicating that the expiry of the anti-dumping duties against imports of garden picks, spades & shovels, forks and rakes originating in or imported from the People's Republic of China (PRC) would likely lead to the continuation or recurrence of dumping and injury, the anti-dumping duties on garden picks, spades & shovels, forks and rakes originating in or imported from the PRC would expire on 01 November 2012.

A response to the sunset review application questionnaire was received from Ussher Inventions (Pty) Limited trading as Lasher Tools on behalf of the Southern African Customs Union (SACU) industry on 1 June 2012.

The Applicant alleges that the expiry of the duties would likely lead to continuation or recurrence of dumping and the continuation or recurrence of material injury. The Applicant submitted sufficient evidence and established a *prima facie* case to enable the Commission to arrive at a reasonable conclusion that a sunset review investigation should be initiated.

### THE APPLICANT

The application was lodged by Ussher Inventions (Pty) Limited trading as Lasher Tools (the Applicant), the major producer of spades & shovels, forks and rakes and the only producer of picks within the SACU.

### THE PRODUCTS

The products allegedly being dumped are picks, spades & shovels, forks and rakes originating in or imported from the PRC and classifiable under the following tariff sub-headings:

### THE ALLEGATION OF THE CONTINUATION OR RECURRENCE OF DUMPING

The allegation of continuation or recurrence of dumping is based on the comparison between the normal values and the export prices.

The Applicant obtained domestic price quotations from the PRC to calculate normal values for picks, spades & shovels, forks and rakes. The Applicant used SARS import statistics to determine the export prices for picks, spades & shovels, forks and rakes from the PRC. The dumping margins were calculated as follows:

| RMB/Unit       | Spades & shovels | Picks | Rakes | Forks |
|----------------|------------------|-------|-------|-------|
| Dumping Margin | 52.1%            | 73.3% | 32.1% | 25.9% |

On this basis, the Commission found that there was *prima facie* proof of the likelihood of continuation or recurrence of dumping if the duties expire.

### THE ALLEGATION OF CONTINUATION OR RECURRENCE OF MATERIAL INJURY

The Applicant alleges and submitted *prima facie* evidence to show that it would experience a decline in sales, production, market share, capacity utilisation, productivity employment and growth if the duties expire. The Applicant's information further indicated that it will make losses, have negative net cash inflows, a further increase in inventories and will not be able to raise capital or obtain any investments if the duties expire.

On this basis, the Commission found that there was *prima facie* proof of the likelihood of continuation or recurrence of material injury if the duties expire.

### PERIOD OF INVESTIGATION

The investigation period for dumping is from 01 July 2011 to 30 June 2012 and the injury investigation involves evaluation of data for the period of 01 July 2008 to 30 June 2011 and 2012 budgeted figures. The Commission will also consider an estimate of what the situation will be, if the anti-dumping duties expire.

## PROCEDURAL FRAMEWORK

Having decided that there is sufficient evidence and a *prima facie* case to justify the initiation of a sunset review investigation, the Commission has begun an investigation in terms of section 16 of the International Trade Administration Act, 2002 (the ITA Act). The Commission will conduct its investigation in accordance with the relevant sections of the ITA Act and the ADR. Both the ITA Act and the ADR are available on the Commission's website ([www.itac.org.za](http://www.itac.org.za)) or from the Trade Remedies section, on request.

In order to obtain the information it deems necessary for its investigation, the Commission will send non-confidential versions of the application and questionnaires to all known importers and known representative associations. Known foreign producers of garden picks, spades & shovels, forks and rakes and the trade representative of the country of origin have also been notified, and have been requested to advise other possible foreign producers accordingly.

Importers and other interested parties are invited to contact the Commission as soon as possible in order to determine whether they have been listed and were furnished with the relevant documentation. If not, they should immediately ensure that they are sent copies. The questionnaire has to be completed and any other representations must be made within the time limit set out below.

## CONFIDENTIAL INFORMATION

Please note that if any information is considered to be confidential then a non-confidential version of the information must be submitted for the public file, simultaneously with the confidential version. In submitting a non-confidential version the following rules are strictly applicable and parties must indicate:



- where confidential information has been omitted and the nature of such information;
- reasons for such confidentiality;
- a summary of the confidential information which permits a reasonable understanding of the substance of the confidential information; and
- in exceptional cases, where information is not susceptible to summary, reasons must be submitted to this effect.

This rule applies to all parties and to all correspondence with and submissions to the Commission, which unless indicated to be confidential and filed together with a non-confidential version, will be placed on the public file and be made available to other interested parties.

If a party considers that any document of another party, on which that party is submitting representations, does not comply with the above rules and that such deficiency affects that party's ability to make meaningful representations, the details of the deficiency and the reasons why that party's rights are so affected must be submitted to the Commission in writing forthwith (and at the latest 14 days prior to the date on which that party's submission is due). ## PROCEDURES AND TIME LIMITS

The Senior Manager: Trade Remedies I should receive all responses, including non-confidential copies of the responses, not later than 30 days from the date hereof, or from the date on which the letter accompanying the abovementioned questionnaire was received. The said letter shall be deemed to have been received seven days after the day of its dispatch.

Late submissions will not be accepted except with the prior written consent of the Commission. The Commission will give due consideration to written requests for an extension of not more than 14 days on good cause shown (properly motivated and substantiated), if received prior to the expiry of the original 30-day period. The CPI index for August 2012 was 124,2. This adjustment was calculated by multiplying the R160'000 limit by 124,2/98,7.
