I, Tina Joemat-Petterssen, Minister for Agriculture, Forestry and Fisheries, acting under sections 13 and 15 of the Marketing of Agricultural Product Act, 1996 (Act No. 47 of 1996), hereby established the statutory measure set out in the Schedule.

SCHEDULE**Definitions**

1. In this Schedule any word or expression to which a meaning has been assigned in the Act shall have that meaning, and unless the context indicates otherwise-

“Exporter” means a person who trades table grapes for export for his own account, or acts as an agent on a commission basis on behalf of table grape producers;

“Grape Producers” means a producer of fresh table grapes intended for table grape exports;

“SAT” means South African Table Grape Producers’ Association, which is an association of farmers who produce table grapes within the borders of South Africa. The principle office of SAT is 2 Bergsig Avenue, Zomerlust Estate, Berg River Boulevard, Paarl, 7620, Western Cape, South Africa;

“SATI” means the South African Table Grape Industry, a section 21 company incorporated in terms of the Companies Act (61 of 1973) whose members are all members of SAT. SATI is the operational arm of SAT and its principle office is 2 Bergsig Avenue, Zomerlust Estate, Berg River Boulevard, Paarl, 7620, Western Cape, South Africa;

“Table grapes” means fresh table grapes; and

“Vines” means vines intended for the production of table grapes.

A person shall have a choice to register as either a producer or an exporter. A person who is a producer as well as an exporter must register as a producer and as an exporter.

Purpose and aims of statutory measure and the relation thereof to the objectives of the Act

2. The levy is needed by the SAT to fund and facilitate market access; information and communication; research and development programmes and technology transfer; transformation and training, and administration for table grapes.

These measures are necessary to ensure that continuous, timeous and accurate information relating to the table grape industry is available to all role players in order for them to make informed decisions in the spheres as indicated.

The measure will not be detrimental to the number of employment opportunities or fair labour practice and will support the statutory measures relating to registration and the rendering of returns applicable to table grapes.

The measure will be administered by SATI, a company established under Section 21 of the Companies Act, 1973 (Act 61 of 1973). SATI will implement and administer the measure as set out in the Schedule on behalf of SAT, a company incorporated under section 21 of the Companies Act, 1973 (Act 61 of 1973).

Products to which statutory measure applies

3. This statutory measure shall apply to inspected volumes of table grapes passed for export.

Area in which measures applies

4. This statutory measure shall apply in the geographical area of the Republic of South Africa

Imposition of levy

5. A levy is hereby imposed to be paid on inspected volumes of table grapes passed for export.

Amount of levy

6. The amount of the levy shall be 8c/kg on all inspected volumes of table grapes passed for export (all classes). An amount of 1% interest will be charged on all overdue accounts.

Persons by whom levy and to whom levy is payable

7. (1) The levy imposed under clause 5 shall –
 - (a) be payable by a table grape exporter on behalf of the producer from which such table grapes have been procured in respect of all table grapes exported.

- (2) A levy imposed under clause 5 shall be payable to SATI in accordance with clause 8.

Payment Levy

8. (1) Payment of the levy shall be made not later than (30 days) following the month end of the inspection of a quantity of table grapes passed for export.
- (a) any payment not paid within this period will be charged interest at a rate of 1% per month.
- (2) Payment shall be made by means of a cheque or electronic transfer in favour of SATI, and shall –
- (a) when paid by cheque, be addressed to

- (b) when electronically transferred, be paid to the bank account obtainable from SATI on request.

Use of levy

9. The minister approves that-
- (a) at least 70% of the levy funds should be used for the core business functions e.g. research;
- (b) not more than 10% for administrative use; and
- (c) at least 20% be allocated towards transformation and training

Commencement and period of validity

10. This statutory measure shall come into operation on the date of publication hereof and lapse four (4) years later.

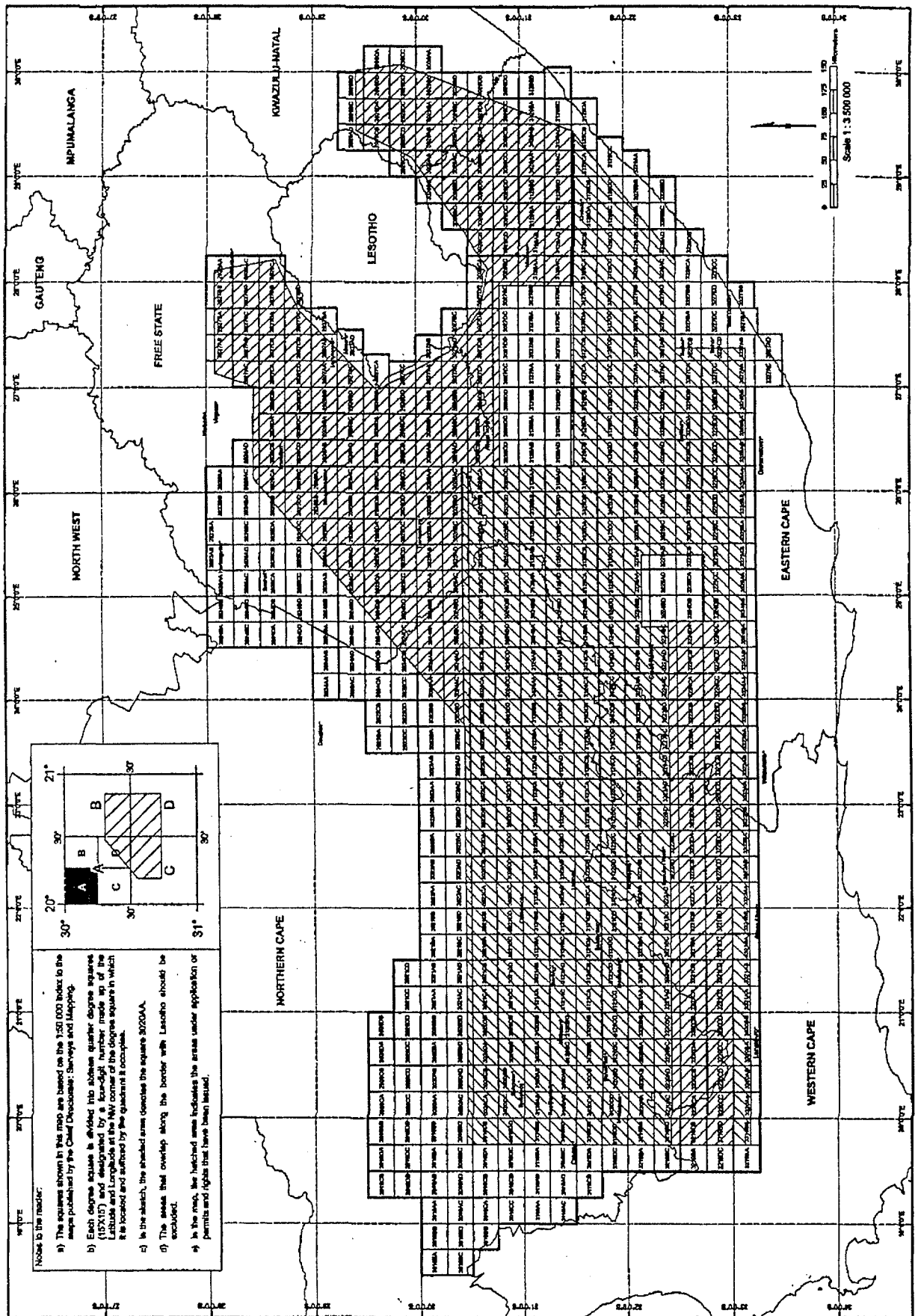

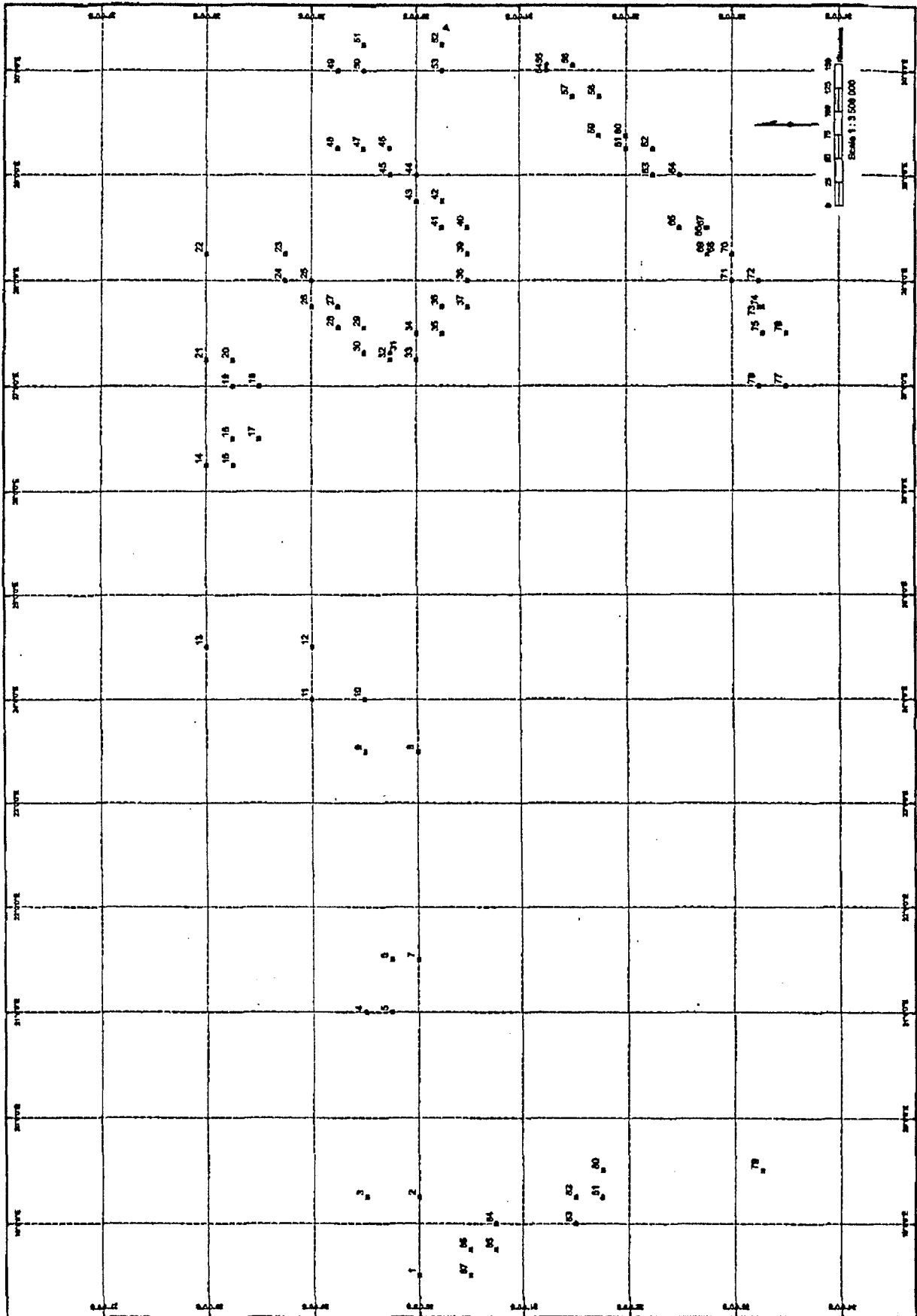

The effect of the IDOW rules is that certain unregistered professionals are prevented from performing work identified for any category of the registered professionals. CONTINUING PROFESSIONAL DEVELOPMENT

The Allied Health Professions Council of South Africa (AHPCSA), having consulted with the Professional Boards for Homeopathy, Naturopathy, and Phytotherapy (PBHNP), Chiropractic and Osteopathy (PBCO), Therapeutic Aromatherapy, Therapeutic Reflexology, Therapeutic Massage Therapy (PBARM) and for Ayurveda, Chinese Medicine and Acupuncture and Unani-Tibb (PBACMU), announces that Continuing Professional Development (CPD) will be instituted from 1 July 2013.

REQUIREMENTS FOR CONTINUING PROFESSIONAL DEVELOPMENT

1. As from 01 July 2013, all registered practitioners and therapists, whose names appear on the registers kept in terms of Section 14 of the Allied Health Profession Act 63 of 1982 (as amended) 'the Act', are required to comply with the conditions of continuing professional development laid down in this Board Notice or any subsequent Board Notice as a prerequisite for such practitioner to retain his or her registration in terms of the Act.
2. For the purposes of complying with the requirements of continuing professional development the following conditions shall apply:
 - 2.1 CPD will run over a **two (2) year cycle** with all registered practitioners and therapists required to accumulate **40 Continuing Education Units (CEUs) per cycle**;

- 2.2 In order to facilitate the implementation of the new system all registered practitioners and therapists **currently registered** with the AHPCSA will be given a **starting balance of 20 CEUs**;
 - 2.3 Any person, who is registered as a practitioner or a therapist for the first time after 1 July of a particular year, will commence with his / her CPD programme immediately. CEU values will be calculated on a pro-rata basis for the remainder of that year;
 - 2.4 Registered practitioners and therapists who accumulate more than 40 CEU values in a cycle will be permitted to carry over to a **maximum of 10 CEUs** to the next cycle;
 - 2.5 Registered practitioners and therapists shall be required to obtain a **minimum of two (2) CEUs** in AHPCSA specific Jurisprudence and Ethics per CPD cycle, while the balance of CEUs may be acquired at a single level or across all levels; and
 - 2.6 Registered practitioners and therapists who are registered in more than one (1) Allied Health profession will be required to obtain **30 CEUs per profession** with a **minimum of two (2) CEUs** for AHPCSA specific Jurisprudence and Ethics per CPD cycle.
3. CEUs are linked to a hierarchy of learning activities based on whether the outcome is measurable or not, or is a structured learning programme. The prescribed units in 2 above shall be accumulated by way of different educational or developmental activities approved by the AHPCSA in any of the following levels of activities:
 - 3.1 **Level one** activities with non-measurable outcomes, limited to a maximum of six (6) units in any one (1) year period;
 - 3.2 **Level two** activities with measurable outcomes; and
 - 3.3 **Level three** activities with formally structured learning programmes.
4. Cross Recognition of CEUs
 - 4.1 Registered practitioners and therapists shall obtain their CEUs from approved CPD service providers within their own registered profession(s), within professions of the same registration category grouped under the same professional board or within another registered profession, provided that any such activity shall be in accordance with his or her scope of practice;
 - 4.2 Any CPD service provider from other registered healthcare professions registered under other statutory health councils may apply for approval to be accredited by the AHPCSA as an AHPCSA CPD service provider provided

that the CPD programme is an existing pre-approved CPD programme by that statutory health council; consideration of approval will require that that CPD programme lies within the scope of practice of an AHPCSA registered practitioner or therapist or may be of relevance to the CPD of that AHPCSA registered practitioner or therapist; and

- 4.3 In the case of international conferences approval shall be sought from the AHPCSA.
5. Deferment or exemption from compliance with the requirements of continuing professional development for any specific period may be granted to individual practitioners or therapists by the AHPCSA on application and submission of adequate reasons for such request and subject to any such conditions as the AHPCSA may determine.
6. In the event of a practitioner or therapist not complying with the requirements specified in these rules within the prescribed time frames:
 - 6.1 Such an omission shall be considered an omission in terms of Section 29 of the Act, under which the AHPCSA may take disciplinary action, and
 - 6.2 The AHPCSA may impose one or more of the following sanctions on the defaulting practitioner or therapist:
 - (a) such programme of continuing professional development as may be determined by the professional board;
 - (b) an examination as may be determined by the professional board;
 - (c) or any other disciplinary action as set out in Section 24(1) of the Act; or
 - (d) any other appropriate action as may be determined by the AHPCSA.

APPROVAL OF CONTINUING PROFESSIONAL DEVELOPMENT SERVICE PROVIDERS

7. Any person, institution, body, facility or organisation wishing to offer CPD to registered practitioners or therapists may apply to the AHPCSA for approval as a service provider.
 - 7.1 An application for approval as a service provider shall be:-
 - (a) submitted on the relevant application form obtainable from the AHPCSA, duly completed;
 - (b) supported by all the documentation as set out in the guidelines for service providers, which are obtainable from the AHPCSA; and
 - (c) accompanied by the prescribed fee.
 - 7.2 An application for approval as a service provider may be granted to any person, institution, body, facility or organisation complying with the

requirements of these rules and guidelines for continuing professional development as issued by the AHPCSA.

- 7.3 In the event that an application for approval has been declined, the applicant may appeal against the decision.
- 7.4 The appeal referred to in (7.3) must be submitted within 3 months from date on which the application was declined and must be accompanied by the documents referred to in (7.1) and written representations in response to the decision.
- 7.5 The AHPCSA, in consultation with the professional board, may after due consideration of an appeal brought to it in terms of (7.3), grant or decline the appeal.
- 7.6 An approval granted in terms of (7.2) or (7.5) shall be valid for a period of twelve months.

IMPLEMENTATION AND APPLICATION OF CONTINUING PROFESSIONAL DEVELOPMENT

8. CPD shall apply to every person registered as a practitioner or therapist under the Act.
 - 8.1 AHPCSA approved Guidelines for Continuing Professional Development are published on www.ahpcs.co.za > Continuing Professional Development (CPD) > Guidelines.
 - 8.2 Applications from any person, institution, body, facility or organisation interested in offering CPD courses for Allied Health Professions must be in the prescribed manner as per the documentation published on www.ahpcs.co.za > Continuing Professional Development (CPD) > Service Provider Application.

The CPD operates on a system of trust and as such all individual registered practitioners and therapists that attend CPD activities in order to comply with the statutory requirements as determined by the AHPCSA shall ensure that he/she is in possession of a certificate of attendance and shall keep such certificates of attendance for a minimum of two years on record to comply with random compliance checks.

RULES IN TERMS OF SECTION 36(1) REQUIREMENTS FOR RECOGNITION AS A VOLUNTARY ASSOCIATION**SCHEDULE****1. DEFINITIONS**

In these rules, and unless the context otherwise indicates, any expression or word to which a meaning has been assigned in the Architectural Professions Act, 2000 (Act 44 of 2000), bears the same meaning and -

- (1) "**Annual fees**" means the fees determined by the Council in terms of section 12(1)(c) of the Act;
- (2) "**Built Environment Councils**" means a Council referred to in section 1(iv) a-f of the Council for the Built Environment Act, 2000 (Act No. 43 of 2000);
- (3) "**Council for the Built Environment**" abbreviated as CBE, as established under the Council for the Built Environment Act, 2000 (Act No. 43 of 2000);
- (4) "**Code of Professional Conduct**" means the code of conduct drawn up by the Council in terms of section 27(1) of the Architectural Professions Act, 2000 (Act 44 of 2000);
- (5) "**Council**" means South African Council for the Architectural Profession established by Section 2 of the Architectural Professions Act, 2000 (Act 44 of 2000);
- (6) "**Governing body**" means the highest authority of a voluntary association charged with controlling the affairs of the voluntary association;
- (7) "**In Good Standing**" means that a member of an association who is not regarded by such an association as being in default of its constitution, by-laws and any relevant statutory requirements;
- (8) "**Minister**" means the Minister responsible for Public Works in terms of section 1 (ix) of the Architectural Professions Act, 2000 (Act 44 of 2000);
- (9) "**Non- Recognised Voluntary Association**" means an association not recognised by the Council as a Voluntary Association in terms of section 25 of the Act, but whom may be considered by Council in terms of section 3 (1) (c) and 4 (2) of the Act.
- (10) "**Non-Voting**" member means a member of a Voluntary Association who is not eligible to vote in terms of its constitution.
- (11) "**Recognised Voluntary Association**" means an association recognised by the Council as a Voluntary Association in terms of section 25 of the Act, and
- (12) "**Registered Persons**" means persons registered in any of the categories of registration referred to section 18(1) of the Act;
- (13) "**Relevant Statutory Requirements**" means statutory requirements as determined by the SACAP Council from time to time;
- (14) "**The Act**" means the Architectural Profession Act, 2000 (Act No.44 of 2000) as signed by the President of the Republic of South Africa.
- (15) "**Voting Member**" means a member of a Voluntary Association who is entitled to vote in terms of its constitution;
- (16) "**Voluntary Association**" for purposes of these rules means an institute, institution, association, society or federation of natural persons engaged in the architectural profession and/or built environment within any of the categories of registration as specified in **section 18 (1)** of the Act and with the association established by Architectural practitioners to promote their collective professional and/ or business interests;

3. REQUIREMENTS WITH WHICH AN ASSOCIATION MUST COMPLY TO QUALIFY FOR RECOGNITION AS A VOLUNTARY ASSOCIATION

Any association wishing to be recognised as a Voluntary Association must comply with the following requirements:

- (1) the association shall be established as a juristic person with the main objects of promoting the architectural profession and the professional interests of its members.
- (2) The association must be governed by a formally accepted constitution which –
 - a. is not in conflict with the Constitution of the Republic of South Africa;
 - b. is not in conflict with the Act or any policies and rules of the Council; and
 - c. does not obligate its members to adhere to a code of conduct, which is in conflict with the Council's current Code of Professional Conduct, or any applicable code of practice published by the Council;
 - d. provides for its management structure, nomination procedure and requirements with which members nominated for office shall comply;
 - e. defines its powers in general and for the enrolments of members, termination of membership and associated matters;

- f. defines its requirements for membership in different classes/categories and rules for cancellation and reinstatements thereof;
 - g. defines the voting rights of the categories of membership;
 - h. defines a system of disciplinary procedures which includes appropriate sanctions when the code is contravened.
- (3) The association must be of South African origin and its governing body must be independent of direct influence by any foreign body.
- (4) The association must adhere strictly to its constitution, and be able to satisfy the Council of such adherence.
- (5) Transformation is driven through the B-BBEE Act, 2003 (No. 53 of 2003) and its subsequent amendments – Codes of Good practice. Each Voluntary Association should develop its own transformation agenda and priorities, but consider a shared vision with that of the Council, developing strategies and creating a conducive environment that supports transformational change.
- (6) an Association wishing to be recognised as a Voluntary Association must also comply with the following requirements:
- a. The Voluntary Association must have as one of its core missions, the promotion of the interests of its members and the architectural profession;
 - b. The Voluntary Association must have at least 100 voting members, who are in good standing;
 - c. All elected office bearers of the Voluntary Association shall be registered with the Council or any other statutory body within the built environment where, the Voluntary Association is a multi-disciplinary association of the architectural profession;
 - d. The majority of at least 75% of the members of the Voluntary Association shall be registered with the Council in terms of Section 19 of the Act, or any other statutory body within the built environment where the Voluntary Association is multi-disciplinary association of the architectural profession within the built environment.

4. APPLICATION FOR RECOGNITION

- (1) Any Voluntary Association wishing to be recognised as a Voluntary Association by SACAP, must submit an application to the Council in the prescribed format as determine by Council in terms of section 14 (d) of the Act.

5. RECOGNITION AS A VOLUNTARY ASSOCIATION AND DURATION OF RECOGNITION

- (1) If, after consideration of an application, the Council is satisfied that the Voluntary Association meets the relevant requirements for recognition as determined in terms of section 14 (d), the Council may recognise that association and issue a certificate of recognition in terms of section 25(3) of the Act.
- (2) A certificate of recognition is valid for a period of five years from the date of issue, which date is deemed to be the date on which the Council resolves to recognise the Voluntary Association.
- (3) A Voluntary Association must display its certificate of recognition in a prominent place at its head office and may display the prescribe Council logo on its stationery, as an indication of its recognition status
- (4) The Council must, within 30 days from the date on which it recognises a Voluntary Association, publish the name of such Voluntary Association in the Government Gazette and on its website, and thereafter make it known in such other manner as it may deem appropriate.
- (5) Recognised Voluntary Associations must enter into a Memorandum of Understanding with the Council,

- (6) Recognised Voluntary Associations must submit reports as defined by the Council,
 - a. reporting shall include Annual Reports of the Voluntary Association to be submitted to Council by 28 February of every year;
 - b. reporting and statistical data on CPD category one (1) activities with regards to validation procedures, validations completed, activities, certification and records of attendance submitted quarterly;
 - c. annual submission of paid-up membership list by no later than 28 February of the year;
 - d. transformation strategies and statistics;
 - e. other reporting that Council may request from time to time.

Existing and recognised Voluntary Association that were recognised in terms of the previous board notice and/or condition as set out by the Council maintain their current status for the remaining duration of their recognition. However, the latter will be required to meet criteria of new board notice or such condition as determined by the Council on re-application.

6. RENEWAL AND LAPSING OF RECOGNITION

- (1) The recognition of a Voluntary Association remains in effect for as long as it meets the requirements for recognition in terms of these rules.
- (2) The recognition of a Voluntary Association lapses in terms of section 25(6)(a) and (b) of the Act;
 - a. if the association no longer complies with the requirements contemplated in section 14 (d) ; or
 - b. at the expiry of the five-year period referred to in subsection (4).
- (3) A Voluntary Association must at least three months prior to the expiry of its recognition, apply in the prescribed manner to the Council for the renewal thereof.
- (4) A Voluntary Association must advise Council of any changes to its constitution and/or by-laws, within 30 days of the date on which the changes were approved.
- (5) If at any time during the period of five years referred to in section 25 (4), a Voluntary Association becomes aware that it no longer complies with the requirements, it must notify the Council forthwith in writing of such fact and provide the reasons for it.
- (6) If the Council is satisfied that a Voluntary Association has ceased to comply with the requirements as specified in section 25, the recognition of such Voluntary Association will lapse in terms of section 25(6)(a) of the Act, on the date on which the Council resolves that the Voluntary Association ceased to comply.
- (7) A Voluntary Association that has not submitted annual reports to **Council** by 28 February in line with the Council's reporting processes will be considered as having ceased to comply with the requirements and may lose its recognition.

7. AMENDMENT OF THE REQUIREMENTS FOR RECOGNITION

- (1) If the Council at any stage decides to amend the requirements for recognition, the Council may, by notice in the Gazette and in terms of Section 36 of the Act
 - (a) Inform all Voluntary Associations of this decision and provide them with the proposed amendments;
 - (b) A formal call for comment will be made by the Council whereby the proposal with amendments will be published for comments from the public and interested parties through the Government Gazette for consideration of such comment before the final Board Notice is gazetted for implementation.
- (2) If an amendment of the requirements so prescribed results in a Voluntary Association ceasing to comply with the requirements, that Voluntary Association must, within 3 months from the date on which the amended requirements have been prescribed, take

the necessary steps to comply with the amended requirements, and provide the Council with proof that it does comply.

- (3) The Council may, at its discretion, extend the period of 3 months by an additional period not exceeding 6 months, if the Council is satisfied that the Voluntary Association in question has taken definite steps to comply with the requirements, but has nevertheless not succeeded in the time allowed.
- (4) If a Voluntary Association fails or refuses to comply with any of the amended requirements within the period allowed, its recognition as a Voluntary Association lapses on the day when the Council resolves that the Voluntary Association ceased to comply with the requirements.

8. RETURN OF RECOGNITION CERTIFICATE

- (1) A Voluntary Association whose recognition has lapsed must, within 30 days from the date on which it is so directed in writing by the Council, return its certificate of recognition in accordance with Section 25 (8) of the Act

9. RIGHTS AND OBLIGATIONS OF COUNCIL AND VOLUNTARY ASSOCIATIONS

- (1) The Council is obliged to consult with the Voluntary Association in terms of the following sections of the Act:
 - Section 3 (1) (a) (i) and Section 4 (1) - Nominating persons as members of Council
 - Section 13 (d) - Determining Competency Standards
 - Section 13 (k) - Determining Continuing Professional Development (CPD) requirements
 - Section 26 (1)(a) - Identification of work
 - Section 27 (1) - Drafting of Code of Professional Conduct
 - Section 34 (1) & (2) – Determining of Professional Fees
- (2) The Council undertakes to -
 - a. Consider persons nominated by a Voluntary Association for purposes of appointment as members of its committees: Provided that this provision may not be construed as precluding Council from engaging in constructive cooperation with any other association, institute, society or interested group in sourcing suitable persons;
 - b. Promote a greater awareness among registered persons of the advantages of membership of a Voluntary Association.

10. REPEAL OF PREVIOUS RULES

- (1) The published rules under Board Notice 153 of 2009 are hereby repealed.
