

### NOTICE 944 OF 2012

#### NATIONAL AGRICULTURAL MARKETING COUNCIL

#### REQUEST TO AMEND THE STATUTORY MEASURE REGARDING RECORDS AND RETURNS BY MILK PRODUCERS

---

It is hereby made known in terms of section 11 of the Marketing of Agricultural Products Act, 1996 (Act No.47 of 1996) (MAP Act), that the Minister of Agriculture, Forestry and Fisheries has received a request from the milk industry for the amendment of the statutory measure (records and returns).

The Milk Producers' Organisation (MPO), on behalf of directly affected groups in the milk industry applied for the amendment. The current statutory measure (records & returns) in the milk industry will lapse on 1 November 2015. The MPO is the administrator of the existing statutory measure.

According to the applicant (MPO), in some cases, dairy products are being imported at abnormally low prices as a result of, among others, government assistance, fraudulent activities and sub-standard content. This has a significant negative impact on the South African dairy industry as a whole since the industry cannot compete against these imports on a price basis. This creates a cycle of downward pressure on the price paid to producers which in turn leads to a loss in job opportunities and investment in the industry. Furthermore, imports of this nature increase the entry barriers for potential developing/small milk producers and further have a negative impact on the sustainability of existing developing/small milk producers, commercial milk producers and processors of dairy products. The low priced imports cause injury to and disrupt the entire dairy industry by the price suppressing effect it has on the entire dairy value chain.

In terms of the proposed amendment, the MPO shall have, if approved by the Minister, the authority to verify the correctness of import and export statistics through access to all ports of entry into the Republic of South Africa to the following –

- (a) All relevant documentation with regard to imported milk and dairy products;
- (b) All relevant documentation with regard to exported milk and dairy products;

- (c) Inspection of imported milk and dairy products; and
- (d) Inspection of exported milk and dairy products.

A record system that reflects good accounting practise shall be introduced and kept by the MPO.

The National Agricultural Marketing Council (NAMC) took cognisance that the proposed amendment of the statutory measure relating to records and returns as requested by the MPO, is consistent with the objectives of the MAP Act. ## SCHEDULE

### *Part 1: Definitions*

#### 1. Definitions

In this Notice a word or expression to which a meaning has been assigned in the Act has that meaning and, unless the context otherwise indicates-

**'act'** means the National Environmental Management: Air Quality Act 2004 (Act No.39 of 2004).

**'authorized person'** means any person authorized by municipal council to implement this Notice.

**'biomass'** means non-fossilized and biodegradable organic material originating from plants, animals and micro-organisms excluding-(a) sewage; and (b) treated or coated wood waste which may contain halogenated organic compounds or heavy metals.

**'black smoke'** should be interpreted / understood to refer to smoke as dark or darker than Shade 4 of the Ringelmann chart, which refers to an equivalent of 80% black (refer Schedule B).

**'boiler'** means a combustion appliance designed to heat water.

**'dark smoke'** should be interpreted / understood to refer to smoke as dark or darker than Shade 2 of the Ringelmann chart, which refers to an equivalent of 40% black (refer Schedule B).

**'existing small boiler'** shall mean any small boiler that was manufactured before the date on which this Notice takes effect.

**'new small boiler'** shall mean any small boiler manufactured after the date on which this Notice takes effect.

**'operator'** means a person who owns, manages, or controls a small boiler.

**'small boiler'** means any boiler with a design capacity equal to 10MW but less than 50MW net heat input, capable of burning biomass, solid, liquid and/or gaseous fuels or a combination thereof, with:

$$\text{NHI} = M_f \times \text{NCV} / (3.6 \times 10^6)$$

Where,  
 NHI refers to the Net Heat Input expressed in MW;  
 $M_f$  refers to the Mass flow rate of the fuel expressed in kg/hour;  
 NCV refers to the Net Calorific Value of the fuel expressed in kJ/kg;

With:

$$\text{NCV} = \text{GCV} - 2442 \times (\text{H}_2\text{O in fuel} + 9 \times \text{H}_2 \text{ in fuel})$$

Where, GCV refers to the Gross Calorific Value expressed in kJ/kg (Air dried basis for solid fuels);

H<sub>2</sub>O in fuel refers to the Total moisture in the fuel, expressed as a Mass fraction (As fired condition);

H<sub>2</sub> in fuel refers to the Total hydrogen in the fuel including hydrocarbons, expressed as a Mass fraction (Obtained from the ultimate analysis of the fuel);

'soot blowing' refers to a method of cleaning deposited carbon from the internal surfaces of a boiler, which usually includes the use of a jet of air or steam onto heat exchange surfaces to clean deposits. Soot blowing is conducted on a regular schedule during each day.

### Part 2: General

#### 2. Application

This Notice shall apply to any small boiler under normal operating conditions subject to the provisions for start-up, soot-blowing and incidences of abnormal conditions.

#### 3. Permitted black and dark smoke emissions and associated timeframes:

(1) During small boiler start-up, black smoke shall be limited to a period of twenty (20) minutes.

(2) During soot blowing of a small boiler and abnormal conditions, dark smoke shall be limited to the following periods:

Number of small boilers per shared stack	Permitted emissions of dark smoke in any period of 8 hours	
	Abnormal conditions	Soot blowing
One (1)	10 minutes	14 minutes
Two (2)	18 minutes	25 minutes
Three (3)	24 minutes	34 minutes

#### **4. Implementation**

The emission standards contained in this Notice shall be implemented by the municipalities.

#### **5. Compliance time frames**

- (1) New small boiler must comply with the new small boilers emission standards as contained in Part 3 on the date of publication of this Notice.
- (2) Existing small boiler must comply with emission standards for existing small boilers as contained in Part 3 within 5 years of the date of publication of this Notice

#### **6. Reporting requirements**

- (1) The operator of a small boiler must:—
  - (a) Submit at least one (1) emissions report per annum to the relevant authorized person per the format specified in Schedule C ;
  - (b) Submit the first emissions report to the relevant authorized person within 12 months from the date on which this Notice takes effect;
  - (c) Provide any additional emission reports and/or other necessary information as requested by an authorized person, for the implementation of this Notice;
  - (d) Record all measurement results and keep a copy of this record for at least five (5) years after obtaining the results;
  - (e) Produce the record of the measurement results for inspection if requested to do so by an authorized person.
- (2) For reporting requirements, emissions shall be measured by stack emission measurement and may be supplemented by means of either of the following methods:
  - (a) Mass balance;
  - (b) Engineering calculations;

**7. Emission measurement:**

- (1) The concentration or mass of pollutant for which emissions standards have been set in this Notice shall be reported as the average of at least three (3) measurements; measured over a minimum sample period of 60 minutes to obtain a representative sample.
- (2) The manner in which measurements shall be carried out must be in accordance with the standard sampling and analysis methods listed in Schedule A of the Notice.
- (3) Methods other than those contained in Schedule A may be used with the written consent of the National Air Quality Officer. In seeking the written consent referred, an applicant must provide the National Air Quality Officer with any information that supports the equivalence of the method other than those referred.

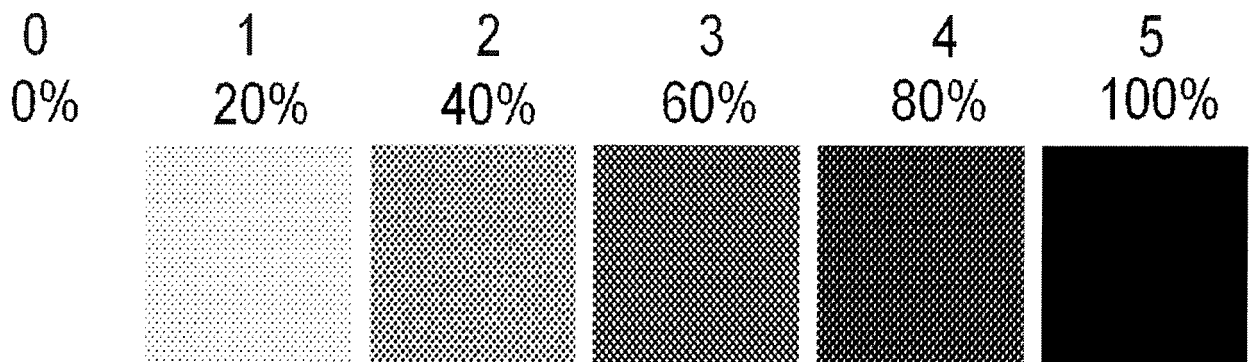

## ANNEXURE D: EXAMPLES ON CALCULATING NET HEAT INPUT AND ON CO-GENERATION

**Example:** Simultaneous combustion of Solid Biomass Fuel and Gaseous Fuel (low dust content gaseous fuel) for an Existing Small Boiler:

The first step is to calculate the NHI from each fuel based on individual firing rates (*refer Part 1: Definitions*), for the purpose of this example, it is assumed that both fuels each contribute with a NHI value of 5 MW:

Solid Biomass Fuel:  $NHI_{fuel1} = 5 \text{ MW}$

Gaseous Fuel (Low dust content):  $NHI_{fuel2} = 5 \text{ MW}$

The second step is to calculate the emission standard (ES) of each substance (pollutant) against the 3% O<sub>2</sub> reference concentration for the CES (*refer "CESref" as subscript below*) as referred above. Particulate Matter (PM) will be used for this example:

Fuel 1: The ES for PM for the solid biomass fuel: is 250 mg /Nm<sup>3</sup> dry at 6% O<sub>2</sub>

$$\begin{aligned} ES_{PM \text{ for fuel1 at } 3\%O_2} &= ES_{PM \text{ for biomass fuel}} \times (20.95 - \%O_{2\_CESref}) / (20.95 - \%O_{2\_biomass \text{ fuel}}) \\ &= 250 \times (20.95 - 3) / (20.95 - 6) \\ &= 300 \text{ mg/Nm}^3 \text{ dry at } 3\% \text{ O}_2 \end{aligned}$$

Fuel 2: The ES for PM for the gaseous fuel: is 20 mg /Nm<sup>3</sup> dry at 3% O<sub>2</sub>

$$\begin{aligned} ES_{PM \text{ for fuel2 at } 3\%O_2} &= ES_{PM \text{ for gaseous fuel}} \times (20.95 - \%O_{2\_CESref}) / (20.95 - \%O_{2\_gaseousfuel}) \\ &= 20 \times (20.95 - 3) / (20.95 - 3) \\ &= 20 \text{ mg/Nm}^3 \text{ dry at } 3\% \text{ O}_2 \end{aligned}$$

The third step is to apply the equation provided under 8(f) above:

For PM the calculated emission standard (CES) for the simultaneous combustion of the two fuels is:

$$\begin{aligned} CES_{PM} &= \frac{(NHI_{fuel1} \times ES_{PM \text{ for fuel1 at } 3\%O_2}) + (NHI_{fuel2} \times ES_{PM \text{ for fuel2 at } 3\%O_2})}{(NHI_{fuel1} + NHI_{fuel2})} \\ &= \frac{((5 \times 300) + (5 \times 20))}{(5 + 5)} \\ &= 1600 / 10 \\ &= 160 \end{aligned}$$



The calculated emission standard for PM for the simultaneous combustion of the two fuels used in this example is therefore calculated to be:

**NOTICE 955 OF 2012****INTERNATIONAL TRADE ADMINISTRATION COMMISSION****NOTICE OF AN INITIATION OF THE INVESTIGATION FOR REMEDIAL ACTION IN THE FORM OF A SAFEGUARD AGAINST THE INCREASED IMPORTS OF FROZEN POTATO CHIPS**

The International Trade Administration Commission of South Africa (the Commission) decided to proceed with an investigation for remedial action against the increased imports of frozen potato chips.

Based on the information submitted, the Commission decided that *prima facie* information was submitted to indicate that a recent, sudden, sharp and significant surge in imports has taken place and is causing serious injury to the Southern African Customs Union (SACU) industry.

**THE APPLICANT**

The application was lodged by McCain (SA) (Pty) Ltd, a major producer of frozen potato chips in the SACU supported by Nature's Choice Products (Pty) Ltd and Lamberts Bay Foods.

A non-confidential version of the application is available for inspection at the Commission's offices.

**DESCRIPTION OF THE SUBJECT PRODUCT UNDER INVESTIGATION**

The subject product is described as frozen potato chips (scientific name) or commonly known (in South Africa) as slap chips or french fries/pommes frites/chips (trade name), classifiable under tariff subheading 2004.10.90.

**DESCRIPTION OF THE LIKE OR DIRECTLY COMPETITIVE SACU PRODUCT**

The SACU product is described as frozen potato chips (scientific name) or commonly known (in South Africa) as slap chips or french fries/pommes frites/chips (trade name).

**ALLEGATION OF SERIOUS INJURY AND CAUSAL LINK**

The Applicant alleges and submitted *prima facie* information indicating that it is experiencing serious injury in the form of a decline in sales volume, output, market share, productivity and capacity utilisation. It further alleges that it is experiencing an increase in losses in light of the recent, sudden, sharp and significant surge in imports.

The Applicant further alleges that there is an oversupply of frozen potato chips in the world market, that there is a recent, sudden, sharp and significant surge in imports of frozen potato chips and that they are exported to the SACU at prices which will have a significant depressing and a further suppressing effect on the Applicant's prices.

It further alleges that the significant increase in the market share of the imported frozen potato chips in the SACU has been at the expense of a corresponding decrease in the SACU industry's market's share.

On this basis the Commission found that *prima facie* information was submitted to indicate that the SACU industry was suffering serious injury which could be causally linked to the recent, sudden, sharp and significant surge in imported frozen potato chips.

**UNFORESEEN DEVELOPMENTS**

The Applicant indicated that the expansion of capacity in the EU, the financial crisis which resulted in the oversupply of frozen potato chips in the world market and an aggressive export strategy by the EU producers of frozen chips augmented by the absence of sufficient duty protection as a result of the TDCA culminated in circumstances that occurred after the negotiation of the relevant tariff concessions

“could not have been foreseen at the time the concessions were negotiated” in accordance with Article XIX of the GATT.

### **PROCEDURAL FRAMEWORK**

This investigation will be conducted in accordance with the International Trade Administration Act, 2002 (ITA Act), the World Trade Organization Agreement on Safeguards (the Safeguard Agreement) and the International Trade Administration Commission Safeguard Regulations (SGR).

#### **NATIONAL COUNCIL OF SOCIETIES FOR THE PREVENTION OF CRUELTY TO ANIMALS**

#### **R U L E S**

##### **1 NEW RULE TO BE NUMBERED 2.13**

A Society shall inspect the premises of any new staff or committee member to ensure compliance with the Rules, Statement of Policy, Animals Protection Act and any other associated legislation, to ensure that the welfare of any animals on the premises is in no way compromised. National Inspectors will be permitted to inspect the premises of any member of staff or the Management committee in the presence of the staff or committee member concerned, to ensure that they are not in conflict with the Statement of Policy.

##### **2 AMENDMENT TO RULE 3.6**

A Society shall keep accurate, complete and legible records of every animal handled by it, or reported to it, so that such records give a full account of the circumstances under which the animal came to be handled, the activities undertaken by the Society in relation to the animal and result thereof. All such records shall be adequately referenced, kept together and shall not be distributed among different files i.e. Admittance Form, adoption/euthanase/owner claim form, application for adoption, sterilisation contract (if necessary) medical record if applicable and pre and post home checks. Such records shall be made available to the Board on request to facilitate the compilation of accurate and comprehensive records of the activities of member Societies.

##### **3 AMENDMENT TO RULE 6.8**

A Society shall not keep any animals for breeding purposes nor allow SPCA facilities to be used for breeding animals, whether intentionally or negligently.

##### **4 AMENDMENT TO RULE 6.13**

Any Society that homes any animal to areas outside their area of jurisdiction must sterilise such animals as specified in the Operations Manual before releasing them to their new owners notwithstanding the provisions of Rule 6.6.

##### **5 AMENDMENT TO RULE 6.20**

Pre and post home inspections shall be carried out physically by a trained individual for all species of animals adopted by a Society. All aspects of the possible adoption shall be inspected and recorded i.e. property, housing and feeding of animal/s, present animals and capability and knowledge of new owner to care for animal/s adequately. Furthermore animals shall not be adopted into areas where there are no animal welfare organisations and/or SPCA that are able to provide this service and are in agreement with carrying out these inspections on a regular basis. This Rule shall be in conjunction with Rules 6.10 and 6.11 respectively.

**6 AMENDMENT TO RULE 6.24**

Prior to homing an animal, including owner claimed or stray, the Society shall ensure that it is micro-chipped. In the event that the Society is unable to do so for financial reasons or reasons that are not practicable then the humane alternative methods of identification should be adopted. In the case of a dog or cat that cannot be micro-chipped, it must be fitted with a suitable collar and identity disc prior to it leaving the SPCA.

**7 NEW GUIDELINE TO BE NUMBERED 13**

All new Committee members, as well as those seeking re-election, and new members of staff of SPCAs must not have a criminal record where the conviction in question relates to misconduct in regards to animals and further may not take up employment, be employed or serve on the committee of any SPCA in a position where a criminal record and a conviction relates to the type of work they will be engaged in.
