NOMINATIONS OF MEMBERS OF THE NATIONAL HEALTH LABORATORY SERVICE BOARD

NOTICE OF NOMINATION

- 1) Notice is hereby given for all interested persons to nominate candidates to be considered for appointment by the Minister of Health to the National Health Laboratory Service Board (NHLS) in terms of Sections 9(1) and 8(2) of the National Health Laboratory Service, 2000 (Act No. 37 of 2000) ("the Act") for a three (3) year term of office of whom:
 - a) One shall be the Chairperson;
 - b) One shall be the vice-chairperson; and
 - c) Three members of the public of who will be appointed on account of his/her knowledge in -
 - i. Economics, financial matters of accounting
 - ii. Legal matters
 - iii. Health research; or
 - iv. Epidemiology.
- 2) The objects of (NHLS) as well as the functions, powers and duties of the service are provided in terms of the Act.
- 3) A person nominated shall not be appointed as a member of the Board if that person (a) is not a South African citizen and ordinarily resident in the Republic; (b) is an unrehabilitated insolvent; (c) has at any time been convicted of an offence involving dishonesty, whether in the Republic or elsewhere, and sentenced to imprisonment without the option of a fine; or (d) had been removed from an office of trust.
- 4) Nominations must be submitted in the form of motivation, including comprehensive curriculum vitae (CV) and a signed letter of acceptance of the nomination from the candidate not later than **16h30 on 07 December 2012**.
- 5) Every nomination in respect of which any of the requirements as stipulated above has not been complied with, or which is not received by the aforesaid date and time will be considered invalid.
- 6) All nominations must be directed to the Director-General: Health (for the attention of the Director: Public Entities Governance and Management) and -
 - a) be deposited at the Department of Health, Room 0811 South Tower, Civitas Building, Cnr Thabo Sehume and Struben Streets, Pretoria or
