SMALL CLAIMS COURTS ACT, 1984 (ACT NO. 61 OF 1984)

ESTABLISHMENT OF SMALL CLAIMS COURTS FOR THE AREAS OF ERMELO AND CAROLINA AND WITHDRAWAL OF GOVERNMENT NOTICE NO. 275 OF 24 FEBRUARY 1989

I, Andries Carl Nel, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (a) (i) establish a Small Claims Court for the adjudication of claims for the area of Ermelo, consisting of the district of Ermelo;
- (ii) determine Ermelo to be the seat of the said Court; and
- (iii) determine Ermelo to be the place in that area for the holding of sessions of the said Court.
- (b) (i) establish a Small Claims Court for the adjudication of claims for the area of Carolina, consisting of the district of Carolina;
- (ii) determine Carolina to be the seat of the said Court; and
- (iii) determine Carolina to be the place in that area for the holding of sessions of the said Court.
- (c) withdraw Government Notice No. 275 of 24 February 1989.

Despite the withdrawal of Government Notice No. 275 of 24 February 1989, any claim emanating from the district of Carolina which has already been instituted in the Small Claims Court of Ermelo prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Ermelo as if this Government Notice has not been published.

SCHEDULE

1. Definitions

In these regulations any word or expression to which a meaning has been assigned in the Act has that meaning, and unless the context indicates otherwise-

“ASTM D1739” means the American Standard for Testing and Materials method D1739, which is the standard test method for the collection and measurement of dust fall;

“dust fall” means the deposition of dust;

“dust fallout monitoring programme” means monitoring of the dust fallout on a continuous basis.

“industrial area” means any area classified for industrial use as per the local town planning scheme;

“Non- residential area” means any area not classified for residential use as per local town planning scheme;

“premises” means-

- (a) any adjoining land occupied or used in connection with any activities carried on in that building or structure;
- (b) any building or other structure;
- (c) any locomotive, ship, boat or other vessel which operates in the precincts of any harbor, within the area of the jurisdiction of the Republic of South Africa.
- (d) any vacant land; or

“residential area” means any area classified for residential use in terms of the local town planning scheme;

“settleable particulate matter (or dust)” means any material composed of particles small enough to pass through a 1 mm screen and large enough to settle by virtue of their weight into the container from the ambient air.

2. Purpose of the regulations

The purpose of the regulations is to prescribe general measures for the control of dust (settleable particulate matter) in all areas.

3. Dust fallout standard

Table 1: Acceptable dust fall rates as measured (using ASTM D1739:1970 or equivalent) at and beyond the boundary of the premises where dust originates.

Restriction Areas	Dust fall rate (mg/m ² /day, 30-days average)	Permitted frequency of exceeding dust fall rate
Residential area	$D < 600$	Two within a year, not sequential months.
Non-residential area	$600 < D < 1200$	Two within a year, not sequential months.

4. Baseline establishment

- (1) Any person who conducts any activity in such a way as to give rise to dust in quantities and concentrations that may exceed the dust fall standard set out in regulation 3 of these Regulations must, within a year after publication of these Regulations, submit a dust monitoring report to the air quality officer.
- (2) A dust fallout monitoring report, contemplated in subregulation (1), must provide-
 - (a) Information on the location of samples, including coordinate reference on a topographic map and the proximity of the samples to residential and non-residential areas;
 - (b) classification of the area where samples were taken from;
 - (c) meteorological data of the sampling area;
 - (d) any other relevant data that might influence the results; and
 - (e) the dust fallout monitoring results.

5. Measures for the control of dust

- (1) Any person who has exceeded the dust fall standard set out in regulation 3 of these Regulations must, within three months after submission of the dust monitoring report, develop a dust management plan.
- (2) A dust management plan, contemplated in subregulation (1), must-
 - (a) identify all possible sources of dust within the affected areas; and
 - (b) detail best practicable measures to be undertaken to control dust.

6. Dust fallout monitoring

- (1) An air quality officer may require any person to undertake a dust fallout monitoring programme contemplated in subregulation (2) if-
 - (a) the air quality officer suspects that the person is contravening regulation 3 of these Regulations; or
 - (b) the activity being conducted by the person requires a fugitive emission management plan in terms of a notice published in terms of section 21 of the Act.
- (2) A dust fallout monitoring programme must include-
 - (a) the implementation of the best practicable measures to control dust
 - (b) compliance or non-compliance report with regulation 3 of these Regulations to the satisfaction of the air quality officer.

7. Ambient air quality monitoring for PM₁₀

An air quality officer may require any person to undertake continuous ambient air quality monitoring for PM₁₀ in accordance with a notice published in terms of section 9 of the Act, if the dust fallout monitoring programme contemplated in regulation 6(2) indicates non-compliance with regulation 3 of these Regulations.

8. Offences

A person is guilty of an offence if that person contravenes a provision of regulation 4, 5, 6 or 7 of these Regulations.

9. Penalties

A person convicted of an offence referred to in regulation 8 of these Regulations is liable to –

- (1) imprisonment for a period not exceeding five years;
- (2) an appropriate fine; or
- (3) both a fine and imprisonment.

10. Short title and commencement

These regulations are called the National Dust Control Regulations, 2012 and shall come into operation on a date determined by the Minister by notice in the *Gazette*.

The CMS lays out medium to long term strategic action programmes to achieve water use that is sustainable, equitable and efficient. The Strategy sets out principles for allocating water to users and takes into account all matters relevant to the protection, use, development, conservation, management and control of water resources.

The CMS consists of four parts. Part A consists of the Foundation Information that provides an understanding of the type and current state of water resources in the Inkomati Catchment. It provides stakeholders with the basis for collectively deciding what the water resources should be like in the future.

The Board intends to embark on a new process to determine and publish a tariff of fees as contemplated in section 53(3)(d) of the Health Professions Act, 56 of 1974 (*“the Act”*) for medical practitioners and dentists registered in terms of the Act (*“guideline tariffs”*).

Once determined and published, the guideline tariffs will be used as a norm for the determination, upon application by a patient for such determination as contemplated in section 53(3)(a) of the Act, of amounts which in the opinion of the professional board should have been charged by the practitioner to which the application relates to professional services rendered by such practitioner to the patient concerned.

Interested persons are hereby afforded an opportunity to submit substantiated comments or representations in writing on the issues that the Board should consider in the compilation of guideline tariffs as envisaged in the Act including but not limited to:


- a. The process and methods that the Board and its Tariff Committee (*"its Committee"*) should follow to determine the guideline tariffs referred to above;
- b. The appropriateness of using the 2006 National Health Reference Price List (*"the NHRPL"*) determined by the Council for Medical Schemes as a basis for the guideline tariffs and, if not appropriate, a proposal regarding an appropriate basis that the Board and its Committee should use for the determination of the guideline tariffs;
- c. If the NHRPL is used as the basis for the guideline tariffs, the appropriateness of using inflators such as the Consumer Price Index to counteract the effects of inflation in relation to the prices indicated in the NHRPL;
- d. If the NHRPL is used as the basis for the guideline tariffs, how to deal with the inclusion of codes for new procedures conducted by practitioners but not included in the NHRPL, the unbundling of certain codes and the excision of codes for obsolete procedures included in the NHRPL;
- e. The process and methods to be used by the Board and its Committee to determine practice costs and prices taking into account what patients can afford and a fair and reasonable fee for services rendered; and
- f. Any other relevant considerations relating to both the procedure that the Board should follow and the substantive factors that the Board should take into account in formulating the guideline tariff.
