AMENDMENT OF NATIONAL ROAD N17 SECTION 5 AS A TOLL ROAD

By virtue of Section 27(1)(a)(ii) of The South African National Roads Agency Limited and the National Roads Act, 1998 (Act No. 7 of 1998), I hereby amend Declaration No. 896 of 2006 by de-declaring the section of road from Oos Street east of Ermelo up to the entrance of the operational area of the Oshoek Border Post as declared in terms of Government Gazette No. 29200 of 8 September 2006, as a Toll Road. The declaration of the existing National Road N17 sections 2, 3 and 4 as a Toll Road is not amended or withdrawn and remains of full force and effect.
