
ELECTRONIC COMMUNICATIONS ACT, 2005 (ACT NO. 36 OF 2005)

APPLICATION FOR AUTHORISATION OF CHANNELS BY ON-DIGITAL MEDIA (PTY) LTD

1. The Independent Communications Authority of South Africa ("the Authority") hereby gives notice that it has received an application from On-Digital Media (Pty) Ltd ("ODM"), for the authorisation of three video channels lodged in terms of regulation 3 of the Subscription Broadcasting Services Regulations of 2006.
2. The application, relevant schedule and any representations received pursuant thereto will be made available and be open for inspection by interested parties in the Authority's library during the Authority's normal office hours.
3. Interested parties are invited to lodge written representations in relation to the application within twenty one days (21) working days of the date of publication of this notice.
4. ODM shall be entitled to respond in writing to written representations made by interested persons on the application for authorisation of channels, and such written response must be lodged with the Authority within fourteen (14) working days of the closing date for the representations. ODM must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, or has sent a copy of such response by registered mail or by facsimile to the relevant person having made such written representations.
