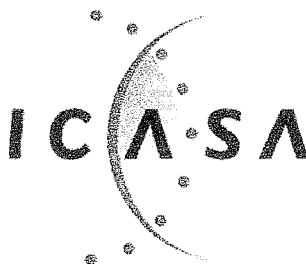



All written representations submitted to the Authority pursuant to this notice shall be made available for inspection by interested persons from the 25<sup>th</sup> of February 2013 at the ICASA Library or website and copies of such representations and documents will be obtainable on the payment of a fee.

Where persons making representations require that their representation or part thereof be treated as confidential, then an application in terms of section 4D of the ICASA Act, 2000 (Act No. 13 of 2000) must be lodged with the Authority. Such an application must be submitted simultaneously with the representation on the draft regulations and plan. All confidential material must be pasted onto a separate annexure which is clearly marked "Confidential". If, however, the request for confidentiality is not accepted by the Authority, the person making the request will be allowed to withdraw the representation or document in question.
