#### AMENDMENT OF PUBLIC SERVICE REGULATIONS, 2001

The Minister for the Public Service and Administration has, under section 41 of the Public Service Act, 1994 (promulgated under Proclamation No. 103 of 1994) and with effect from 1 March 2013, amended Part VII of Chapter 1 of the Public Service Regulations, 2001 (published under Government Notice No. R. 1 of 5 January 2001), as amended, by the substitution for subregulations D.2 (a) and (d) of the following subregulations:

- “(a) the head of a national department, shall be chaired by the Minister responsible for the portfolio in which the vacancy exists and include at least two other Ministers and a national head of department;
- (d) a Deputy Director-General of a national department, shall be chaired by the Minister responsible for the portfolio in which the vacancy exists and include at least two Deputy Ministers and the relevant head of department;”


