#### PRIVATE SECURITY INDUSTRY REGULATION ACT, 2001 (ACT NO. 56 OF 2001): EXEMPTION IN TERMS OF SECTIONS 1(2) AND 20(5) OF THE ACT

By virtue of the powers vested in the Minister of Police by sections 1(2) and 20(5) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), I, Emmanuel Nkosinathi Mthethwa, hereby determine that Mafanato Sara Nkuna (ID No. 381116 0186 083) is exempted from the provisions of sections 20(1) and 20(2) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), for a period of five years from date hereof, on condition that -

- she may not directly or indirectly participate or influence the decisions relating to the day-to-day security services provided by Nkuna Security Services Professional Private Investigators CC;
- she may not function as a security service provider; and
- she remains in a member of Nkuna Security Services Professional Investigators CC in the same position as indicated in her application.
