DEPARTMENT OF TRADE AND INDUSTRY

CONSUMER PROTECTION ACT, 2008

CATEGORIES OF GOODS THAT ARE REQUIRED TO HAVE A TRADE DESCRIPTION APPLIED TO THEM IN TERMS OF THE CONSUMER PROTECTION ACT, 2008 (ACT NO. 68 OF 2008)

I, Dr Rob Davies, Minister of Trade and Industry, intend to issue a notice in terms of Section 24(4)(a) and (c) of the Consumer Protection Act, 2008 (Act No. 68 of 2008) (the Act), prescribing certain categories of goods that are required to have a trade description applied to them and prescribing information that is required to be included in such trade description from among the categories of information contemplated in the definition of a "trade description" in section 1 of the Act, as set out in the attached schedule.

Interested persons may submit written comments on the proposed notice not later than sixty (60) days from date publication of this notice to:


