I, Andries Carl Nel, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (a) establish a Small Claims Court for the adjudication of claims for the area of Msinga, consisting of the district of Msinga;
- (b) determine Msinga to be the seat of the said Court; and
- (c) determine Msinga to be the place in that area for the holding of sessions of the said Court.

ESTABLISHMENT OF SMALL CLAIMS COURTS FOR THE AREAS OF VRYHEID AND NGOTSHE AND WITHDRAWAL OF GOVERNMENT NOTICES NO. 1962 OF 11 SEPTEMBER 1987 AND NO. 1755 OF 2 AUGUST 1991

I, Andries Carl Nel, Deputy Minister of Justice and Constitutional Development, acting under the powers delegated to me by the Minister of Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (a) (i) establish a Small Claims Court for the adjudication of claims for the area of Vryheid, consisting of the district of Vryheid;
- (ii) determine Vryheid to be the seat of the said Court; and
- (iii) determine Vryheid to be the place in that area for the holding of sessions of the said Court.
- (b) (i) establish a Small Claims Court for the adjudication of claims for the area of Ngotshe, consisting of the district of Ngotshe;
- (ii) determine Louwsburg to be the seat of the said Court; and
- (iii) determine Louwsburg to be the place in that area for the holding of sessions of the said Court.
- (c) withdraw Government Notices No. 1962 of 11 September 1987 and No. 1755 of 2 August 1991.

Despite the withdrawal of Government Notices No. 1962 of 11 September 1987 and No. 1755 of 2 August 1991, any claim emanating from the district of Ngotshe which has already been instituted in the Small Claims Court of Vryheid prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Vryheid as if this Government Notice has not been published.



- (c) determine Elliot to be the place in that area for the holding of sessions of the said Court.

ALTERATION OF THE AREA FOR WHICH THE SMALL CLAIMS COURT FOR RUSTENBURG WAS ESTABLISHED AS PUBLISHED IN GOVERNMENT NOTICE NO. 2096 OF 20 SEPTEMBER 1985, AS AMENDED BY GOVERNMENT NOTICE NO. 1743 OF 26 JUNE 1992, AS AMENDED BY GOVERNMENT NOTICE NO. 324 OF 19 MARCH 2004, AS AMENDED BY GOVERNMENT NOTICE NO. 528 OF 13 JULY 2012: ESTABLISHMENT OF A SMALL CLAIMS COURT FOR THE AREA OF MADIKWE

I, Andries Carl Nel, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (i) (a) alter the area for which the Small Claims Court of Rustenburg was established by excising therefrom the district of Madikwe;
- (b) amend Government Notice No. 2096 of 20 September 1985 to reflect that the area of the Small Claims Court of Rustenburg consists of the district of Rustenburg; and
- (c) determine Rustenburg to be the place in that area for the holding of sessions of the said Court.
- (ii) (a) establish a Small Claims Court for the adjudication of claims for the area of Madikwe, consisting of the district of Madikwe;
- (b) determine Madikwe to be the seat of the said Court; and
- (c) determine Madikwe to be the place in that area for the holding of sessions of the said Court.

Despite the amendment to Government Notice No. 2096 of 20 September 1985, any claim emanating from the district of Madikwe which has already been instituted in the Small Claims Court of Rustenburg prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Rustenburg as if this Government Notice has not been published.
