**DETERMINATION OF A DATE IN TERMS OF PARAGRAPH 9(2) OF THE FOURTH SCHEDULE TO THE INCOME TAX ACT, 1962 (ACT NO. 58 OF 1962), UPON WHICH THE NEW EMPLOYEES' TAX DEDUCTION TABLES AS PRESCRIBED IN TERMS OF PARAGRAPH 9(1) OF THE FOURTH SCHEDULE TO THE INCOME TAX ACT, 1962 (ACT NO. 58 OF 1962) CAME INTO OPERATION**

1. In terms of paragraph 9(2) of the Fourth Schedule to the Income Tax Act, 1962 (Act No. 58 of 1962) it is hereby announced that new deduction tables as prescribed in terms of paragraph 9(1) of the Fourth Schedule, came into operation on 1 March 2013.
2. All previous deduction tables prescribed in terms of paragraph 9(1) of the Fourth Schedule are hereby withdrawn with effect from 1 March 2013.
3. The new deduction tables are known as the Weekly, Fortnightly, Monthly and Annual Tax Deduction Tables with an effective date 2013.03.01 and shall remain in operation until further notice.
4. The Weekly, Fortnightly, Monthly and Annual Tax Deduction Tables with an effective date 2013.03.01, is available on SARS's website ([www.sars.gov.za](http://www.sars.gov.za)).
5. A notice in this regard was issued on 1 March 2013 to users of the Statutory Tax Rates.
