Covering a total area of 30,111 ha, the property includes a main core component of 30,108 ha, and three smaller (each 1 ha in size) component sites - two to the west, and one to the south east of the core area. The southern boundary of the core component area lies about 6 km to the north of the town of Vredefort, and the northern boundary is about 26 km to the north of the town. The eastern boundary is found 5 km from the town of Parys, with its western boundary located some 19 km from the town.

The core of the Vredefort Dome is situated between 26° 59' and 26° 45' Southern Latitude, and between 27° 11' and 27° 26' Eastern Longitude.
