BOARD NOTICE 81 OF 2013 FINANCIAL SERVICES BOARD

FINANCIAL ADVISORY AND INTERMEDIARY SERVICES ACT, 2002 (ACT NO. 37 OF 2002)

EXEMPTION OF TSHIRELETSO FINANCIAL SERVICES (PTY) LTD (FSP NO. 40422)

I, German Emmanuel Anderson, Deputy Registrar of Financial Services Providers, hereby exempt under section 44(4) of the Financial Advisory and Intermediary Services Act, 2002 (Act No. 37 of 2002), Tshireletso Financial Services (Pty) Ltd to the extent set out in the Schedule.

SCHEDULE

EXEMPTION OF TSHIRELETSO FINANCIAL SERVICES (PTY) LTD (FSP NO. 40422)

Definitions

1. In this Schedule, "the Act" means the Financial Advisory and Intermediary Services Act, 2002 (Act No. 37 of 2002), any word or expression to which a meaning is assigned in the Act shall have that meaning, and unless the context otherwise indicates-

"Section 19(3) Auditor's Report", means the report referred to in section 19(3) of the Act and published by Board Notice 85 of 2008 in Government Gazette No. 31384 of 3 September 2008;

"Tshireletso Financial Services", means Tshireletso Financial Services (Pty) Ltd.

Extent of exemption

2. Tshireletso Financial Services is exempted from having to submit the Section 19(3) Auditor's Report for the years 2010 and 2011.

Amendment and withdrawal of exemption

3. The exemption mentioned in paragraph 2 are subject to-
 - (a) amendment thereof published by the Registrar by notice in the *Gazette*; and
 - (b) withdrawal in like manner.

Short title and commencement

4. This Exemption is called the Exemption of Tshireletso Financial Services (Pty) Ltd, 2013, and comes into operation on the date of publication in the *Gazette*.
