FOODSTUFFS, COSMETICS AND DISINFECTANTS ACT, 1972 (ACT 54 OF 1972)

REGULATIONS GOVERNING IRRADIATED FOODSTUFFS: AMENDMENT

The Minister of Health has, in terms of section 15 (1) of the Foodstuffs, Cosmetics and Disinfectants Act, 1972 (Act No. 54 of 1972) made the regulations in the Schedule.

SCHEDULE

1. In these regulations “**the Regulations**” means the regulations published under Government Notice No. R. 1600 of 22 July 1983.

Amendment of Regulation 2

2. Regulation 2 is hereby amended by inserting the following sub-paragraph:

(b) Approvals referred to in sub-regulation 2(a), shall be in line with the *Guidelines for Monitoring Irradiated Foodstuffs in South Africa*, which is available from the Directorate: Food Control, or on the website of the Department of Health at: www.doh.gov.za.


BYLAE
