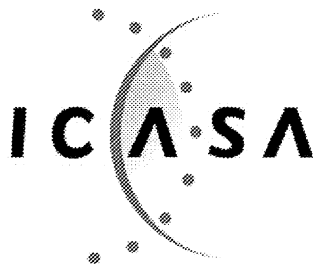

EXTENSION OF THE CLOSING DATE FOR SUBMISSIONS OF COMMENTS REGARDING THE DRAFT LABELLING REGULATIONS

1. The Independent Communications Authority of South Africa ("the Authority"), hereby gives notice of the extension regarding the closing date for the submission of comments on the draft labelling regulations published in Government Gazette No. 36380 (Notice No. 393) dated 16th April 2013.
2. The closing date for the submission of written representations by interested persons on the Draft Labelling regulations is hereby extended from Friday, 10 May 2013 to **Friday, 17 June 2013 at 16h00**.

Copies of the representations from the library will be obtainable upon payment of a fee.

Where persons require that their representation or part thereof be treated as confidential, an application in terms of section 4(d) of the ICASA Act, 2000 (Act No. 13 of 2000) must be lodged with the Authority. Such an application must be submitted simultaneously with the representations. All confidential material must be placed in a separate annexure which must be clearly marked "Confidential". If, however, the request for confidentiality is not accepted by the Authority, the person making the request will be allowed to withdraw the representations.
