**DEPARTMENT OF JUSTICE AND CONSTITUTIONAL DEVELOPMENT****No. 403****7 June 2013****SMALL CLAIMS COURTS ACT, 1984 (ACT NO. 61 OF 1984)****ALTERATION OF THE AREA FOR WHICH THE SMALL CLAIMS COURT FOR PIETERMARITZBURG WAS ESTABLISHED AS PUBLISHED IN GOVERNMENT NOTICE NO. 2096 OF 20 SEPTEMBER 1985, AS AMENDED BY GOVERNMENT NOTICE NO. 1743 OF 26 JUNE 1992, AS AMENDED BY GOVERNMENT NOTICE NO. 324 OF 19 MARCH 2004, AS AMENDED BY GOVERNMENT NOTICE NO. 528 OF 13 JULY 2012: ESTABLISHMENT OF A SMALL CLAIMS COURT FOR THE AREA OF CAMPERDOWN**

I, Andries Carl Nel, Deputy Minister of Justice and Constitutional Development, acting under the power delegated to me by the Minister of Justice and Constitutional Development, under section 2 of the Small Claims Courts Act, 1984 (Act No. 61 of 1984), hereby -

- (i)
  - (a) alter the area for which the Small Claims Court of Pietermaritzburg was established by excising therefrom the district of Camperdown;
  - (b) amend Government Notice No. 2096 of 20 September 1985 to reflect that the area of the Small Claims Court of Pietermaritzburg consists of the districts of Pietermaritzburg and Lions River; and
  - (c) determine Pietermaritzburg to be the place in that area for the holding of sessions of the said Court.
- (ii)
  - (a) establish a Small Claims Court for the adjudication of claims for the area of Camperdown, consisting of the district of Camperdown;
  - (b) determine Camperdown to be the seat of the said Court; and
  - (c) determine Camperdown to be the place in that area for the holding of sessions of the said Court.

Despite the amendment to Government Notice No. 2096 of 20 September 1985, any claim emanating from the district of Camperdown which has already been instituted in the Small Claims Court of Pietermaritzburg prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Pietermaritzburg as if this Government Notice has not been published.

- (i) (a) establish a Small Claims Court for the adjudication of claims for the area of Mkobola, consisting of the district of Mkobola;
  - (b) determine Mkobola to be the seat of the said Court;
  - (c) determine Mkobola to be the place in that area for the holding of sessions of the said Court;
- (ii) (a) establish a Small Claims Court for the adjudication of claims for the area of KwaMhlanga, consisting of the district of KwaMhlanga;
  - (b) determine KwaMhlanga to be the seat of the said Court;
  - (c) determine KwaMhlanga to be the place in that area for the holding of sessions of the said Court;
- (iii) (a) establish a Small Claims Court for the adjudication of claims for the area of Mdutjana, consisting of the district of Mdutjana;
  - (b) determine Mdutjana to be the seat of the said Court;
  - (c) determine Mdutjana to be the place in that area for the holding of sessions of the said Court;
- (iv) (a) establish a Small Claims Court for the adjudication of claims for the area of Mbibana, consisting of the district of Mbibana;
  - (b) determine Mbibana to be the seat of the said Court; and
  - (c) determine Mbibana to be the place in that area for the holding of sessions of the said Court.
- (v) withdraw Government Notice No. 1162 of 15 August 2003.

Despite the withdrawal of Government Notice No. 1162 of 15 August 2003, any claim emanating from the districts of KwaMhlanga, Mbibana and Mdutjana which has already been instituted in the Small Claims Court of Mkobola prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Mkobola as if this Government Notice has not been published.



- (ii) determine Ladybrand to be the seat of the said Court; and
- (iii) determine Ladybrand to be the place in that area for the holding of sessions of the said Court.
- (b) (i) establish a Small Claims Court for the adjudication of claims for the area of Clocolan, consisting of the district of Clocolan;
- (ii) determine Clocolan to be the seat of the said Court; and
- (iii) determine Clocolan to be the place in that area for the holding of sessions of the said Court.
- (c) withdraw Government Notice No. 2860 of 29 December 1989.

Despite the withdrawal of Government Notice No. 2860 of 29 December 1989, any claim emanating from the district of Clocolan which has already been instituted in the Small Claims Court of Ladybrand prior to the publication of this Government Notice, shall be continued and concluded in the Small Claims Court of Ladybrand as if this Government Notice has not been published.
