

**Amendment of the Practice Rules of the Free State Provincial Division**

The RULES REGULATING THE CONDUCT OF THE PROCEEDINGS OF THE ORANGE FREE STATE PROVINCIAL DIVISION OF THE HIGH COURT OF SOUTH AFRICA promulgated under GN 820 in GG 30253 of 7 September 2007 are hereby amended as follows:

1. **Replace Rule 7.4 with the following:**

7.4 All applications must be indexed, paginated and bound at the time of set-down.

2. **Replace Rule 9.4.1 with the following:**

9.4.1 All applications for provisional sequestration and voluntary surrender will be approached by this Court on the basis that the costs of sequestration and administration will amount to R30 000. (This amount may be adjusted from time to time.)

3. **Replace Rule 13.3 with the following:**

**13.3 Opposed Motions**

Set-down and Heads of Argument:

13.3.1. Opposed motions must be enrolled before 12h00 on the second Friday of the week preceding the date of hearing.

13.3.2. The applicant's heads of argument shall be filed before 12h00 on the Wednesday of the week immediately preceding the date of hearing.

13.3.3. The respondent's heads of argument shall be filed before 11h00 on the Friday immediately preceding the date of hearing.

13.3.4. The heads of argument of all parties shall be accompanied by a practice note in which the issues in the application are succinctly identified and an estimated duration of the argument is stated.


**4. Replace Rule 16.5 with the following:**

16.5 Leave to appeal applications can be decided in chambers upon written representations, unless one of the parties or both request a hearing in open court, or where the judge deems it desirable to hear the application in open court.

**5. Replace Rule 17.4 with the following:**

17.4 Leave to appeal applications can be decided in chambers upon written representations, unless one of the parties or both request a hearing in open court, or where the judge deems it desirable to hear the application in open court.

**6. These amendments shall come into operation on 1 June 2013 insofar as they are not yet en force.**



**SCHEDULE****Definitions**

1. In this Schedule the definitions are as follows:

**"Category A"**, in respect of a private consulting practice in natural sciences, shall mean a top practitioner whose expertise is nationally or internationally recognised and who provides advice at a level of specialisation where such advice is recognised as that of an expert;

**"Category B"**, in respect of a private consulting practice in natural sciences, shall mean a partner, a sole proprietor, a director, or a member who, jointly or severally with his other partners, co-directors or co-members, bears the risk of the business, takes full responsibility for the liabilities of such practice, performs work of a conceptual nature in natural sciences and development, provides strategy guidance in planning and executing a project and/or carries responsibility for quality management pertaining to a project;

**"Category C"**, in respect of a private practice in natural sciences, shall mean all salaried professional and technical staff performing work of a natural scientific nature and who carry the direct technical responsibility for one or more specific activities related to a project. A person referred to in Category B may also fall in this category if such person performs work of a natural scientific nature at this level;

**"Category D"**, in respect of a private consulting practice in natural sciences, shall mean all other salaried technical staff with adequate expertise and relevant experience performing work of a natural scientific nature with direction and control provided by any person contemplated in Categories A or B or C.

- (b) **“annual fee”** means the fee payable by the registered person within 60 days from the date on which he/she is informed (in writing) that his/her annual fee has become payable. Annual fees will become payable on the 1<sup>st</sup> of April of every year. In the first year of registration a *pro rata* annual fee will be payable in the month following the date of registration.
- (c) **“qualifications assessment fee”** must be paid for evaluation of qualifications for registration purposes.
- (d) **“re-instatement fee”** means the fee payable on submission of an application to reinstate a registration. A fee is payable for each field of practice for which re-instatement is required.
