PUBLICATION OF EXPLANATORY SUMMARY OF SOUTH AFRICAN POSTBANK LIMITED AMENDMENT BILL, 2013

1. Notice is hereby given in terms of Rule 241(1) (b) of the Rules of the National Assembly of Parliament that the Minister of Communications intends to introduce the South African Postbank Limited Amendment Bill, 2013, in the National Assembly shortly.

2. The explanatory summary of the Bill is hereby published in accordance with Rule 241(1) (c) of such Rules.

3. The Bill makes provision for the amendment of the South African Postbank Limited Act, 2010; so as to amend provisions that may negatively affect the operational autonomy and independence of the Office for Banks; to remove any inconsistencies with the Banks Act; and to provide for matters connected therewith.
