

**LAND SURVEY ACT 8, 1997: AMENDMENT OF REGULATIONS**

I, Gugile Ernst Nkwinti, Minister of Department of Rural Development and Land Reform, acting in terms of Land Survey Act 8, 1997 (Act No. 8 of 1997), after consultation with Survey Regulations Board, hereby amend the Regulations promulgated by Government Notice R1130 of 29 August 1997, as set out in the Schedule hereto. The Regulations will come into operation one month from the date of publication hereof in the *Government Gazette*.

## SCHEDULE

### DEFINITIONS

1. “GPS” is hereby amended by the substitution of the following definition:

“GNSS means Global Navigation Satellite System”

### Amendment of Regulation 3

2. Regulation 3 is hereby amended by the entire substitution of sub-regulation (2) (d) by the following sub-regulation:

“(d) when its position is determined by GNSS, at least two known points or two independent vectors shall be used;”

### Amendment of Regulation 6

3. Regulation 6 is hereby entirely amended by the substitution of the regulation by the following regulation:

“For the purpose of section 24 of the Act the limit of disagreement from the original diagram is –

$$0,11\sqrt{d}$$

where d represents the distance in metres derived from data on the original diagram between any two beacons affected by the subdivision. Any portion of a boundary line shall be deemed to be within the limit when the whole of such boundary line is within such limit.”

### Amendment of Regulation 18

4. Regulation 18 is hereby amended by the substitution of the sub-regulation (1) (e) (ii) and (iii) by the following sub-regulations:

“ (e) (ii) the relative positions, descriptions and designations of all beacons, stations or points used, adopted, fixed and calculated during the course of the survey:  
Provided that descriptions of beacons, stations or other points need not be shown if they appear on the co-ordinate list;

(e)(iii) the positions of all curvilinear boundaries, which unless co-ordinates are provided, shall be plotted to the scale of the diagram to be framed or to a scale of 1/7500”

### **Amendment of Regulation 20**

**5** Regulation 20 is hereby amended by the entire deletion of sub-regulation 20 (2).

## SCHEDULE

1. In this Schedule "Rules" means the Rules Relating to the Practising of Veterinary Professions under the Veterinary and Para-Veterinary Professions Act, 1982, published under Government Notice No. R 34 of 18 January 2002, and any word or expression to which a meaning has been assigned in the Rules shall have that meaning, unless the context otherwise indicates.

### Amendment of rule 1

2. Rule 1 of the Rules is hereby amended by the insertion of the following definition of "veterinary shop" \_ after the definition of "veterinary services at all times"

"veterinary shop" means a facility at or from which a person who practices a veterinary profession sells veterinary pharmaceutical products, including products for which the manufacturer has limited the sale to veterinary professionals, to the public

### Insertion of Part XI

3. The Rules are hereby amended by the insertion of the following heading and rules after rule 40:

#### **"RULES: PART XI: MINIMUM STANDARDS FOR VETERINARY SHOPS**

##### **General structural requirements**

41.(1) A veterinary shop shall –

- (a) be a permanent structure. (This is not intended to exclude buildings, which are factory produced and site assembled, e.g. a prefabricated building as the word "permanent" relates to the materials used and not the building itself);
- (b) have adequate lighting and ventilation;
- (c) have internal walls and floor surfaces that are neat and constructed of impervious materials to ensure that hygienic conditions can be maintained.
- (d) have sufficient storage space to ensure hygienic insect and rodent free storage of all items stocked in the veterinary shop; and
- (e) have provision for the display of merchandise in or on neat and attractive display cabinets, shelving, counters and tables that have impervious surfaces that can be properly cleaned and disinfected.

**General procedural requirements**


- 42.(1) Only a veterinarian may have a financial interest in and own a veterinary shop.
- (2) All staff employed at a veterinary shop should have completed a minimum training course acceptable to council to ensure that they are adequately and appropriately trained and qualified to offer a professional service to the public;
- (3) Attendance certificate need to be kept for each staff member as proof of completion of the acceptable training course.
- (4) Any consultation or service requests of a veterinary clinical nature should be referred to a registered veterinary facility.
- (5) Veterinary or para-veterinary supervision at a veterinary shop is essential with active and visible participation in the activities of veterinary shop

**Sale of merchandise**

- 44.(1) The following products may be sold at a veterinary shop:
  - (i) Medicines that are registered as schedule 0 medicines in terms of the Medicines and Related Substances Control Act, Act 101 of 1965;
  - (ii) Stock remedies registered without any conditions for sale or use in terms of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, Act 36 of 1947; and
  - (iii) Any other veterinary pharmaceutical products including products for which the manufacturer has limited the sale to veterinary professionals.
- (2) Stock remedies registered with restricted requirements such as for "use by or under the control of a veterinarian only" in terms of the Fertilizers, Farm Feeds, Agricultural Remedies and Stock Remedies Act, Act 36 of 1947 may only be sold if a veterinarian has advised on the suitability of the stock remedy and is present in the veterinary shop at the time of the sale.
- (3) No medicines registered as schedule 1 or any higher schedule in terms of the Medicines and Related Substances Control Act, Act 101 of 1965 may be sold from a veterinary shop.
- (4) No live animals are to be kept for sale or sold at a veterinary shop."

**Designation of Diners Club (SA) (Proprietary) Limited as a designated clearing system participant****1. Introduction**

1.1 The South African Reserve Bank ("the Reserve Bank") is empowered to designate a clearing system participant in terms of section 6(3)(a) of the National Payment System Act, 1998 (Act No. 78 of 1998) ("the Act"), as amended. Such designation may be made if it is in the interest of the integrity, effectiveness, efficiency or security of the payment system.

1.2 The objective of this Designation Notice ("Notice") is to designate Diners Club (SA) (Proprietary) Limited (Registration No. 1956/000068/07) ("Diners Club") as a designated clearing system participant. The designation will enable Diners Club to clear in the manner contemplated in section 4 (2)(d)(i) of the Act.

**2. Background of the proposed designated clearing system participant**

2.1 Diners Club is operating as a wholly owned subsidiary of The Standard Bank of South Africa Limited ("Standard Bank") under a franchise agreement with Diners Club International Limited.

2.2 Diners Club issues and acquires Diners Club branded cards that clients use to purchase goods and services, as well as withdraw cash.

2.3 Transactions initiated through the use of Diners Club cards may either be:

- 2.3.1 "on-us" payment instructions, as part of a closed-loop business model; or
- 2.3.2 payment instructions cleared and settled in the payment system by Standard Bank on behalf of Diners Club. These payment instructions fall within the ambit of clearing, as contemplated in the Act, and therefore it is required that Diners Club be designated by the Reserve Bank as a designated clearing system participant.
- 2.4 The Act allows for non-banks to clear payment instructions in the payment system if designated as a designated clearing system participant, and subject to any terms and conditions imposed by the Reserve Bank.

### 3. Designation

The Reserve Bank has considered the provisions of the Act together with the nature of the activities of Diners Club as indicated in clause 2.3.2, and has deemed it to be in the interest of the integrity, effectiveness, efficiency and security of the payment system to designate Diners Club as a designated clearing system participant.

Therefore, I Gill Marcus, Governor of the Reserve Bank hereby with effect from 01 September 2013:

- (1) DESIGNATE, in accordance with section 6(3)(a) of the Act, Diners Club as a designated clearing system participant, subject to the conditions listed in clause 4; and
- (2) CONFIRM, in terms of section 6(3)(a)(ii) of the Act, that the Reserve Bank settlement system participant associated with Diners Club, as the designated clearing system participant, is Standard Bank.

#### 4. Conditions

4.1 The aforementioned designation is subject to Diners Club adhering to the following conditions within a period of twelve months from the date of this Notice:

4.1.1 comply with the entry and participation criteria to become a member of the payment system management body ("PSMB") as referred to in section 3 of the Act as well as a member of the relevant structures in the PSMB;

4.1.2 comply with all other criteria set by the PSMB for clearing system participants, not contained in clause 4.1.1;

4.1.3 enter into a mentorship and sponsorship agreement with Standard Bank as well as comply with any other requirements set by Standard Bank for sponsorship;

4.1.4 participate in such Payment Clearing Houses ("PCHs") established by the PSMB to govern and manage the clearing and settlement of card-related transactions, for example, purchase transactions and cash withdrawals;

4.1.5 obtain written approval from Standard Bank, which written approval shall not be unreasonably withheld, prior to participating in a PCH that is not set out in clause 4.1.4 above. Provided that written approval is granted, Diners Club may then follow the normal process for participation in a PCH;

4.1.6 terminate participation in any PCH, subject to the process for termination determined by the PSMB, and prior written notice to the Reserve Bank and Standard Bank; and

4.1.7 not sponsor, as contemplated in the "Sponsorship Criteria within the National Payment System" issued by the PSMB, any entity in any PCH.



4.2 The conditions listed above apply exclusively for the designation of Diners Club and may be varied, revoked or new conditions imposed by the Reserve Bank by way of a notice in the Government Gazette.

5. **Recordal**

It is recorded that the Diners Club activity referred to in clause 2.3.1 which does not fall within the clearing environment shall continue and be unaffected by the designation contemplated in this Notice.


