NOTICE FOR THE EXTENSION OF THE SUBMISSION DATE FOR TOLL-FREE FRAMEWORK PROPOSALS.

On 01 August 2013 the Independent Communications Authority of South Africa ("the Authority") published a general notice (GG 36 722 of 2013) inviting interested persons to submit written proposals or representations on the development of toll-free proposals within 30 days.

The submission deadline for all proposals was 09 September 2013. On 27 August 2013, the Authority received written representations requesting for an extension on the submission date.

The Authority has considered the request and decided to grant an extension of seven (7) working days from 09 September 2013 to 18 September 2013.
