NOTICE OF INTENTION TO INTRODUCE THE MERCHANT SHIPPING AMENDMENT BILL, 2013 INTO PARLIAMENT IN TERMS OF THE RULE 241(1) (b) OF THE NATIONAL ASSEMBLY

The Minister of Transport hereby in terms of National Assembly Rule No.241(1) (b) intends introducing the Merchant Shipping Amendment Bill, 2013 ("the Bill") in Parliament during the third term of 2013.

The Bill and its Explanatory Memorandum were published for a comment in Government Gazette No. 36839 dated 11th September 2013 and is called the Merchant Shipping Amendment Bill, 2013

The object of the Bill is as follows:

- To amend the Merchant Shipping Act, 1951, so as to give effect to the Maritime Labour Convention, 2006 and the Work in Fishing Convention, 2007; and to provide for matters connected therewith.
