DEPARTMENT OF ENERGY**No. R. 849****5 November 2013****PETROLEUM PRODUCTS ACT, 1977 (ACT No. 120 OF 1977)****REGULATIONS IN RESPECT OF THE SINGLE MAXIMUM NATIONAL
RETAIL PRICE FOR ILLUMINATING PARAFFIN**

1. I, Mr. Dikobe Ben Martins, Minister of Energy, under section 2(1)(c) of the Petroleum Products Act, 1977 (Act No. 120 of 1977), determine that a maximum retail price for Illuminating Paraffin (excluding the price of any form of packaging) will become effective on the first Wednesday of each month.
2. The maximum retail price for illuminating paraffin, excluding the price of any form of Packaging for the period 06 November 2013 to 02 December 2013 will be 1246 .0 c/l.
3. **Commencement**
These regulations shall come into operation at **00:01 on 6 November 2013**.
