NOTICE 1092 OF 2013

MEMBERS APPOINTED TO THE BOARD OF THE ROAD ACCIDENT FUND

The Road Accident Fund is a national public entity established for the purpose of paying compensation in accordance with the provisions of the Road Accident Fund Act, 1996 (Act No. 56 of 1996) as amended, for loss or damage wrongfully caused by the driver of a motor vehicle within the Republic of South Africa.

The RAF Act makes provision for the appointment of the Board, whose powers and functions, amongst others, are to ensure that the Fund strives for the achievement of the objects stipulated in the Act and exercise overall authority and control over the financial position, operation and management of the Fund.

The Act requires the Minister to publish the names in the *Gazette* of members appointed to the Board together with such member's area of expertise. Members who were appointed with effect from 1 October 2013 for a period of three years are listed below –
