#### CIVIL AVIATION REGULATIONS, 2011

The Minister of Transport intends, in terms of section 155(1) of the Civil Aviation Act, 2009 (Act No. 13 of 2009) and on the recommendation of the Civil Aviation Regulations Committee (CARCom), to amend the Civil Aviation Regulations, 2011, by the amendment of the following Parts:

Part 1:	General Provision
Part 91:	General operating and flight rules
Part 92:	Conveyance of dangerous goods
Part 141:	Aviation training organisation
SA-CATS 61	Pilot licensing
SA-CATS 121	Air transport operations: Carriage on the aeroplanes of more than passengers or cargo
SA-CATS 135	Air transport operation: Small aeroplanes
