**ELECTORAL ACT 73 of 1998****AMENDMENT TO THE REGULATIONS CONCERNING THE SUBMISSION OF  
LISTS OF CANDIDATES, 2004,****Published under**

GN R14 in Government Gazette No. 25894 of 7 January 2004

General N 1203 in Government Gazette No. 31451 of 26 September 2008

GN R1168 in Government Gazette No. 31558 of 30 October 2008

The Electoral Commission has, under the powers vested in it by section 100 of the Electoral Act, 1998 (Act No. 73 of 1998), made the regulations set out in the Schedule.

**SCHEDULE****Definition**

1. In this schedule, a word or expression to which a meaning has been assigned in the Act shall bear the meaning so assigned to it, and unless the context otherwise indicates--

"the Act" means the Electoral Act, 1998 (Act No. 73 of 1998); and

"the Regulations" means the Regulations Concerning The Submission of Lists of Candidates, 2004, published in GN R 14 in Government Gazette No. 25894 of 7 January 2004 as amended by General Notice in Government Gazette No. 3145 of 26 September 2008 as amended by GN R1168 in Government Gazette No. 31558 of 30 October 2008.

**Amendment of Regulation 2 of the Regulations**

2. Regulation 2 (1) (a) of the Regulations, is hereby amended by the substitution for the phrase “situated at 260 Walker Street, Sunnyside in Pretoria” of the phrase “situated in Election House, Riverside Office Park, 1303, Heuwel Avenue, in Centurion.”

**Amendment of Regulation 3 of the Regulations**

3. Regulation 3 (1) of the Regulations, is hereby amended-

- (a) by the substitution for subregulation 3 (1) (a) of the following subregulation:  
“3 (1) (a) two hundred thousand rand (R 200, 000-00) in respect of an election of the National Assembly;” and
- (b) by the substitution for subregulation 3 (1) (b) of the following subregulation:  
“3 (1) (b) forty five thousand rand (R 45, 000-00) in respect of an election of a provincial legislature;”

**Substitution of Appendix 5 of the Regulations**

4. Appendix 5 of the Regulations is hereby substituted for the following Appendix:
