HEALTH PROFESSIONS ACT, 1974 (ACT NO.56 OF 1974)

REGULATIONS RELATING TO THE REGISTRATION OF MEDICAL TECHNICIANS IN THE CATEGORY TUBERCULOSIS (BACTERIUM): CORRECTION NOTICE

The Minister of Health has, under sections 61 of the Health Professions Act, 1974 (Act No. 56 of 1974), and after consultation with the Health Professions Council of South Africa, made the regulations in the schedule.


SCHEDULE

Definitions

1. In these regulations "**the regulations**" means regulations relating to the registration of medical technicians in the category tuberculosis (bacterium) published under Government Notice R399 in *Government Gazette* 35367 of 21 May 2012, and any word or expression to which a meaning has been assigned in the regulations shall have that meaning and, unless the context otherwise indicates -

Amendment of Regulation 2 of the regulations.

2. Regulation 2 of the regulations is hereby amended by the substitution for the word "Immunology" of the words "tuberculosis (bacterium)"
