#### FOODSTUFFS, COSMETICS AND DISINFECTANTS ACT, 1972 (ACT 54 OF 1972) REGULATIONS RELATING TO MILK AND DAIRY PRODUCTS: AMENDMENT

The Minister of Health, in terms of Section 15(1) of the Foodstuffs, Cosmetics and Disinfectants Act, 1072 (Act 54 of 1972), made the regulations contained in the Schedule.

#### SCHEDULE

##### Definitions

1. In these Regulations "the Regulations" means the regulations published by Government Notice R 1555 of 21 November 1997, as corrected by Government Notice No. R. 1278 of October 1999 and amended by Government Notices No. R. 53 of 28 January 2000, No. R. 755 of 28 July 2000, No. R 837 of 25 August 2000 and R. 1052 of 27 October 2000.


##### Amendment of Annexure C of the Regulations
