# FOODSTUFFS, COSMETICS AND DISINFECTANTS ACT, 1972 (ACT 54 OF 1972) REGULATIONS RELATING TO MILK AND DAIRY PRODUCTS: AMENDMENT

The Minister of Health, in terms of Section 15(1) of the Foodstuffs, Cosmetics and Disinfectants Act, 1072 (Act 54 of 1972), made the regulations contained in the Schedule.
