COUNCILS OF THE UNIVERSITY OF MPUMALANGA AND SOL PLAATJE
UNIVERSITY RESPECTIVELY IN TERMS OF SECTION 20(7) OF THE HIGHER
EDUCATION ACT, 1997**

I, Bongikosi Emanuel Nzimande, MP, Minister of Higher Education and Training, have established the Interim Councils of the University of Mpumalanga and the Sol Plaatje University in terms of section 20(6) of the Higher Education Act, 1997 under Government Notice No. 631 in Government Gazette No. 36772 dated 22 August 2013 and under Government Notice No. 630 in Government Gazette No. 36771 dated 23 August 2013, respectively.

I hereby in terms of section 20(7) of the Higher Education Act, extend the period of establishment of –

- a) i) the Interim Council of the University of Mpumalanga for a period of six (6) months from 23 February 2014 to 23 August 2014; and
- ii) the term of office of the following members of the Interim Council of the University of Mpumalanga is extended for further six months until 23 August 2014:

- b) i) the Interim Council of the Sol Plaatje University for a period of six (6) months from 24 February 2014 to 24 August 2014; and
- ii) the term of office of the following members of the Interim Council of the Sol Plaatje University is extended for further six months until 24 August 2014:

- Mr Maripung Lekwene;
- Mr Abel Madonsela; and
- Dr Yvonne Muthien.
