CIVIL AVIATION ACT, 2009 (ACT NO. 13 OF 2009)

FIFTH AMENDMENT OF THE CIVIL AVIATION REGULATIONS, 2011

I Dipuo Elizabeth Peters, Minister of Transport hereby in terms section 155(1)(z)(i), read with section 74(1) (a), of the Civil Aviation Act, 2009, (Act No. 13 of 2009), after consultation with the Minister of Finance, make the regulations in the Schedule hereunder.

SCHEDULE

1. Amendment of Part 187 of the Civil Aviation Regulations, 2011 (hereinafter referred to as "the Regulations")

Part 187 of the Regulations is hereby amended by -

a) the renumbering of the existing regulation 187.01.15 as regulation 187.01.15(1);

b) the substitution in regulation 187.01.15(1) for paragraph (a) of the following paragraph:

"(a) for appeals against being found medically unfit 5 000.00

c) the addition in regulation 187.01.15 of the following sub-regulation as sub-regulation(2):

"(2)(a) If the Director sets aside any decision on an appeal, the fees referred to in subregulation (1) must be refunded to the appellant.

(b) If the Director varies any such decision, he or she may direct that the whole or part of such fees be refunded to the appellant."

These Regulations are called the Fifth Amendment of the Civil Aviation Regulations, 2011, and shall come into operation on the 01st of May 2014.
