**CALEDON MODDER SUBSYSTEM – LIMITING THE USE OF WATER IN TERMS OF
ITEM 6 OF SCHEDULE 3 OF THE NATIONAL WATER ACT OF 1998 FOR URBAN AND
IRRIGATION PURPOSES FROM THE DAMS WITHIN THE CALEDON-MODDER
SUBSYSTEM**

I, *Trevor Balzer*, in my capacity as Director General (Acting) of the Department of Water Affairs, on reasonable grounds believe that a water shortage exists in the Caledon Modder subsystem especially in the Modder River catchment. This is due to insufficient rains and infrastructural constraint that are limiting transfer capacity from the Caledon to the Modder sub-system.

The Minister of Water and Environmental Affairs may in terms of item 6(1) of Schedule 3 to the National Water Act of 1998 (Act No. 36 of 1998)(the Act) limit the use of water in the area concerned if the Minister on reasonable grounds believes that a water shortage exists within the area concerned. This power has been delegated to me in terms of section 63(1) (b) of the Act.

Therefore, in my capacity as the Director General (Acting) of the Department of Water Affairs, I hereby under delegated authority in terms of item 6 (1) of Schedule 3 to the Act limit the taking of water from the Caledon-Modder subsystem by all users as follows-

- a) 15% restriction on water use for Domestic and Industrial supply to the Mangaung Metropolitan Supply area; and
- b) 50% restrictions on the use of water for Irrigation purposes in the Modder River sub-catchment upstream of Maselspoort Dam.

Water for irrigation from the main stem of the Modder River is further limited as follows-

- a) No water may be taken from the Modder River for any agricultural purpose between 18h00 on a Friday until 06h00 on the Monday succeeding that Friday;
- b) Please take note that starting from the date of this notice-
 - (i) water users on the left bank of the Modder River may from 06h00 to 18h00 take water on Monday, Wednesday and Friday; and
 - (ii) in the same week the water users on the right side of the Modder River may from 06h00 to 18h00 only take water on Tuesday and Thursday.


- c) The following week from notice-
- (i) water users on the right bank of the Modder River may from 06h00 to 18h00 take water on Monday, Wednesday and Friday; and
 - (ii) in the same week the water users on left side of the Modder River may from 06h00 to 18h00 only take water on Tuesday and Thursday.
- d) This arrangement should be followed in the same pattern of interchanging weeks until further notice is issued;
- e) Water may only be taken with waterworks as they were in operation on 1 November 2013; and
- f) A left bank of the river is defined as the left side of a person, if that person looks in the direction the water flows in a river concerned.

The limitations apply from the date of this notice until further notice.

In exercising the powers, I have given preference to the maintenance of the Reserve, treated all water users on a basis that is fair and reasonable, considered the actual extent of the water shortage, the likely effects of the shortage on the water users, the strategic importance of any water use and any water rationing or water use limitations by a water services institution having jurisdiction in the area concerned under the Water Services Act 108 of 1997.

Placing limitation on the taking of water use as set out in this notice is an administrative action affecting the rights of the public as contemplated in section 4 of the Promotion of Administrative Justice Act 3 of 2000 (PAJA). After I have taken into consideration all relevant factors, including those referred in section 4 (4) (b) of PAJA, I have decided that it is reasonable and justifiable in the circumstances to depart from the requirements referred to in section 4 (1) (a) to (e), (2) and (3) of PAJA and instituted this limitation without allowing the water users affected and other role players to comment on the matter before I institute the limitation.

This notice overrides any other previous authorization on water restrictions issued by the Department relating to this area.

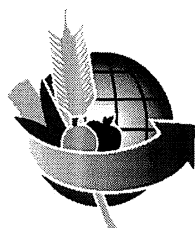

- (1) In this Regulations a word or expression to which a meaning has been assigned in this Act has that meaning and, unless the context otherwise indicates—

“**person**” includes juristic person;

2. Requirements for pollution prevention plans

- (1) A pollution prevention plan must include—

- (a) Full details of the person;
- (b) Full contact details;
- (c) Full description of the activity;
- (d) Details of the current methods used by the person to monitor and measure greenhouse gas emissions and any plan to improve such monitoring and measurement in the future; and
- (e) Measures on how and over what period the person will reduce the greenhouse gas emissions.

3. Submission of pollution prevention plans

- (1) Pollution prevention plans must be submitted by 31 March 2015 and shall be submitted every five years thereafter.
- (2) A person must submit progress report towards implementation of the pollution prevention plan by 31 March each year for the preceding calendar year.
- (3) Upon receipt of the pollution prevention plan or progress report on the approved pollution prevention plan, the Department must within 14 days in writing—
- (a) acknowledge receipt of and accept the pollution prevention plan or progress report on the approved pollution prevention plan if it is in order; or
 - (b) acknowledge receipt and reject the pollution prevention plan or progress report on the approved pollution prevention plan if it not in order.
- (4) The Department must, in writing, within 60 days after acknowledgement of receipt contemplated in subregulation (3) of the pollution prevention plan or progress report on the approved pollution prevention plan—
- (a) If all is in order, accept the pollution prevention plan or progress report on the approved pollution prevention plan and advise the person to proceed with the implementation thereof; or
 - (b) If all is not in order, request the person to make amendments to the pollution prevention plan or progress report on the approved pollution prevention plan within 60 days, if so required.

4. Short title and commencement

These Regulations are called the National Pollution Prevention Plans Regulations, 2014, and come into effect on 31 March 2015.

 - (d) Hydrofluorocarbons (HFCs);
 - (e) Perfluorocarbons (PFCs); and
 - (f) Sulphur hexafluoride (SF₆).

3. Persons required to submit pollution prevention plans

A person conducting an activity set out in Annexure I to this Notice which involves the emission of greenhouses declared as priority air pollutant in paragraph 2 in excess of 0.1 Megatonnes (10⁹ kg) (Mt) or more annually or measured as CO_{2-eq} is required to submit a pollution prevention plan.

4. Requirements for a significant emitter of greenhouse gases

The person referred to in paragraph 3 must prepare, submit to the Minister for approval, a pollution prevention plan in accordance with the requirements contained in the regulation developed in terms of section 29(3) of this Act.

GUIDANCE ON THE INTERPRETATION OF THE SCHEDULE

1. The schedule reflects the annual safety permit fees applicable to different types of permits as provided for in S.28(a) of the Act. Safety Permit Fees are exempted from VAT as the Regulator is a Schedule 3A Entity in terms of the Public Finance Management Act.
2. Application fees (*Point 1 in Section A of the Notice*) are payable when any type of safety permit is applied for. This is charged only on application.
3. Temporary safety permit fees (*Point 2 in Section A of the Notice*) are payable when an operator is about to be issued with a temporary safety permit, valid for 6 months. These fees are only charged when the permit is issued, not on an annual basis.
4. All revenue generating operators conducting or commencing normal rail operations are issued with either a Group A, Group B or Group C safety permit. Group A, B and C safety permit fees are charged prior to the issuing of a safety permit when applied for.
- 4.1. The following formula is used to determine the Safety Permit fees for Group A revenue generating operators (*refer to the Legend in Section C in the Notice to calculate the variables*):

$$\text{Group A Safety Permit Fee (W)} = (Y-U-V) * X/Z$$

5. All train, network and/or station non-revenue generating operators conducting or commencing normal rail operations are issued with train, network and/or station safety permits. Train, network and/or station safety permit fees are charged prior to the issuing of a safety permit when applied for as well as on an annual basis when new permits are required to be renewed.
- 5.1. The following formula is used to determine the Safety Permit fees for train, network and/or station non-revenue generating operators (*refer to Section B in the Notice to calculate the [Unit]*):

$$\text{Safety Permit Fee (R)} = [\text{Unit}] \times [\text{Fee Rate}]$$

6. No operator will pay less than what they are currently paying + CPI increase. In addition, no operator will pay less than the basic minimum fee + the CPI increase. For 2014/15, the basic minimum fee + annual CPI is R 6 996 .00.
7. All safety permit fee increases will not exceed a maximum of 140%.
8. All operators are required to, within thirty working days (30), provide the Railway Safety Regulator with all applicable data to ensure that the Regulator conduct audits for calculations of operator levies and ensure accuracy and validity of information reported.
9. All safety permits are valid for twelve (12) months only.


