THE SOUTH AFRICAN DENTAL TECHNICIANS COUNCIL

NOTICE REGARDING ANNUAL FEES PAYABLE TO THE COUNCIL

I, Pakishe Aaron Motsoaledi, Minister of Health, hereby fix, in terms of section 49 of the Dental Technicians Act, 1979 (Act No. 19 of 1979) ("the Act"), and on the recommendation of the South African Dental Technicians Council (hereinafter referred to as "the Council"), the fees set out in the Schedule as the fees to be paid to the Council.

SCHEDULE

Annual fees payable by dental technicians and dental technologists

1. Any person who, in terms of section 18 of the Act—
 - (a) is registered, shall pay to the Council an amount of **R1,000.00** as an annual fee ;
or
 - (b) is registered during such period shall pay to the Council an amount of **R 500.00** as an annual fee in respect of the unexpired portion of that year.

Annual fees payable by permit holders for trading in un-mounted artificial teeth

2. Any person who, in terms of section 33(3) of the Act—
 - (a) registers with the Council as a dental trader, shall pay to Council a registration fee of an amount of **R 1,850.00**;
 - (b) is issued with a permit by the Council, shall pay to Council an amount of **R 5,000.00** as an annual fee for the period 1 March 2014 to 28 February 2015; or

- (c) is issued with a permit by the Council during such period shall pay to the Council an amount of **R 2,500.00** as an annual fee in respect of the unexpired portion of that financial year.

Annual fees payable by dental laboratory assistants

3. Any person who, in terms of section 28(3) of the Act would like to apply for registration as a dental laboratory assistant during 2014, shall pay to the Council an annual fee for the period 1 March 2014 to 28 February 2015, as to be determined by the Council.

Registration fees payable by dental technician assistant

4. Any person who, in terms of section 23A of the Act would like to apply for registration as a dental technician assistant, shall pay to the Council an amount of **R492.00** for the period 1 March 2014 to 28 February 2015.

Application fees for CPD Accreditation Activities

5. Any registered person or service provider of activities related to continuous professional development, shall apply to Council for accreditation of such activity and pay the following fees in terms of section 50(1)(r) of the Dental Technicians Act as amended:

(a) Application for CPD Activity		R400.00
(b) Application for Micro Event		R800.00
(c) Application for Macro Event		R5000.00
(d) Late Application		R2000.00
(e) Road show/s	One show	R600.00
	Two or more shows	R1200.00
(i) Non-profit Interest Group		R600.00
(ii) Profit making – Special Interest Group		R600.00 per annum

Liability

6. The annual fees referred to in-

- (a) paragraphs 1(a) and 2(a) shall be due on period 1 March 2014 of the financial year concerned and shall be payable not later than 31 March of that financial year; and
 - (b) paragraphs 1.(b) and 2(b) shall be due on the day of the registration concerned or the permit is issued, as the case may be, and shall be payable on or before the last day of the third month following that day, or on 28 February of that financial year, whichever date is the earlier.
7. If a person referred to in paragraphs 1 and 2, as the case may be, does not pay the annual fees referred to in the aforementioned paragraphs by the relevant date referred to in paragraph 3, the registrar shall send a reminder by e-mail and/or registered post to such dental technician(s) or the permit holder's address, as the case may be, as entered in the register.

Removal from the Register

8. If a person referred to in paragraphs 1 and 2 does not pay the annual fees within three (3) months after the date on which the reminder referred to in subparagraph(1) was sent to him or her, his or her name shall be removed from the register concerned in terms of section 24(1) or the permit be withdrawn in terms of section 33(4) of the Act as the case may be.
9. A person referred to in paragraph 4 whose name has been removed from the register concerned or whose permit has been withdrawn, may be restored to such register in terms of section 24(5) of the Act, or his permit be restored, if such person-
- (a) within a period of six (6) months after the date on which his or her name was removed from the register concerned, pays the equivalent of two (2) times the annual fee referred to in paragraph (a) or 2(a), including any other outstanding fee(s); or
 - (b) after a period of six (6) months has expired after the date on which his or her name was removed from the register concerned, pays the equivalent of five (5) times the annual fee referred to in paragraph 1(a) or 2(a), including any other outstanding fee(s).

Exemption

10. The Council may by resolution, order the Registrar to exempt any dental technician or dental technologist for an indefinite or definite period, from the age of 70 years from payment of any annual fee prescribed in terms of subparagraph 1, if the Council is satisfied that such a dental technician or dental technologist-
- (a) has a written application by way of an affidavit accompanied by a certified copy of a valid identity document, before 28 February preceding the year for which exemption is sought or applied for, and
 - (b) has attained the age of 70 years; and
 - (c) has paid the prescribed fee of **R 334.00**

Value added tax

11. All fees referred to in this notice shall include 14% value-added tax.

Commencement

- 12 This notice shall come into operation on 1 March 2014.

Withdrawal of notice

- 13 Government Notice No. R150 of 08 February 2008 is hereby withdrawn.

Ek, Pakishe Aaron Motsoaledi, Minister van Gesondheid, het, kragtens artikel 49 van die Wet op Tandtegnici, 1979 (Wet No. 19 van 1979) ("die Wet"), en op aanbeveling van die Suid-Afrikaanse Raad vir Tandtegnici (hierna "die Raad" genoem), die gelde in die Bylae uiteengesit, vasgestel as die gelde wat aan die Raad betaal moet word.

BYLAE**Jaarlikse gelde betaalbaar deur tandtegnici en tandtegnoloë**

1. Enige persoon wat kragtens artikel 18 van die Wet—
 - (a) geregistreer is, betaal aan die Raad 'n bedrag van **R1,000.00** as jaarlikse gelde; of
 - (b) gedurende genoemde tydperk geregistreer word, betaal aan die Raad 'n bedrag van **R5,00.00** as jaarlikse gelde ten opsigte van die onverstreke gedeelte van daardie jaar.

Jaarlikse gelde betaalbaar deur permit houers wat handeldryf in ongemonteerde kunstande

2. Enige persoon wat kragtens artikels 33 (3) van die Wet—
 - (a) met die Raad as 'n tandheelkundige handelaar registreer, betaal aan die Raad 'n registrasie fooi bedrag van **R1850.00**.
 - (b) aan wie in 'n permit deur die Raad uitgereik is, sal aan die Raad 'n bedrag van **R5,000.00** as jaarlikse gelde vir die periode 1 Maart 2014 tot 28 Februarie 2015 vir elke finansiële jaar betaal; of

- (c) as 'n permit deur die Raad uitgereik word gedurende sodanige periode, sal 'n bedrag van **R2,500.00** as jaarlikse gelde aan die Raad betaalbaar wees, vir die onverstreke gedeelte van daardie jaar.

Registrarsie fooi betaalbaar deur tandtegnikus assistent

4. Enige persoon wat Kragtens artikel 23A van die Wet op Tandtegnici, 1979 (Wet nr.19 van 1979), aansoek wil doen as 'n tandtegnikus assistent, sal aan die Raad 'n bedrag van **R492.00** vir die periode van 1 Maart 2014 tot 28 Februarie 2015 betaal.

Aansoek fooi vir VPO Akkreditasie Aktiviteite

5. Enige geregistreerde persoon of diensverskaffer van aktiwiteite met betrekking tot voortdurende professionele ontwikkeling, moet by die Raad aansoek doen vir akkreditasie van die aktiwiteit en die volgende gelde betaal in terme van artikel 50(1)(r) van die Wet op Tandtegnici, soos gewysig

Aanspreeklikheid**6. Die jaarlikse gelde in-**

- (a) paragraaf 1(a) en 2(a) is verskuldig op 1 Maart van die betrokke finansiële jaar en is betaalbaar nie later nie as 31 Maart van daardie finansiële jaar, en
- (b) paragraaf 1(b) en 2(b) is verskuldig op die dag van die betrokke registrasie of waarop die permit uitgereik is, na gelang van die geval, en is betaalbaar voor of op die laaste dag van die derde maand wat op daardie dag volg of op 28 Februarie van daardie finansiële jaar, welke datum ook al die vroegste is.

7. Indien 'n persoon in paragraaf 1 en 2 bedoel, na gelang van die geval, nie die jaarlikse gelde in die voormelde paragrawe vermeld, teen die datum in paragraaf 3 bedoel, betaal nie, moet die registrateur 'n aanmaning per e-pos en/of aangetekende pos aan sodanige tandtegnikus of permithouer, wat die geval ook mag wees, se adres wat in die register aangeteken is, stuur.

Betrokke register

8. Indien 'n persoon in paragraaf 1 en 2 bedoel nie die jaarlikse geld binne (3) drie maande na die datum waarop die aanmaning bedoel in subparagraaf (1) aan hom of haar gestuur is, betaal nie, moet sy of haar naam van die betrokke register geskrap word ingevolge artikel 24(1) van die Wet of die permit onttrek word ingevolge artikel 33 (4) van die Wet, wat die geval ook mag wees.

9. 'n persoon in paragraaf 4, wie se naam geskrap is van die betrokke register, of wie se permit onttrek is, kan kragtens artikel 24(5) van die Wet op sodanige register teruggeplaas word, of sy permit kan weer uitgereik word, indien sodanige persoon:

- (a) binne 'n periode van ses(6) maande na die datum waarop sy of haar naam uit die betrokke register geskrap is, die ekwivalent van twee (2) keer die jaarlikse geld in paragraaf 1(a) of 2 (a) bedoel, insluitend enige ander uitstaande gelde, betaal; of
- (b) nadat 'n periode van ses(6) maande verstryk het, na die datum waarop sy of haar naam uit die betrokke register geskrap is, die ekwivalent van vyf (5) keer

keer die jaarlikse geld in paragraaf 1(a) of 2 (a) bedoel, insluitend enige ander uitstaande gelde, betaal.

Vrystelling

9. (1) Die Raad kan, by besluit, die Registrateur opdrag gee om enige tandtegnikus of tandtegnoloog vanaf 70 jarige ouderdom vir 'n onbepaalde of bepaalde tyd, vry te stel van betaling van die voorgesrewe jaarlikse gelde, kragtes paragraaf 1, as die Raad tevrede is dat sodanige tandtegnikus of tandtegnoloog-
- (a) 'n skriftelike aansoek het, by wyse van 'n beëdigde verklaring, wat vergesel is van 'n gesertiseerde afskrif van 'n geldige identiteitsdokument, voor 28 Februarie van die voorafgaande finansiële jaar waarvoor vrystelling aansoek gedoen word; en
- (b) reeds 70 jaar is; en
- (c) wat die voorgeskrewe bedrag van **R 334.00** betaal het.

Belasting op toegevoegde waarde

10. Alle gelde in hierdie kennisgewing bedoel, sluit 14% op toegevoegde waarde in.
