THE NATIONAL RAILWAY SAFETY REGULATOR ACT, 2002**

I Dipuo Peters, Minister of Transport, hereby in terms of section 23(2)(a) of the National Railway Safety Regulator Act, 2002 (Act No. 16 of 2002) read together with section 23(2)(b) of the Act determine fees that the Railway Safety Regulator must charge for safety permits as indicated in the Schedule. This safety permit fees determination is for the year 2014 to March 2015 and shall come into operation on the date of publication.

The safety permit fees are published for compliance and general information.

PERMIT FEES PAYABLE TO THE RAILWAY SAFETY REGULATOR

APPLICATION FEE AND SAFETY PERMIT FEES

(1). The fees specified in second column of the Schedule shall be payable in respect of the corresponding activities specified in the first column of the Schedule indicated as follows:

(b) Temporary Safety Permit	R 9 000.00
(c) Construction Train Safety Permit	R 20 000.00
(d) Test and Commissioning Safety Permit	R 30 000.00
