**PRIVATE SECURITY INDUSTRY REGULATION ACT, 2001
(ACT NO. 56 OF 2001): EXEMPTION IN TERMS OF
SECTIONS 1(2) AND 20(5) OF THE ACT**

By virtue of the power vested in the Minister of Police by sections 1(2) and 20(5) of the Private Security Industry Regulation Act, 2001 (Act No. 56 of 2001), I, Emmanuel Nkosinathi Mthethwa, hereby determine that-

- they may not directly or indirectly participate or influence the decisions relating to the day-to-day security services provided by DENEL SOC Ltd, trading as MECHEM (Pty) Ltd;
- they may not function as security service providers ; and
- they remain in the employment of DENEL SOC Ltd, trading as MECHEM (Pty) Ltd in the same position as indicated in their application.
