I, Angelina Matsie Motshekga, Minister of Basic Education, hereby, in terms of *Sections 3(4)(I) and* 7 of the *National Education Policy Act, 1996 (Act No. 27 of 1996)* and after consultation with the Council of Education Ministers give my intention to amend national education policy pertaining to the National Senior Certificate examinations as stipulated in the policy document, *National policy on the conduct, administration and management of the National Senior Certificate: A qualification at Level 4 on the National Qualifications Framework (NQF), promulgated in <i>Government Gazette No. 30048* of 6 July 2007. In view of this, I invite stakeholder bodies and members of the public to comment on the relevant policy changes as set out in the **Schedule**.

CALL FOR WRITTEN SUBMISSIONS FROM STAKEHOLDER BODIES AND MEMBERS OF THE PUBLIC ON THE DRAFT AMENDMENT POLICY PERTAINING TO THE CONDUCT, ADMINISTRATION AND MANAGEMENT OF THE NATIONAL SENIOR CERTIFICATE EXAMINATION

- 1. I, Angelina Matsie Motshekga, Minister of Basic Education, hereby, in terms of *section 6A* of the *South African Schools Act, 1996 (Act. No. 84 of 1996)*, may determine
 - (a) a national curriculum statement indicating the minimum outcomes and standards; and
 - (b) a national process and procedures for the assessment of learner achievement.
- 2. Minimum outcomes and standards, as contemplated in *paragraph 1(a)* above, means the minimum level at which a learner must attain the content and assessment requirements for all subjects listed in the *National Curriculum Statement Grades* R 12.
- 3. Processes and procedures for the assessment of learner achievement, as contemplated in *paragraph 1(b)* above means the conduct, administration and management of internal assessment, end-of year examination, and the final National Senior Certificate examination.
- 4. After consultation with the Council of Education Ministers, I hereby give my intention to amend policy as set out in the **Schedule**, which will impact on the minimum outcomes and standards; and a national process and procedures for the assessment of learner achievement as stipulated in the policy document, *National policy on the conduct, administration and management of the National Senior Certificate: A qualification at Level 4 on the National Qualifications Framework (NQF)*, published in *Government Gazette No. 30048* of 6 July 2007.
- 5. Stakeholder bodies and members of the public are accordingly invited to comment on the amendment to policy which will impact on the minimum outcomes and standards; and a national process and procedures for the assessment of learner achievement.
- 6. The curriculum and the process for the assessment of learner achievement contemplated in *paragraph* (1) will be applicable to public and those independent schools that offer the *National Curriculum Statement Grades* R 12.

SCHEDULE

DEFINITIONS

1. In this policy "policy" means the policy published as *Government Notice No.* 564 in *Government Gazette No.* 30048 of 6 July 2007 as amended by *Government Notices No.* R872, *Government Gazette No.* 31337 of 29 August 2008, *No.* 1327 and No. 1328, *Government Gazette, No.* 31680 of 12 December 2008, *Government Notices*1041 and 1042, *Government Gazette, No.* 32678 of 3 November 2009, *Regulation Notice No.* 188, *Government Gazette No.* 35103 of 2 March 2012; and *Regulation Notice No.* 444, *Government Gazette No.* 35429 of 7 June 2012.

Amendment of Paragraph 44 of the Policy

Paragraph 44 of the Policy is hereby amended by the addition of sub-paragraph
(3) following sub-paragraph (2) -

"(3) All Provincial Education Departments must ensure that-

(a) the category of top learners is based on the aggregate of the six best subjects, excluding Life Orientation; and

(b) The selection will be based on the learner data as at the date of the official release of results by the Minister and no appeals or outcome of supplementary examination results will be considered"."

Amendment of Paragraph 45 of the Policy

2. Paragraph 45 is hereby amended by the substitution for sub-paragraph (1)(a) of the following sub-paragraph-

"(1)(a) A candidate may apply for the re-marking or re-checking of his or her examination answer scripts, within **[twenty-one (21)]** <u>fourteen (14)</u> calendar days of the official release of the results."

Amendment of Paragraph 50 of the Policy

3. Paragraph 48 is hereby amended by the substitution for sub-paragraph (3) of the following sub-paragraph-

"(3) The **[national]** security and confidentiality agreement relating to examination matters must be signed by all officials involved in managing and administering the examination process. In addition all examination officials must be subjected to a police clearance followed by a security clearance. The level of security clearance will be determined by the responsibility attached to the functions performed by the official.".
