#### **SOUTH AFRICAN CIVIL AVIATION AUTHORITY LEVIES ACT, 1998 (ACT NO. 41 OF 1998)**

#### **NOTICE OF AN AMENDMENT OF A DETERMINATION MADE BY THE SOUTH AFRICAN CIVIL AVIATION AUTHORITY IMPOSING A FUEL LEVY ON THE SALE OF AVIATION FUEL.**

The South African Civil Aviation Authority, in terms of the provision of section 2(7) of the South African Civil Aviation Authority Levies Act, 1998 (Act no. 41 of 1998), hereby amends the Determination contained in Government Notice No. R1665 of 14 December 1998, as amended by Government notice No. R932 of 30 of July 1999, Government Notice No. R1033 of 27 August 1999, Government notice No. R1101 of 9 November 2005, Government Notice No. R473 of 25 April 2008, Government Notice R163 of 26 February 2010 and Government Notice No. R307 of 13 April 2013.

#### **Amendment of paragraph 2 of the Determination**

1. Paragraph 2 of the Determination is hereby amended by the substitution for subparagraph (1) of the following subparagraph:

“(1) Subject to the provisions of paragraph (2), a levy of 13.00 cents per litre is payable by consumers (including a wholesale distributor) on the sale of all aviation fuel which is manufactured, distilled, imported or sold in the Republic.”.

#### **Insertion of paragraph 3 in the Determination**

2. The following paragraph is hereby inserted in the Determination as a new paragraph 3:

(3) Interest at a rate of 2% above prime lending rate per annum, compounded monthly, is payable in respect of the outstanding balance of the levy after the due date.”.

#### **Commencement date**

3. This amendment shall come into operation on 01<sup>st</sup> August 2014.

**Vervanging van paragraaf 2 van die Vasstelling**

1. Paragraaf 2 van die Vasstelling word hiermee gewysig deur die vervanging van van subparagraaf (1) deur die volgende subparagraaf:

“(1) Onderworpe aan die bepalings van paragraaf (2), is ‘n heffing van 13.00 sent per liter betaalbaar deurverbruikers(insluitende ‘n groothandelverspreider) op die verkoop van alle vliegtuigbrandstof wat in die Republiek geproduseer, versprei, ingevoer of verkoop word.”.

**Invoeging van paragraaf 3 in die Vasstelling**

- 2 Die volgende paragraaf word hiermee as ‘n nuwe paragraaf 3 in die Vasstelling ingevoeg:

“(3) Rente teen ‘n koers van 2%bo die prima uitleenkoers per annum,maandeliks saamgesteld, is betaalbaar ten opsigte van die uitstaande balans van die heffing,na die betaaldag.”
