## TAXI SECTOR, SOUTH AFRICA: MINIMUM WAGE INCREASES

2.3. During the ECC deliberation on the increase of the taxi wages, the ECC recommended that the minimum wages should be raised by CPI (excluding owners equivalent rent) plus 2% from 1 July 2013. For year two and three, the ECC recommended that the minimum wages for the taxi sector should be increased by CPI (excluding owners equivalent rent) plus 1, 5% on 1 July 2014 and by CPI plus 1, 5% on 1 July 2015 respectively.

Substitute clause 9 (1) (a) as reflected in the Government Gazette No. 36619 of 1 July 2013 with the following:

## 9. BOARDING ALLOWANCES

(1) If an employer requires an employee to sleep over at a place other than where the employee resides, the employer must either-

- (a) Pay the employee the amount as reflected in table 2 below per night; or
- (b) Reimburse the employee's reasonable expenses; or
- (c) With the agreement of the employee, accommodate the employee in reasonable accommodation
