##### PREScribed RATE OF INTEREST (SECTION 1 OF THE PRESCRIBED RATE OF INTEREST ACT, 1975)

- (1) Under section 1(2) of the Prescribed Rate of Interest Act, 1975 (Act No. 55 of 1975), and after consultation with the Minister of Finance, I, Tshililo Michael Masutha, Minister of Justice and Correctional Services, hereby prescribe a rate of interest of 9, 0 per cent per annum as from 1 August 2014 for the purposes of section 1(1) of the said Act.
- (2) Government Notice No. R. 1814 of 1 October 1993 is hereby withdrawn.
