NOTICE 581 OF 2014

INVITATION FOR NOMINATIONS OF PERSONS TO SERVE ON THE BOARD OF THE SOUTH AFRICAN CIVIL AVIATION AUTHORITY (SACAA)

The South African Civil Aviation Authority (SACAA) is a national public entity established in terms of the Civil Aviation Act, 2009) (Act No. 13 of 2009). Its mandate is to control and regulate civil aviation safety and security, oversee the implementation and compliance with the National Aviation Security Program, oversee the functioning and development of the civil aviation industry, promote civil aviation safety and security, develop any regulations that are required in terms of the Act and monitor and ensure compliance with the Act and the International Civil Aviation Convention.

The Authority has a Board which in terms of the Civil Aviation Act has to provide, amongst others, the strategic direction and oversee the corporate governance of the Authority in order to attain the mandate. The members of the Board are part time, hold office for a period not exceeding three years and are accountable to the Minister of Transport. In terms of the Act, the Minister of Transport is required to appoint seven members to the Board. Amongst the persons that the Minister appoints shall be persons with suitable expertise in human resource management, representatives of the civil aviation industry with suitable financial and operational expertise, aviation law and a person with civil aviation acknowledged technical competencies involved in organized labour from the aviation industry.

The members of the Board shall be persons who are not in full-time service of any organ of state or public entity as referred to in Schedule 2 and 3 of the Public Finance Management Act. A person is disqualified from being appointed to the Board if he is not a South African citizen. Therefore, the Minister of Transport hereby, in terms of section 77 (3)(a) of the Act invites interested parties to nominate persons suitable for the appointment.

Nominations must contain a full motivation, the full name and address of the interested parties making the nominations, a signed acceptance of the nomination by the nominee, ID copy and Curriculum Vitae of the nominee providing, amongst others, the candidate's:

- **Full name and gender;**
- **Contact address, telephone and fax numbers and e-mail address;**
- **Previous experience and relevant expertise, quoting dates and organizations concerned;**
- **Academic qualifications;**
- **Other Board membership.**

Security screening will be conducted for shortlisted nominees. Candidates who were nominated in the previous call for nominations under Government Notice No. 1077 in Gazette No. 36979 need not apply as their nominations will still be considered in this current process.
