### ELECTRONIC COMMUNICATIONS ACT, 2005 (ACT NO. 36 OF 2005)

#### **APPLICATION FOR A TRANSFER OF AN INDIVIDUAL ELECTRONIC COMMUNICATIONS NETWORK SERVICE LICENCE FROM ZENSHO TELECOMS (PTY) LTD TO OCTANOX (PTY) LTD**

1. The Independent Communications Authority of South Africa (“the Authority”) hereby gives notice that it has received an application from Zensho Telecoms (Pty) Ltd for a transfer of its Individual Electronic Communications Network Service (I-ECNS) licence. The application was lodged in terms of regulation 11 of the Processes and Procedures Regulations for Individual Licences and Special Temporary Authorisations of 2010 read with sections 13(1), (2) and (6) of the Electronic Communications Act, as amended.
2. The transfer application seek the approval from the Authority to transfer the I-ECNS licence from Zensho Telecoms (Pty) Ltd to Octanox (Pty) Ltd.
3. The application, relevant schedule and any representations received pursuant thereto would be made available and open for inspection by interested parties in the Authority’s library during the Authority’s normal office hours.
4. Interested parties are invited to lodge written representations in relation to the application within twenty one (21) working days of the date of publication of this notice in the *Government Gazette*.

5. Persons who make such representations must indicate in their written representations whether they require an opportunity to make oral representations in the event the Authority decides to hold public hearings.

Zensho Telecoms (Pty) Ltd shall be entitled to respond in writing to written representations made by interested persons on the transfer application, and such written response must be lodged with the Authority within forty two (42) working days of the date of publication of this notice in the *Government Gazette*. Zensho Telecoms (Pty) Ltd must, at the time of lodging such written response, furnish proof to the Authority's satisfaction that it has delivered a copy of such response by hand, OR has sent a copy of such response by registered mail OR by facsimile OR by e-mail to the relevant person having made such written representations.
