ALLIED HEALTH PROFESSIONS ACT, 1982 (ACT NO. 63 OF 1982)

LEGAL NOTICE: CALL FOR NOMINATIONS OF CANDIDATES TO BE APPOINTED TO FILL TWO EXISTING VACANCIES ON THE ALLIED HEALTH PROFESSIONS COUNCIL OF SOUTH AFRICA

Notice is hereby given in terms of the provisions of Regulation 4 (GNR127, 12/02/2001) of the Allied Health Professions Act, 1982 (Act 63 of 1982), as amended ("the Act"), for nominations of suitable candidates to be considered for appointment by the Minister of Health, Honourable Dr A. Motsoaledi, to serve on the Allied Health Professions Council of South Africa for the unexpired term of office ending 31 August 2016 in accordance with Section 5(1)(b)(ii) and (iii) of the Act as follows:

- One person to be appointed on account of his/her knowledge of the law; and
- One person to be appointed on account of expertise in the fields of Health, Education and Welfare as a community representative.

Requirements of a valid nomination: Nominations must be made on a prescribed nomination form obtainable from the Department of Health website at www.doh.gov.za. A comprehensive CV of the nominee as well as a written motivation by the nominee should be attached, including certified copies of academic qualifications and other relevant supporting information.

The nominee shall declare that he/she is not registered in terms of the Allied Health Professions Act, is a South African citizen residing within the Republic and is not an unrehabilitated insolvent. The nomination shall be signed by the nominee indicating his/her acceptance of the nomination and willingness to serve on Council should he/she be appointed.

Submission of nominations: Nomination forms, duly completed and signed, addressed to the Director-General, Department of Health and marked for the attention of the Director: Public Entities Governance, Ms M.
